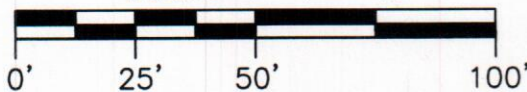

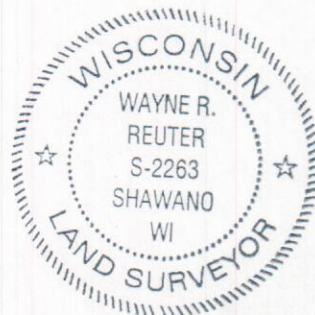

Being part of Government Lot 4, Section 34, Township 26 North, of Range 15 East, Town of Belle Plaine, Shawano County, Wisconsin bounded and described as follows: Commencing at the South 1/4 corner of the said Section 34; thence N88°17'32"W along the section line 166.12 feet; thence N23°22'43"W 728.26 feet to a found 1" iron pipe at the intersection with the north line of Rustic Drive; thence N23°22'43"W continuing along the same line 162 feet more or less to the water's edge of Pine Lake and the place of beginning; thence retrace the last described line S23°22'43"E 162 feet more or less to the said 1" iron pipe; thence S74°09'22"W along the said north line 59.54 feet to a found 1" iron pipe; thence N19°24'42"W 175 feet more or less to the water's edge of Pine Lake; thence following the said water's edge of Pine Lake in a general easterly direction to the place of beginning. Subject to all easements and restrictions of record. Parcel contains 9,000 sq. ft. or 0.21 acre more or less.
