Broker Participation Agreement

YOU must attend the sale, and register YOUR Buyer at the auction for a bid number and remain with YOUR Buyer until the end of contracting. There are no exceptions.

In any actions brought to enforce the terms of this agreement, the successful party shall be entitled to recover, in addition to other damages, attorney fees and court costs incurred in said litigation. This agreement shall be governed, construed and enforced under the laws of the State of Florida. The parties agree that any action of proceeding to enforce or construe the terms of this agreement shall be brought in the court of the appropriate jurisdiction in Pinellas County, Florida, the parties hereby submitting to the **in-personam** jurisdiction of said court.
