
SURVEY DESCRIPTIONS


Part of the South Half of Section 34, including Lots"A", "B" and "C" of the Pine Bluff Warehouse Industrial Subdivision; part of the Joseph Vallieur Survey and part of the Francis Coupot Survey all in Section

COMMENCING at the northeast corner of Section 2, Township 6 South, Range 9 West, as set by J.W. Gould in 1956 running thence NORTH a distance of 50.00 feet to a point on the northern right-of-way of the Missouri Pacific Railroad; thence run N88"54'43"W, along said right-of-way, for a distance of 395.90 feet to the southeast corner of said Pine Bluff Warehouse Industrial Subdivision; thence continue N88°54'43"W, along sald railroad right-of-way, the same being the south boundary of Lot "8" of said subdivision, for a distance of 384.60 feet to the southwest corner of said Lot "8", said corner being marked by a 3/4" iron pipe: thence run N00"20'22"E, along the west boundary of Lot "B" for a distance of 130,00 feet to the southwest corner of Lot "C" of said subdivision, said corner marked by a 5/8" rebar; thence run N00*20'22"E, along the west boundary of said Lot "C", for a distance of 122.30 feet to a 6" iron pipe marking a northwesterly corner of said Lot "C"; thence run N74*03'04"E, along the northwesterly boundary of said Lot "C", for a distance of 26.65 feet to an angle iron marking a northwesterly corner of said Lot "C", said corner being on the southern right-of-way of the St. Louis Southwestern Railway; thence run S88"16'30"E, along the north boundary of said Lot "C", the same being the south boundary of said railroad right-of-way, for a distance of 75.12 feet to the northwest corner of Lot "A" of said subdivision; thence run S88°16'29"E, along the north boundary of said Lot "A" and southern railroad right-of-way, for a distance of 286.90 feet to the northeast corner of said Lot "A"; thence continue S88'16'29"E along said southern railroad right-of-way, for a distance of 1028.28 feet to the northeast corner of a parcel of land described in a Warranty Deed to Holly Grove Land Company filed for record in Deed Book 693 at Page 630 in the office of the Jefferson County Circuit Clerk, said corner marked by a 1" iron pipe; thence run 500"49'24"W, along the east boundary of said Holly Grove parcel, for a distance of 244.63 feet to the southeast corner thereof, said corner marked by a 1" iron pipe, said corner being on the aforementioned Missouri Pacific Railroad right-of-way; thence run N88*54'43"W, along said right-of-way, for a distance of 633.03 feet to the POINT OF BEGINNING, containing 8.20 acres, more or less, subject to all easements and rights-of-ways of record or
