

**DESCRIPTION**

A portion of the SW $\frac{1}{4}$ SW $\frac{1}{4}$  in Section 8, a portion of the NE $\frac{1}{4}$ NE $\frac{1}{4}$  in Section 18, and all of the SE $\frac{1}{4}$ SE $\frac{1}{4}$  in Section 7, all in Township 5 South, Range 24 West, Pike County Arkansas; described as follows:

Beginning at a  $\frac{1}{2}$  inch Rebar with Alum. Cap PLS 902 at the NW Corner of said SW $\frac{1}{4}$ SW $\frac{1}{4}$  as shown on this Survey Plat prepared for Wayne Buck by Fred deAryan; **thence** along the north line of said SE $\frac{1}{4}$ SE $\frac{1}{4}$  N 87°33'55" W 1327.11 feet to a  $\frac{1}{4}$  inch Pipe at the NW Corner thereof; **thence** along the west line of said SE $\frac{1}{4}$ SE $\frac{1}{4}$  S 02°06'48" W 1317.85 feet to a  $\frac{1}{2}$  inch Rebar with Alum. Cap PLS 902 at the SW Corner thereof; **thence** along the south line of said SE $\frac{1}{4}$ SE $\frac{1}{4}$  S 87°34'27" E 212.23 feet to a  $\frac{1}{2}$  inch Rebar with Cap PLS 902; **thence** leaving said south line S 02°06'04" W 1200.54 feet to the Centerline of Rock Creek Road; **thence** along said Centerline S 78°13'03" E 306.09 feet to the beginning of a 596.11 foot radius curve to the left; **thence** along said curve through a central angle of 22°38'03" an arc distance of 235.49 feet (chord S 88°13'15" E 233.95 feet) to the end of said curve; **thence** N 82°03'22" E 106.34 feet to the beginning of a 1219.50 foot radius curve to the left; **thence** along said curve through a central angle of 14°48'23" an arc distance of 315.14 feet (chord N 75°42'48" E 314.26 feet) to the end of said curve; **thence** N 69°37'58" E 193.10 feet; **thence** leaving said Centerline N 01°28'58" E 1063.46 feet to a 2 inch Iron Pipe with Alum Cap at the NE Corner of said NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; **thence** S 87°00'26" E 329.44 feet to a  $\frac{1}{2}$  inch rebar with Cap PLS 902; **thence** N 02°25'15" E 1324.83 feet to a  $\frac{1}{4}$  inch Pipe; **thence** N 88°15'29" W 330.53 feet to the POINT OF BEGINNING, containing 80.89 acres, more or less.
