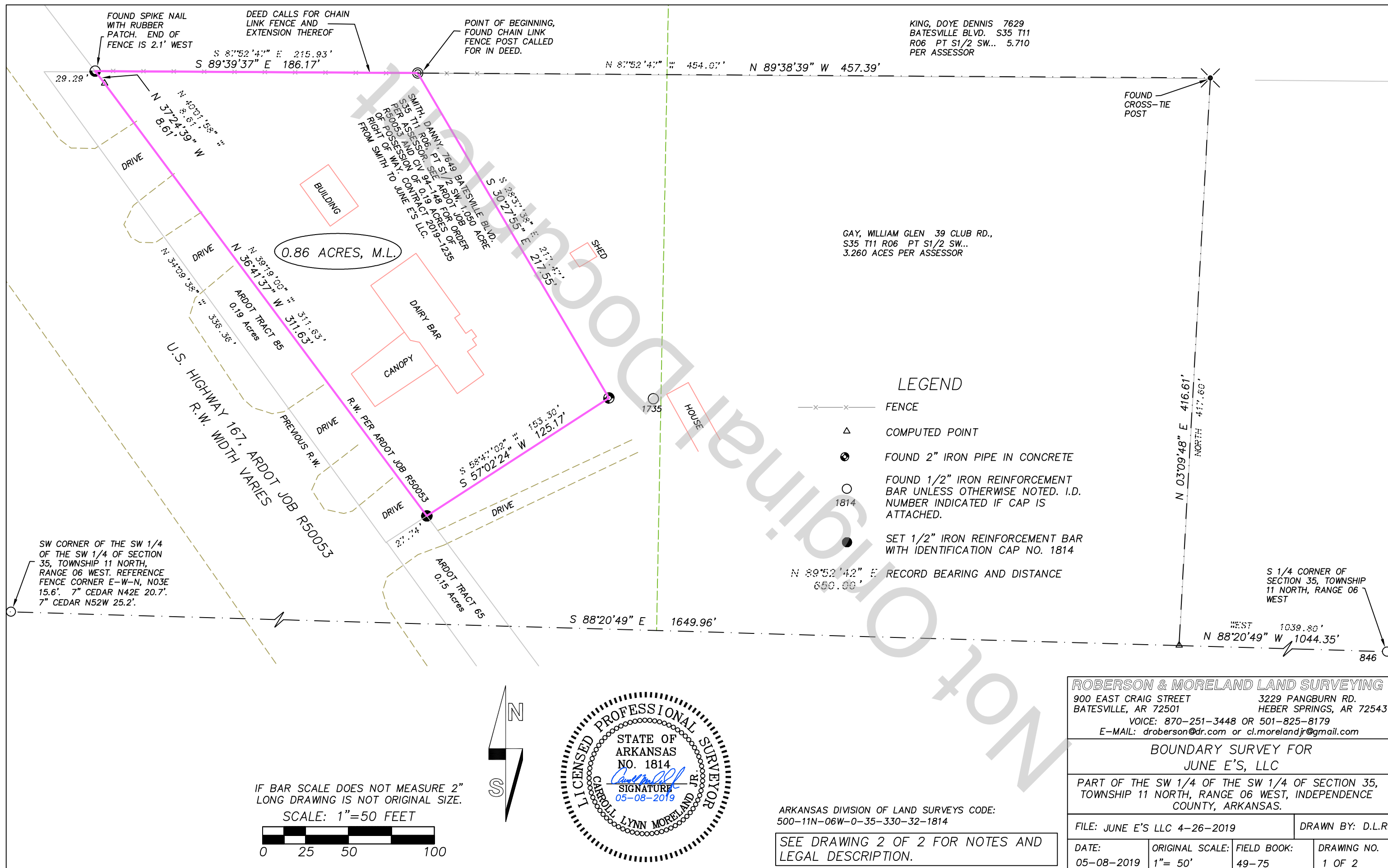

A part of the Southwest Quarter of the Southwest Quarter of Section 35, Township 11 North, Range 06 West, Independence County, Arkansas and more particularly described as follows:

Commencing at a found ½-inch iron reinforcement bar being used for the Southwest Corner of the Southwest Quarter of the Southwest Quarter of Section 35, Township 11 North, Range 06 West, Independence County, Arkansas; thence S 88°20'49" E along the South line of the said Southwest Quarter a distance of 1,649.96 feet to a point, thence N 03°09'48" E a distance of 416.61 feet to a found cross-tie post, thence N 89°38'39" W a distance of 457.39 feet to a found chain link fence post being used for the Point of Beginning, thence S 30°27'55" E a distance of 217.55 feet to a found 2-inch iron pipe in concrete, thence S 57°02'24" W a distance of 125.17 feet to a set ½-inch iron reinforcement bar with an identification cap, thence N 36°41'37" W along the East right of way line of U.S. Highway 167 as shown on Arkansas Department of Transportation Job R50053 a distance of 311.63 feet to a point, thence N 37°24'39" W a distance of 8.61 feet to a found spike nail in a rubber patch, thence leave the said East right of way line of U.S. Highway 167 and run S 89°39'37" E along an existing chain link fence a distance of 186.17 feet to the point of beginning.
