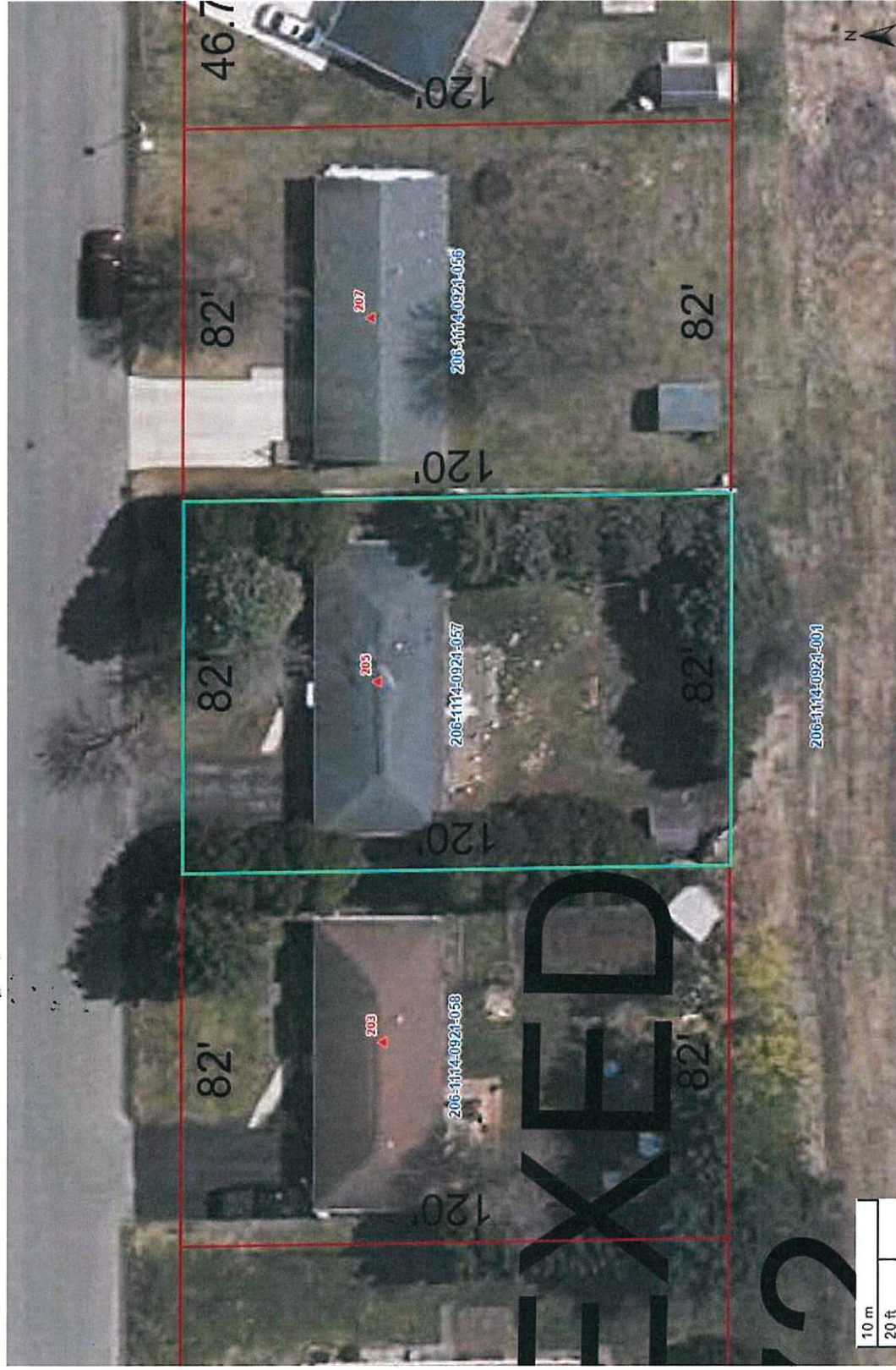

This area may be subject to the land division provisions of the Dodge County Land Use Code (LUC). Click [here](#) for a full version of the LUC. Relevant provisions are summarized below.

Parcel Identification Number - ... Land with separate parcel identification numbers shall not be considered separate lots.

Contiguous - ... abutting or touching at any point of which no part is separated by ...

Division of Land - ... transfer of title to less than the entire legal interest in an entire contiguous area of land ...

Exemptions - ... Adjustment of the boundary line or the transfer of land between 2 adjoining property owners ...

Lot - ... tax parcel identification numbers shall not be used in defining a lot.

Non-conforming Lot - Illegal - ... created ... without all of the required Department approvals ...

Parcel - ... A parcel shall not be considered a separate lot ...

Enforcement and Penalties - ... Any violation ... shall be subject to the remedies and penalties provided for ... Each day ... shall constitute a separate violation of this Code ... forfeit not less than \$50 nor more than \$500 dollars and costs ... shall be imprisoned ... for a period not to exceed 6 months.
