# The Salvation Army Home/Centre Sponsorship Programme

The Home/Centre Sponsorship Programme supports the diverse needs of underprivileged children who are cared for by The Salvation Army, namely our children's homes, day care and tuition centres, centres for special needs children and kindergartens, where children's needs are being met holistically. Thus enabling many children to benefit from this Sponsorship.



Your financial sponsorship provides these vulnerable children with proper nutrition, clothing, shelter, healthcare and also educational, social and spiritual nurturing, opportunities and experiences to foster their development.

This Sponsorship Programme coordinates the funds received from sponsors of supporting countries and relationships between donors and The Salvation Army-operated children's homes and centres.

Your sponsorship of S\$720/RM 2,100 a year or S\$60/RM175 a month goes towards supporting a Home or Centre in Malaysia or Myanmar. 100% of your contribution goes to support the children in the Home or Centre. For just S\$2.00/RM6 a day, you can make a difference in the lives of the children and help them reach their full potential for a brighter future.

# Frequently Asked Questions

## 1. Will the sponsored children know who I am?

We encourage children of our Home/Centre as a group to write a note or card to the sponsors especially during special occasions like Easter, Christmas, etc. Conversely, sponsors can also write to the Home/Centre to give children the opportunity to know you, or arrange a visit to the Home/Centre.

## 2. Can I send gifts to the children?

Sponsors are advised to send only monetary gifts due to mailing difficulties and financial costs.

## 3. Can I sponsor more than one Home / Center?

Certainly, if you are able to do so, as your contribution will benefit more children.

## 4. Are sponsorships short-term? Can they be long-term?

We request that our sponsors commit their monetary giving for a minimum period of one (1) year. Longer term sponsorship is encouraged as it sustains the care support that our children need in the long run.

## 5. How much money reaches the children I am sponsoring?

100% of your monetary contribution shall be directed to the Home/Centre for their care of the children.

## 6. Is my donation tax deductible?

No, it is not. The Singapore government stipulates that donations for overseas causes will not be entitled to tax deduction.

## 7. What happens if my financial circumstances change and I cannot make payments?

While we hope that you will be able to continue your sponsorship for a longer term, we recognize that circumstances may change over time. You may discontinue your sponsorship at any time. Conversely, you may also renew your sponsorship when you are able to do so.

## 8. Can a group of people sponsor a Home / Center?

Yes. Both individual and group sponsorships are accepted.

## 9. Can I sponsor an individual child?

We encourage our sponsors to take on our Home/Centre Sponsorship as it offers a possibility for many children to benefit at a time and to benefit equally. These funds are used to ensure all children in the Home/Centre have access to education and supporting services.

## 10. What is a Discretionary Sponsorship?

We also accept discretionary donations. You may choose the Home(s) or Centre(s) to which you would like your donation to go to, determine the amount(s) to be given, and when to give.
