Policies and Guidelines

- 1) Bus service is provided 178 days per year. Deviations from regularly scheduled departure times will be published on the school calendar.
- 2) Students must be registered to use Bus Services including those using Drop-In Service.
- 3) School behavioral guidelines remain in place during bus use.
- 4) Bus Service charges are drafted in 9 equal monthly payments beginning Sept. 16 through May 16 **unless** paid in full by Sept. 7. Full payment plans receive a 3 percent prepayment discount. Semester payment plans receive a 1.5 percent prepayment discount.
- 5) Bus Service charges are drafted from the same bank account as school tuition charges unless the business office is notified and a separate draft agreement is completed.
- 6) Sixth grade students may ride the bus at no cost. Sixth grade students must be registered and keep their plan selection/use current with the business office.
- 7) Families may change their enrollment plan once per semester without incurring an administrative fee. Additional changes require a \$25 processing fee and the completion of a change of plan form. Forms are available in school offices.
- 8) Changes to plans are made on the 15th of each month for the next billing period. Families must turn in a change of plan form by the 10th of the month for changes to go into effect for the next billing period.
- 9) Families are charged the full plan amount if they use the service during any part of a billing period. Billing periods end on the 15th of each month.
- 10) The Bus Service Contract may be canceled and pre-paid amounts refunded (less a \$25 processing fee) in accordance with school policy, upon receipt of written notice of withdrawal.
- 11) Students will not be allowed to use Drop-In Afternoon Service without "same-day" parent/guardian authorization.
- 12) **DROP-IN BUS SERVICE** should be paid on site on the day of use. Drop-In Bus Service charges that are not paid for by the 10th of the month are billed at double the published drop-in rate.
- 13) Transportation Services will be suspended if an account is past due, until payment or arrangements are made.
