

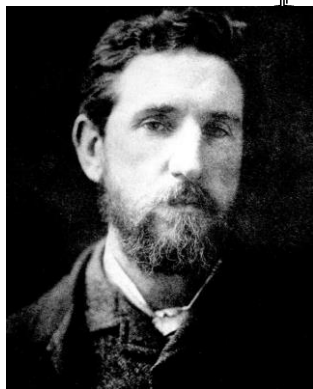

## Field Trip: August St. Gaudens Homestead



### Augustus Saint-Gaudens, President Theodore Roosevelt & the Coins.

Augustus Saint-Gaudens and Theodore Roosevelt's relationship was not only a working one, but also a friendly one. Their most famous project together was the beautifully designed ten and twenty-dollar gold coins. Along with the coins, Saint-Gaudens also designed Roosevelt's 1905 Inaugural Medal.

During his presidency from 1901 to 1909, Roosevelt helped to create and promote American culture in the country and the world. One way he did this was by commissioning an American artist, Augustus Saint-Gaudens, to design currency that represented American progress and ideals. Roosevelt chose Saint-Gaudens because he ushered in the nascent American art scene and because he often used American symbols and allegorical figures in his art such as angels, bald eagles, and stars and stripes.

The Saint-Gaudens double eagle is a twenty-dollar gold coin, or double eagle, produced by the United States Mint from 1907 to 1933. The coin is named after its designer, the sculptor Augustus Saint-Gaudens, who designed the obverse and reverse. It is considered by many to be the most beautiful of U.S. coins.

After several versions of the design for the double eagle proved too difficult to strike, Charles E. Barber, Chief Engraver, modified Saint-Gaudens's design, lowering the relief so the coin could be struck with only one blow. When the coins were finally released, they proved controversial as they lacked the words "In God We Trust", and Congress intervened to require the motto's use. The coin was minted, primarily for use in international trade, until 1933. The 1933 double eagle is among the most valuable of U.S. coins, with the sole example currently known to be in private hands selling last year for \$18.8 Million.

### The Saint-Gaudens Coins and the Other Roosevelt

In 1933, President Franklin D. Roosevelt issued executive order 6102 requiring Americans to turn their gold over to the government. In 1934, the Congress passed the Gold Reserve Act outlawing circulation and private possession of United States Gold Coins and declared gold coin no longer legal tender. Since the 1933 Saint-Gaudens double eagle coins were minted after the executive order, the 445,500 specimens were

ordered not to be circulated, but instead melted save 2 examples. It is now known that 20 additional coins survived, as they were stolen from the lot prior to melting. Of these 20, nine were recovered and melted leaving just 13 surviving coins and only one held in a private collection. As for the 1933 \$10 eagle coin, it was produced prior to the executive order. As such it is considered legal to own, however, the vast majority of those were melted as well leaving just 40 known pieces to have survived. To this day, it is considered illegal to own the 1933 Double Eagle coins, except the one known example held in private collection. I believe it is excepted because it was originally owned by a foreigner and in 1976 President Ford reversed the order making it legal to own US gold coins again. Hopefully you have learned this week just how unconstitutional such arbitrary orders from the President are. Skylar Ferrill attended the field trip and reports on the experience...

The trip was a great opportunity to learn about Augustus and his works. The weather was very warm but there was a nice breeze. We watched a short video that explained the sculptures and told where the originals are located. There was a directed tour through the homestead. The tour provided background information on the home and the family. The sculptures themselves were amazing. One of the main things I took away from the sculptor Augustus, was his incredible gift for realism. Overall it was an awesome field trip. I'm glad we had an opportunity to go.

# The Folly of Term Limits

Adding an amendment to the U.S. Constitution to balance the federal budget (the subject of the previous article) is arguably the single biggest reason why conservatives want to call a Constitutional Convention. But there are other reasons too, among them term limits, the subject of this short piece.

The argument for term-limiting congressmen out of office is that their removal will enable others to be elected who will be more in tune with the wishes of the people. But does this argument hold up under scrutiny?

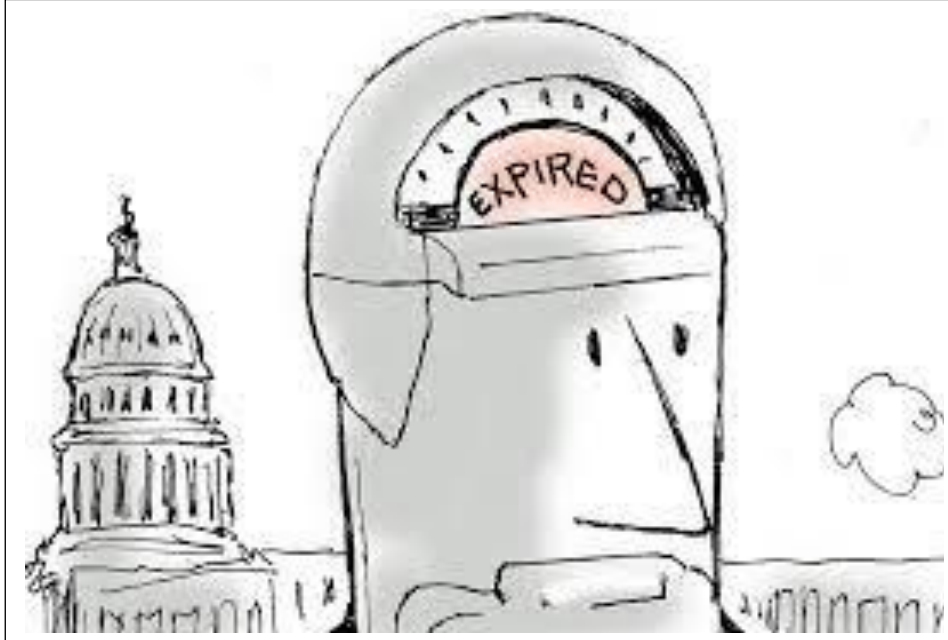
It is ironic that many conservatives who genuinely believe that term limits would result in better congressional representation also believe (and rightly so) that lame-duck sessions of Congress are largely disconnected from

voters. It is ironic because congressmen who are prohibited from running for re-election because of term limits are lame-duck congressmen, as are congressmen who were voted out of office yet continue to serve in Congress in a lame-duck session. In both cases, these congressmen do not have to worry about facing another election for the office in which they serve.

It is obvious that a lame-duck session, which meets after a new Congress is elected but before the newly elected Congress convenes, is not going to be nearly as responsive to the voters than the regular session prior to the election. After all, what influence do voters have over lame-duck congressmen who will not be returning to Congress when the new Congress convenes? Of course, in a lame-duck session even congressmen who were re-elected may feel more emboldened than otherwise to incur the wrath of their constituents by voting against their wishes, since the next election will not occur for another two years in the case of the House, or another six years in the case of the Senate.

Elections provide the people with powerful means for influencing their congressmen. And congressmen know that if they deviate too much

from what their constituents want, they could well be voted out of office in the next election. On the other hand, lame-duck congressmen know that they have nothing to lose in how they vote. This is the case regardless of whether a lame-duck congressman is voting in a lame-duck session of Congress, or if he or she is being term-limited out of office. In fact, every congressman who is being term-limited out of office would be a “lame duck” during the entire period of his final two-year congressional term, not just during a short post-election, lame-duck session.



There are other reasons why term limits are a bad idea:

- ★ Term limits would limit not only the number of terms a congressman serves, but would also limit the choice of voters. Voters who like their congressman and want to vote to keep him or her in office are no longer allowed to do so. Put another way, their franchise is limited.
- ★ Term limits would force not just “progressive” socialists, but also solid constitutionalists, out of office.

- ★ The candidates who are elected to take their place would not necessarily be an improvement. Far from it, in fact. Incumbents became incumbents by first being voted into office. Unless there is a change in the thinking and understanding of the people who elected them, why should we expect the people to do anything other than replace the term-limited socialists with like-minded socialists?
- ★ Finally, in a very real sense we already have term limits: They’re called elections!

Amending the Constitution to term-limit congressmen is not the answer. If the goal is to elect better congressmen, then what’s needed is better-informed voters. Otherwise, the voters will be beguiled again and again by the politicians they elect no matter how many times they replace one politician with another. ★

# Global Temperature Dataset Corrupted?

According to Mar 13, 2022 Ceres-Science online report, a new climate science study, involving a panel of 17 experts from 13 countries, has just been published in the scientific journal, *Atmosphere*.

The study looked at the various data adjustments that are routinely applied to the European temperature records in the widely used Global Historical Climatology Network (GHCN) dataset over the last 10 years.

The GHCN monthly temperature dataset is the main data source for thermometer records used by several of the groups calculating global warming - including NOAA, NASA Goddard Institute for Space Studies (GISS) and the Japan Meteorological Agency (JMA).

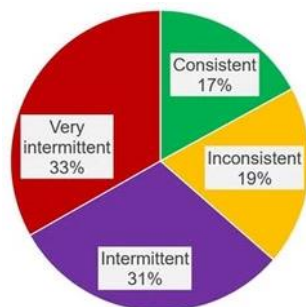
These thermometer records can vary in length from decades to over a century. Over these long periods, the temperature records from individual weather stations often contain abrupt changes due to local factors that have nothing to do with global or national temperature trends. For example, changes in the location of the weather station, the types of thermometers used or the growth of urban heat islands around the station.

To try to correct for these non-climatic biases, NOAA, who maintain the GHCN dataset have been running a computer program to identify abrupt jumps in the records using statistical methods. Whenever the program identifies an abrupt jump it applies an adjustment to remove that jump from the station's record. This process is called temperature homogenization. Until now, most scientists have assumed the process is generally working correctly.

In this new study, the authors analyzed thousands of different versions of the dataset downloaded over 10 years. They studied the homogenization adjustments for more than 800 European temperature records. They found that these adjustments changed dramatically every day when NOAA re-ran their computer program.

The authors found that only 17% of NOAA's adjustments were consistent from run to run. Furthermore, by compiling historical records known as station history metadata for each of the stations, they were able to compare the adjustments applied by NOAA's computer program to the documented changes that were known to have occurred at the weather station.

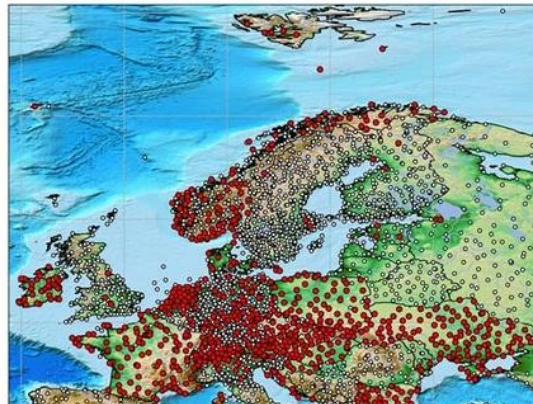
Chart on the right describes the Consistency of NOAA's adjustments for each station. Only 17% of NOAA's adjustments are applied consistently.



They found that less than 20% of the adjustments NOAA had been applying corresponded to any event noted by the station observers - such as a change in instrumentation or a station move.

The findings of the study show that most of the homogenization adjustments carried out by NOAA have been surprisingly inconsistent.

Details on the histories of more than 800 weather stations from 24 European countries were collected to check if the adjustments corresponded to documented changes associated with the weather station. The locations of these stations are indicated below in red.



Moreover, every day, as the latest updates to the thermometer records arrive, the adjustments NOAA applies to the entire dataset are recalculated and changed. As a result, for any given station, e.g., Cheb, Czech Republic, the official homogenized temperatures for 1951 (as an example) might be very different in Tuesday's dataset than in Monday's dataset.

The study itself was not focused on the net effects of these adjustments on long-term climate trends. However, the authors warned that these bizarre inconsistencies in this widely-used climate dataset are scientifically troubling. They also are concerned that most researchers using this important dataset have been unaware of these problems until now.

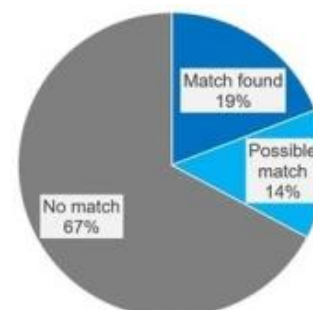
The authors conclude their study by making various recommendations for how these problems might be resolved, and how the temperature homogenization efforts can be improved in the future. ★

## The Tyre Exstinguishers Strike NY

Climate Change activists with a group calling itself Tyre Extinguishers are celebrating their first 'action' in New York City - deflating the tires of 40 SUVs on Manhattan's Upper East Side.

The movement, which originated in the United Kingdom, seeks to dissuade people from owning SUVs in urban areas, and switch instead to more environmentally-friendly vehicles. The SUVs they vandalized had leaflets placed on the windshield, which stated: 'Attention: Your gas guzzler kills'.

### ATTENTION – your gas guzzler kills.

We have deflated one or more of your tires.

You'll be angry, but don't take it personally. It's not you, it's your car.

We did this because driving around urban areas in your massive vehicle has huge consequences for others.

Car companies try to convince us we need massive cars. But SUVs and 4x4s are a disaster for our climate. SUVs are the second-largest cause of the global rise in carbon dioxide emissions over the past decade - more than the entire aviation industry.

The world is facing a climate emergency. According to the UN, millions of people are already dying from climate change-related causes - drought, hurricanes, floods, forced migration, starvation. So far, the impacts on you have probably been minimal. We need emergency action to reduce emissions immediately. We're taking actions into our own hands because our governments and politicians will not.

The loosely-organized movement encourages anyone to participate, at will. They encourage acting under the cover of darkness, working in pairs, and practicing on bicycle tires first.

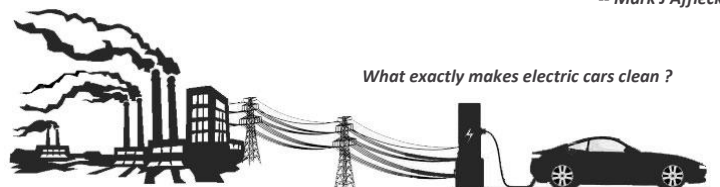

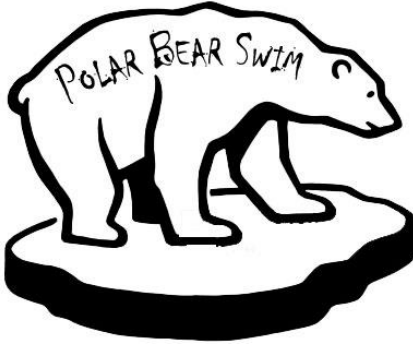

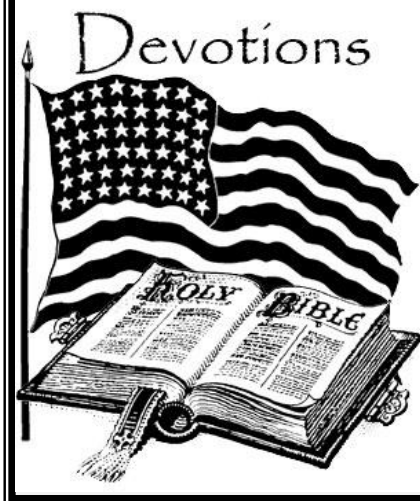
