Bungalow. Wood frame set on concrete foundation; rectangle (26' x 22'); 5 bays wide; 1½-stories; clapboard siding; asphalt-shingled gable roof with extended eaves; center entrance on west facade; off-center interior chimney on west facade. Exterior features include 1/1 double-hung sash; single pane hinged sash with plain surrounds; gable-roofed dormer with exposed rafter ends on west facade; knee braces; exposed rafter ends; boxed cornice; plain frieze board; corner boards; recessed porch with heavy wood posts, boxed clapboard railing, center stairs extends across west facade; wood panel door with single pane window; enclosed shed-roofed porch on east facade; wood sill. Notable landscape features include 1 gable-roofed, board and batten-sided barn; 5 wood frame, gable-roofed outbuildings.

Mr. Hordyk built this farm complex c.1923. The next owner was Otto De Bor who sold the complex to Cornie VanderVoet in 1955. The only change that has been made to the exterior of the house was the back porch addition in 1955.

SIGNIFICANCE

This property is significant under National Register criterion C, because it embodies the distinctive characteristics of architectural expressions and methods of construction that represent the period of community stabilization and economic slowdown (evidenced by simpler forms lacking ornamentation) and the theme of recreation and tourism (evidenced by structures built with natural materials set in scenic locations), from 1911 until 1945. It retains integrity of location, setting, materials, design, workmanship, feeling and association.


PHOTOGRAPHS AND SKETCH MAP OF LOCATION
