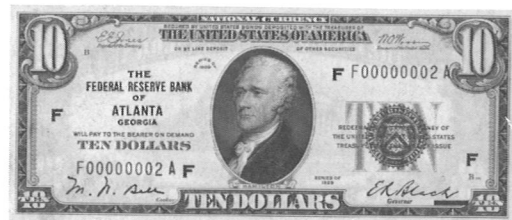

TERMS AND CONDITIONS OF SALE

To give all bidders an equal opportunity, bids will not be opened until the closing date of the sale. In other words, we will not know ourselves, and therefore cannot reveal, where the high bid is until the sale is over. To help us segregate bids from our regular mail, we are providing envelopes for use only for the mail bid sale. Please mark any other envelope you may use on the outside so that we can know it is a bid. Skeptics are invited to inspect the unopened bids up to the closing date. To insure that your efforts are not wasted, mail your bids in early. We will be pleased to discuss and further describe any of the lots by phone, but we must insist that telephone bids be confirmed in writing sent before the deadline. Fax and overnight letters are acceptable. All bids will be opened June 19, 1990.

1. Each lot will be sold to the highest bidder unreserved at a slight advance over the next highest bid. In the event of identical bids, the earliest postmark will receive the lot.
2. As in all legitimate auctions, the second highest bidder will set the price. Up to the \$1000.00 level, advances will be ten per cent with a \$50.00 maximum. At \$1000.00 and over, advances will be 5%. This method will permit a bidder to make a liberal bid with the assurance that his bid will be reduced to the indicated amount above the next highest bid. In cases where only one bid is received, the estimate will be used as the underbid. You should consider your bids in this auction to be your limit rather than your bid.
3. All lots are guaranteed genuine and as described. Please be sure you are bidding the correct amount on the proper lot. Only signed written bids are acceptable. These bids are a binding contractual offer on your part.
4. All successful bidders must remit payment immediately upon receipt of invoice and/or lots. The cost of packing, postage and insurance will be added to the invoices. Lots delivered in Iowa are subject to state sales tax of 4% unless a resale number is given.
5. All photographs are of the actual lots being sold.
6. Prices or estimates given reflect the opinion of the cataloger as to what the lots should or probably will bring. Higher rather than lower valuations are expected to prevail.
7. Alternate and limited bids are acceptable. These can be handled much more efficiently in a sealed bid auction. No buy or unlimited bids are acceptable.
8. GRADING is intended to follow normal standards with a conservative approach. However grading cannot be considered a precise science, and opinions may differ from individual to individual. We guarantee our professional best efforts to properly grade and describe all the lots in this auction. We place our reputation and twenty five years experience on the line with every lot.
9. All invoices are scheduled to be mailed to the bidders within 72 hours of the close of the auction, and payment must be made within five (5) days of receipt of the invoice. It is the responsibility of the bidder to assure such payment or provide alternative arrangements in the event of circumstances which could cause a delay. Bidders will have five (5) after receipt of the material to return any lots misgraded or misdescribed. Lots must be returned intact in the original holder unmolested. No lots may be returned for any reason after thirty days from the sale date.
10. We intend treating our clients as we ourselves would be treated. Any dispute that may arise can be resolved by reasonable negotiation. We WANT to be fair.
11. A 5% buyers fee will be added to the total invoiced amount.

RARITY

The rarity ratings are based on the known notes in either large or small size series notes. This project began over twenty five years ago and has been contributed to by over 350 individuals and institutions. Approximately 125,000 notes have been recorded. The rarities are constantly changing as new notes are added to the census. This is an ongoing project and we appreciate the help we continue to receive. We all benefit from accuracy. The rarity scale is as follows:

- R6 None, one or two notes known to us
- R5 three, four or five notes known to us
- R4 six to eleven notes known to us
- R3 twelve to twenty four notes known to us
- R2 twenty five to fifty notes known to us
- R1 Over fifty notes known to us.

An asterisk (4*) indicates that one or more uncut sheets are counted in the rarity for that bank.

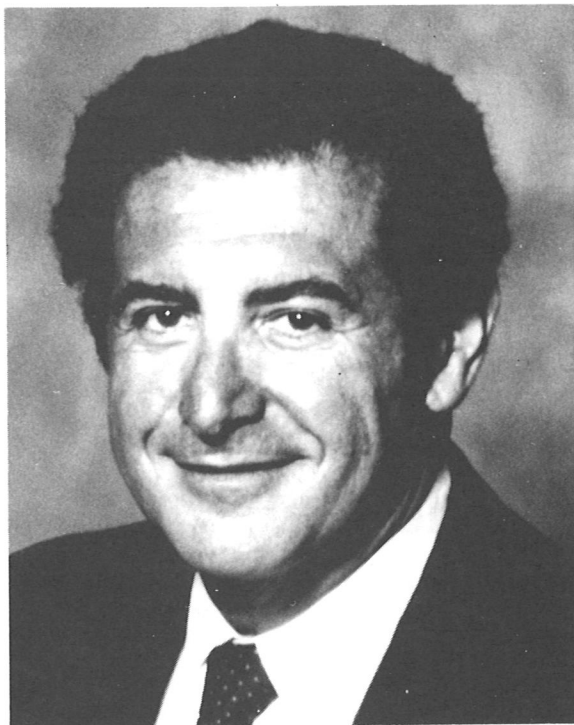

Philip Krakover was one of the movers and shakers of Los Angeles. A graduate of U.S.C., he worked in engineering and city planning for the city until he organized his own land planning and zoning consulting firm in 1964.

In eight years he single handedly processed or had a hand in over 3,400 planning, zoning, or land division projects.

In 1971, he became a founding partner in Engineering Technology, Inc., which grew to annual sales of over five million dollars and a staff of over 80 employees. Mr Krakover became well known for his willingness to undertake projects of great difficulty and immensity.

This trait carried over into his collecting activities. With great tenacity and resourcefulness he undertook the collection of National Bank Notes. Amazingly, he was able to acquire the largest and finest collection of California notes ever assembled in a little over four years. His premature death at 51 robbed his family of a husband and father, his community of one of its dynamic leaders, and our hobby of a very valuable and significant member.

His collection is testimony of his remarkable achievement. We are honored to have been chosen to offer it for sale.

Introduction

Welcome to the second Hickman auction of the 1990s. I am very proud to continue our new venture with such a distinguished offering as the Philip Krakover collection of notes from the first hundred national banks chartered as well as his collection of trade names, number one notes and his superlative collection of type notes. I would like to thank all of you who participated in the March sale of California nationals held in San Diego. There were 89 successful bidders and a realization of over \$291,000.00. As pointed out on the back of the enclosed bid sheet, we believe several records were set and broken with this landmark auction. We can all be proud that it went so well. Our feeling is that the notes realized pretty much what they are worth on the present market and that the successful bidders got value received. We are pleased that we received so many generous comments on the catalog and on the conduct of the sale. We thank you again. For this sealed bid auction we have material for every taste and purse. From the Montana territorial to notes just barely too good to spend and with many notes in between these two extremes. The estate of a client of many years standing has been consigned to us for auction. His collection was almost entirely made up of Series 1929 nationals from Pennsylvania. This sale includes the first of several portions of his material that will be offered in the next three or four sales. We feel an obligation to our clients to handle their material as judiciously as we would if it were our own whether it is of rare and high quality or of more modest pretensions. We haven't forgotten that most collectors do not start off with great rarities. Also, its the minor pieces that help to support the rare ones. Like chess where the pawns play an important part, so do the lesser notes. As in the previous thirty nine auction catalogs I have been involved in, I hope that you will find notes that will enhance your collection, gladden your heart, and leave your purse relatively intact. Hickman Auction's next sale is planned for the weekend of October 14th in Bloomington, Minnesota in conjunction with the 28th annual Minnesota Organization of Numismatist Show. This convention will be held at the Thunderbird Motel, 24th Avenue exit off I-494. The auction will feature the remaining currency in the Del Bertschy estate plus his collection of trade checks, mostly from Wisconsin. The most successful auction ever held by Hickman-Oakes was our 38th, held last September in Milwaukee. It featured currency from the Bertschy estate that had been accumulated over a period of almost sixty years. This next sale will be held in association with Dean Oakes Currency. We invite you to consider consigning material relative to the upper midwest particularly. We anticipate an enthusiastic reception in Minnesota where paper money collecting has a long tradition.

The collection of notes from the first hundred banks chartered is one of the earliest and most popular ways in which national bank notes were collected. The great Albert Grinnell collection contained notes from sixty eight of the first hundred banks, with numerous duplicates. William A. Philpott and Amon Carter, among other prominent collectors undertook this most difficult challenge. The most recent serious attempt was made by Philip Krakover, who in just over four years, assembled fifty four notes, twenty two of which are notes of the first charter period, many in superior condition. We are proud to begin our sale with a sequential listing of these significant notes.

1 1902 Dates The FNB of Philadelphia, Pa. F/VG
 CHARTER #1 #34293-N This is a very neat and acceptable specimen from our first chartered national bank. Well centered face and back and with bold signatures. Worth more than the \$75.00 Mr. Krakover paid to acquire it.

2 1902 The FNB of New Haven, Ct. AU
 CHARTER #2 #54754-C Cut close at the bottom but not touching the design. This note has been very gently handled and has the Speelman-White treasury signatures. Mr. Krakover paid \$142.50 for this beautiful note.

3 1902 The FNB of New Haven, Ct. VG+
 CHARTER #N-2 #9307-C A duplicate, probably purchased before the note above, that cost \$60.00.

4 1902 The FNB of Youngstown, Oh. F
 CHARTER #3 #87199-B A quarter sized brown stain in the border above the portrait and a close cut at the bottom left must be noted. Cost of this note was \$85.00.

5 1902 The F-Stamford NB, Ct. AVF
 CHARTER #4 #45763-E A handsome example with the second title. Acquired by Mr. Krakover @ \$85.00.



6 \$1.00 Original The FNB of Fremont, Oh. VG
 CHARTER #5 #4072-A Mr. Krakover paid \$281.50 for this rare original note with neat pen signatures of A. H. Miller and Jas W. Wilson. Notes from the recharter bank with charter number 5 are not rare, but this is only the third note known to collectors from the original bank. This note is worthy of a liberal bid.

7 \$5.00 1902 Red Seal The FNB of Syracuse, NY AVF
 CHARTER #6 #2218-B This is a vivid note from the first bank chartered in the state of New York. It has distinctive pen signatures of E. S. Tefft and E. B. Judson. Acquired @ \$350.00

8 \$1.00 Original The FNB of Cleveland, Oh. F
 CHARTER #(7) #1701-A This note is a very early issue with the treasury number without prefix or suffix. Nice brown pen signature of Geo Worthington, president. Cost was \$275.00.

9 \$20.00 1902 Dates The FNB of Cleveland CU
 CHARTER #M-7 #43111-B This was one of the few banks that issued notes of the same type with two different charter numbers. This is a genuine crisp uncirculated note and Mr. Krakover paid \$427.50 to acquire a superb specimen.

10 \$10.00 1902 Dates The FNB of Chicago U
 CHARTER #M-8 #52312-B Like the Cleveland bank notes from Charter number 8 can be obtained with two different charter numbers on the same type. This note is cut close at the bottom but not touching the design. This beauty cost \$300.00.



11 \$5.00 1875 The Second NB of Dayton, Ohio VG
 CHARTER #10 #2619-C This is one of the rarest notes among the first 100 charters. We know of only one other note, an 1875 ten. This one has a very distinguished pedigree as part of the Amon Carter collection. In November 1985 this note was Lot 1111 in the 29th Hickman and Oakes Cherry Hill, New Jersey auction where it was illustrated and sold @ \$550.00 to Philip Krakover. Since charter number 9, assigned to The FNB of Dayton is unknown to our best knowledge, this note becomes even more significant.

12 \$10.00 1902 FNB of Fort Wayne, In. VG-F
 CHARTER #11 #21459-A This note has the third of four titles and the second of two charter numbers used by this bank. Cut close and into the design at top right. Acquired @ \$45.00.

13 \$5.00 1902 The FNB of Erie, Pa. CU
 CHARTER #E-12 #11029-C This bank retained it's original charter number through three charter periods and the 1929 series and was still in business 100 years after it was chartered. This note is either Lot 4273 in Grinnell or it's twin. Purchased @ \$285.00.

14 \$1.00 Original The FNB of Springfield, Ma. G
 CHARTER #(14) #1132-C This is a very early and very well circulated note. Treasury number has no prefix or suffix. The brown pen signatures of J. D. Safford and James Kirkham are still vivid and legible. Mr. Krakover paid a very liberal \$400.00 to acquire this rarity.

15 \$5.00 1882 Brownback The FNB of Springfield, Ma. VG
 CHARTER #14 #22903-C Your choice of a note with or without the charter number. This handsome note is evenly circulated and has delicate brown pen signatures of D. A. Folsom and John Olmsted. Mr. Krakover paid \$175.00 for this one.

16 \$10.00 1902 The FNB of Davenport, Ia. CU
 CHARTER #15 #29939-E This was the first national bank in the United States to open for business and was for two days the only national bank in operation. Mr. Krakover paid \$237.00 to acquire this top quality specimen.

17 \$5.00 1902 The FNB of Richmond, In. VG
 CHARTER #M-17 #11852-C Blue seals from this bank come with plate dates with 1902 and 1922. This note has the 1902 date. Purchased by Mr. Krakover @ \$73.12.

18 \$1.00 Original The FNB of Portsmouth, NH XF
 CHARTER #19 #9186-B You're sure to like this beautiful note from New Hampshire's first national bank. Very distinctive brown pen signatures of E. P. Kimball and W. H. Y. Hackett, well centered with generous margins face and back, and vivid color, all add up to a winner. Mr. Krakover purchased this note @ \$427.50.

19 \$10.00 1902 The Fifth-Third NB of Cincinnati, Oh. F
CHARTER #20 #208260-J This note has an unusual title for such a low charter number. This was originally The Third NB of Cincinnati. Mr. Krakover paid \$80.00 for this one.

20 \$1.00 Original The FNB of La Fayette, In. AF
CHARTER #(23) #4605-A In the Max Mehl sale of Albert Grinnell's notes which preceded the Barney Bluestone sales, and which also contained Mr. Grinnell's coins, Lot 1105 was a \$1.00 note on this bank described as about fine which sold @ \$1.80. No serial number was mentioned but plate position A was part of the description. I believe that this is that note. If it is, then there are only two surviving notes from charter number 23 known to collectors. Mr. Krakover paid \$450.00 to acquire this great rarity.

21 \$5.00 Original The FNB of Cincinnati, Oh. F/VG
CHARTER #(24) #17558-A There are two and possibly three of these original fives known to collectors. This note is exceptionally evenly circulated with no impairments. Acquired @ \$400.00.

22 \$5.00 1902 Dates The FNB of Cincinnati, Oh. CU
CHARTER #M-24 #176301-Q This is a very choice note, purchased as a "Gem CU" @ \$295.00 by Mr. Krakover. It's a beautiful note.

23 \$5.00 1902 The FNB of Cincinnati, Oh. F
CHARTER #M-24 #389719-Hh Another duplicate from this interesting bank. This acceptable note cost \$26.40.

24 \$5.00 1902 The FNB of Marietta, Pa. VG-F
CHARTER #25 #26351-A This note is pen signed by R. C. Engle and John Orth. It was purchased by Mr. Krakover @ \$100.00.

25 \$5.00 1902 Dates The FNB of the City of New York CU
CHARTER #E-29 #638699-E3 This note is the finest of four high grade five dollar date backs recorded from this bank. Purchased by Mr. Krakover @ \$225.00.

26 \$10.00 1902 The FNB of Wilkes Barre, Pa. AVF
CHARTER #E-30 #55882-D Ornate and oversized signatures of Francis Douglas and William S. McLean make this nice note more appealing. Acquired @ \$80.00.

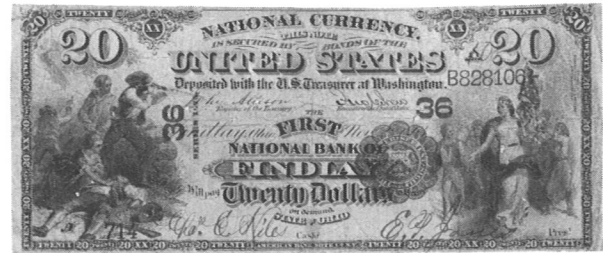
27 \$10.00 1875 The FNB of Huntingdon, Pa. XF
CHARTER #31 #1713-A "Rarity 5. Lot 4293 in the great Grinnell sale and still as nice as it was then, or even a hundred years ago. Cut close at top, but has prime brown pen sigs and excellent color. A note of considerable merit worth a bid in the range of \$750.00" This was the description used in the H & O November 1985 auction where Philip Krakover acquired this note for \$498.75.

28 \$5.00 1902 The FNB of Huntingdon, Pa. F
CHARTER #31 #29762 Still a rarity 5 with only four notes known to us, this being the only blue seal among them. Mr. Krakover paid \$121.00 for this rare specimen. An opportunity for another collector to acquire this rare charter number.

29 \$10.00 1902 The Second NB of Cincinnati F-VF
CHARTER #32 #52198-C \$50.00 was paid for this neat Ohio note. A lot of history for the money.

30 \$2.00 1875 The FNB of Rondout, NY G-VG
CHARTER #34 #2-A Its unusual to find a Lazy Two with serial # two. This bank is also unusual in that the successor bank with the same title, charter #2493 also issued Series 1875 notes. This bank remains a Rarity 5. \$350.00 was paid for this most interesting note.

31 \$2.00 1875 The FNB of Fishkill Landing, NY F
CHARTER #35 #532-A Another rare lazy two, this one from Dutchess County. Attractively pen signed by M. E. Curtiss and James Mackin. Mr. Krakover paid \$650.00 for this note.



32 \$20.00 1875 The FNB of Findlay, Oh. VG-F
CHARTER #36 #714-A You'll like this extremely rare note, the only one known to collectors with this title. All other notes with charter #36 have the second and third titles. Very ornate signatures of Chas E. Niles and E. P. Jones and excellent color for the grade help us understand why Mr. Krakover paid \$900.00 to acquire this unique specimen.

33 \$10.00 1902 Red Seal The FNB of Aurora, Il. Soiled VG
CHARTER #M-38 #1915-B This well circulated but rare red seal was part of the same northwest Iowa cash hoard that contained the Colusa, California note among many others. Purchased @ \$200.00.

34 \$5.00 1902 The FNB of Towanda, Pa. VF
CHARTER #39 #26349-E Another of the first 100 banks that issued notes during all three charter periods and 1929 series as well. This note has heavy signatures of W. E. Lane and G. F. Dayton, Vice. Purchased for \$38.50.

35 \$10.00 1902 The FNB of Strasburg, Pa. VG
CHARTER #E-42 #2641-C This vivid note is legibly pen signed by J. H. Wolf and Robt S. McClure. Mr. Krakover paid \$100.00 for this seldom available note.

36 \$10.00 1902 Dates The FNB of Ellenville, NY F
CHARTER #E-45 #946-F Another nice note with attractive pen signatures. This one signed by F. B. Hornbeck and M. E. Clark. This elusive New York note cost Mr. Krakover \$360.00.

37 \$20.00 1902 The FNB of McConnellsville, Oh. XF
CHARTER #46 #7665-A This type comes with two different dates, 1902 and 1922. This note has the 1922 date, the so called "fourth charter". Two vanity pen signatures of S. A. Finley and J. T. Stanton enhance this handsome note. Acquired @ \$180.00.

38 \$20.00 1902 The FNB of Terre Haute, In. CU
CHARTER #47 #87943-B Another superlative note from the Philip Krakover collection. This one was purchased @ \$237.50.



39 \$50.00 1902 Red Seal The FNB of Pittsburgh, Pa. AF
CHARTER #48 #1737-A The fifty dollar red seal has proved to be one of the most elusive of all the denominations and types among National bank notes. Our census for the entire country indicates that there are less than fifty notes known to collectors. The availability of this rarity gives the collector of low charter numbered notes the opportunity to acquire a very rare type as well. Mr. Krakover paid \$752.00 for this great note and got a real winner.



40 \$5.00 Original The Second NB of Scranton, Pa. F
CHARTER #(49) #3789 This note must be counted among the very rarest notes in this collection. We know of no other notes from this bank and we believe the prospect for additional notes is very slim. This bank issued original fives and tens only and we are lucky even this one survived. Mr. Krakover paid \$660.00 for this unique note, and was well served.

41 \$10.00 1902 The FNB of Johnstown, Pa. VF-XF
CHARTER #E-51 #38658-B This is an exceptionally bright and clean note. Purchased @ \$200.

42 \$5.00 Original The FNB of Newark, NJ VG
CHARTER #52 #12288-D This bank issued first charter notes only. This very early and evenly circulated note cost Mr. Krakover \$220.00.

43 \$5.00 1902 The FNB & Trust Co of Hamilton, Oh. VG
CHARTER #56 #7534-D Notes from this bank with the second title are rarer than notes with the first. This note cost \$60.00.

44 \$1.00 Original The FNB of Newville, Pa. VG-F
CHARTER #60 #1009-B We know of no other first charter notes from this small bank. Mr. Krakover got a great bargain when he purchased this very rare note for \$150.00.

45 \$10.00 1902 The FNB of Newville, Pa. VF
CHARTER #60 #23193-E Another bargain. This note was purchased by Mr. Krakover for only \$52.50. Notes on this bank are rare and rarely available.

46 \$5.00 1902 Dates The Second NB of the City of NY CU
CHARTER #E-62 #24119-E You're not likely to find a nicer note than this from this bank, or for that matter from most others. Acquired @ \$220.00

47 \$10.00 1902 F Wisconsin NB of Milwaukee, Wi. VF
CHARTER #M-64 #38143-B This note is dated April 25, 1902, and cost Mr. Krakover \$49.50.

48 \$20.00 1902 F Wisconsin NB of Milwaukee, Wi. VG-F
CHARTER #64 #90188-B This note is dated April 24, 1922, and cost Mr. Krakover \$43.50.

49 \$2.00 1875 The FNB of Portsmouth, Oh. AU
CHARTER #68 #1049-A This is a very sharp fresh note with very slight evidence of handling. This note may very well be Lot 4333 in the Grinnell sale described as CU. Whether it is or not it's a note you're sure to like. Philip Krakover paid \$1200.00 for it and got a note of exceptional quality.

50 \$5.00 1902 The FNB of Portsmouth, Oh. AVF
CHARTER #M-68 #39094-H A very acceptable duplicate for which Mr. Krakover paid \$180.00.

51 \$1.00 Original The FNB of Cambridge City, In. G
CHARTER #70 #1713-B This well circulated note is one of only two known to collectors from the original bank, and even the restored charter 70 on charter #2734 is rare since only fifties and hundreds were issued. Look this one over, you may never see another. Purchased by Mr. Krakover @ \$505.00.

52 \$20.00 1902 The FNB of Canton, Oh. VG
CHARTER #76 #116886-E This well circulated note cost \$58.50.

53 \$20.00 1902 The FNB of Scranton, Pa. VG
CHARTER #77 #273970-E Another well circulated note, this one is an old friend; Lot 715 in the H & O October 1984 auction where it was acquired by Mr. Krakover @ \$45.00.

54 \$20.00 1875 The FNB of Worcester, Ma. VG
CHARTER #79 #2102-A Ex Amon Carter Collection. This note has a one inch repaired tear at the center of the bottom margin. First charter notes only were issued by this bank and this is the only known twenty. Mr. Krakover paid \$345.00 to own this rarity.

55 \$2.00 Original The FNB of Lawrenceburgh, In. VG
CHARTER #(82) #1085-A This note has blue treasury serial numbers, used for a very short period. We believe this note is unique for this bank and aside from a five dollar proof note that was sold in the H & O April 1977 auction, we know of nothing from this bank. Prospects for more notes in the future are dim. Mr. Krakover paid \$1175.00 to acquire this great rarity.

56 \$2.00 1875 The Third NB of the City of NY F
CHARTER #87 #4755-A There are three or four of these Lazy twos from this bank, all 1875 series. This one cost \$550.00.

57 \$2.00 Original The FNB of Upper Sandusky, Oh. VG
CHARTER #(90) #1782-A This bank issued notes from all three charter periods as well as 1929 series notes. All are scarce to rare. This note, the only lazy two we know of, cost \$650.00.

58 \$1.00 Original The FNB of Toledo, Oh. VG-F
CHARTER #(91) #49856-C Another note with blue treasury serial numbers and brown pen signatures of S. S. Hubbard and N. V. Nearing V. Mr. Krakover paid \$240.00 for this note.

59 \$10.00 1882 BB The Fourth NB of Cincinnati, Oh. VF
CHARTER #93 #15431-A Included with this handsome note is the penned autograph signature of James Gilfillan, Treasurer of the United States, whose signature is part of the Bruce- Gilfillan treasury signature combination found on this note. Collectors who were active in the 1960s will remember Julian Marks of Cincinnati whose collection included this note. Acquired by Mr. Krakover @ \$240.00.

60 \$10.00 1902 Red Seal The Fourth NB of Cincinnati CU
CHARTER #M-93 #15693-A Cut close at the top, touching the design at the right, otherwise flawless. Acquired @ \$378.00.

61 \$2.00 Original The FNB of Port Jervis, NY G
CHARTER #(94) #1219-A Albert Grinnell had a patched Lazy two graded VG, but we know of no others. This well circulated but whole note cost Philip Krakover \$282.00.

62 \$5.00 1902 The FNB of Ironton, Oh. VF
CHARTER #98 #66496-I The grade has been lowered on this almost uncirculated note for minor discoloration, mostly on the back. This note cost Mr. Krakover \$45.00.

63 \$20.00 1902 The FNB of Moravia, NY VG

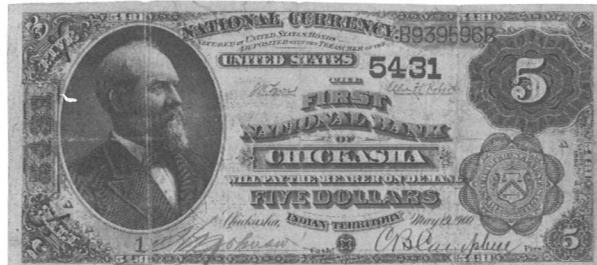

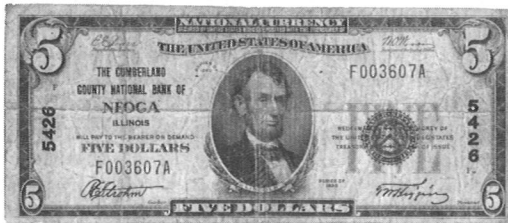

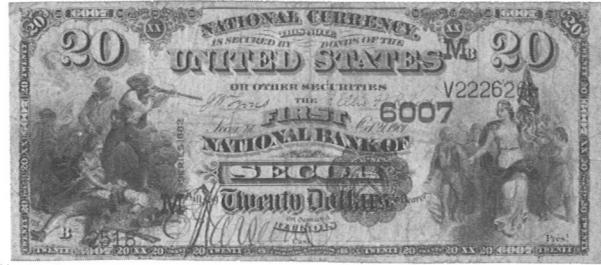

Cedar Falls Bank
Given 1874 Dollar

(COURIER NEWS SERVICE)
CEDAR FALLS—A dollar bill issued in September, 1874, by the First National Bank of Cedar Falls has been presented by the Hanover Bank of New York to what they decided was the "next of kin," the First National Bank in Cedar Falls. The bill, which the New York bank's secret service verifies as "genuine and still worth \$1," turned up in the effects of a deceased customer of the National Provincial-Bank, Ltd., of London, England, the London branch of the Hanover bank.

THE BANK'S vice president, George H. Haslam of New York, had the bill framed and suitably inscribed and sent it

to the First National Bank in Cedar Falls as "a memento of historical interest."

Although the First National Bank of Cedar Falls and the present First National Bank in Cedar Falls vary only by one word in title, they are unrelated.

The earlier bank was organized by two brothers who came themselves from England to Cedar Falls and the bill bears their signatures: William Fields, president, and C. J. Fields, cashier.

THE MEN operated a horse importing business in Cedar Falls on Highway 57 in a barnonial establishment which included a family chapel and the family's own minister. The stone barn, widely used by area artists for a painting subject, remains.

The bank which the brothers operated failed in 1893.

I understand that they both returned to England after the bank failed and they doubtless took this note and possibly others with them. A note of this caliber and merit is worth whatever it cost. 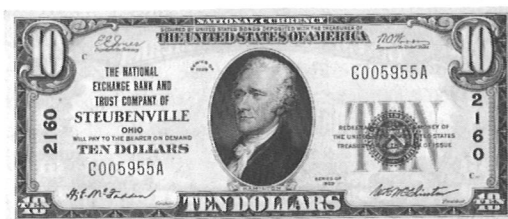

I first met John Waters in the very early 1960's when he came to work for Merchant Money Orders, Inc. a firm in which I had a 25% interest. When we sold the company to Traveler's Express, John went to work for the Central National Bank in the installment loan department. In 1965 we formed a partnership to deal in coins and bank notes. We started with borrowed capital of \$1600.00 and my collection of nationals which I sold to the partnership. As can be seen from these lists, we were pioneers in this field buying and selling notes at very modest prices and operating on a very small scale. We operated with almost zero overhead, using his free checking account, and my post office box, (I kept this box #260 in Des Moines, until last year) and using the bank's typewriter and mimeograph. Our success was slow and modest, but we were learning about national bank notes, and customers and friends we made in the beginning are still receiving these catalogs. Over the course of our partnership we handled the Alaska uncut pair of type two \$5.00s, the first sheet of Alaska Red Seals to be cut, and the great Winnemucca brown back among many hundreds of other common, scarce and rare notes. John Waters withdrew from the bank note business in early 1972 to devote more time to his family. Today, he is the treasurer of a sizable trucking Company, and in good health. Many of you will remember the short notes he sent along with the notes, which went out promptly the day after the order was received. I still miss him. Had I not my own copy of these lists, I would be a formidable competitor to acquire them. These lists are unique and irreplaceable. Bid liberally.
