# **PEOPLE AND THE OCEAN - Fishers as Stewards of Biodiversity**



A session to showcase fishers as stewards of marine biological and cultural diversity, challenging the common narrative that people are separate from nature. By opening the space for fishers representatives to talk about their lived experiences, we will highlight their role as key players in delivering on the Global Biodiversity Framework (GBF). Join us in exploring how fishers across scales and regions offer solutions and how the GBF provides an opportunity to connect people and the ocean for ecological health and human well-being.

#### **KEY ELEMENTS**

Kicking things off with an interactive segment to unpack people's connections to the ocean and marine environment, we'll capture the vibrant and ever-evolving relationship between the sea and fisher communities through a dynamic activity using AI-generated images, highlighting how the GBF offers an opportunity to further connect people and marine biodiversity. These images will present alternative scenarios, challenging us to rethink how we coexist with the ocean and its biodiversity.

Next, the spotlight will shine on "Fishers' Voices," as three fishers representatives take us into their world, sharing their personal stories as stewards of the ocean. Providing on-the-ground perspectives, they will highlight challenges and opportunities and demonstrate how positive engagement of fishers across scales in the GBF is critical to achieving its Targets. To broaden the spotlight, we'll also showcase powerful video messages from fisher communities across the globe.

The session will close with a powerful call to action from a country representative, urging us to harness this momentum and rally Parties to fully integrate biodiversity into fisheries management.

# 11:30 AM - 12:30 PM **THE CONNECTED OCEAN** SERVICE STREAM STREAM

The ocean world is a web of connections on a myriad of scales: between animals, up and down the food chain, between marine life and the physical environment, and between the ocean, the land and the atmosphere. Humans and institutions are an integral part of this network too, relying on the oceans to provide food, clean air, climate control, transport and resources. This session takes a look at some of the members of the great ocean family and the threads that bind them together, using the analogy of a family house.

#### **KEY ELEMENTS**

The importance of stable, safe feeding and breeding grounds for marine animals to gather, socialise, rest and feed, and how these activities drive the great ocean food chain and contribute to nutrient cycling. For migratory species, the connections between these areas – often ocean basins apart – are vital. Climate change and human activities such as shipping, pollution, mineral extraction, noise and light pose significant threats to all these areas of the ocean family house.

But there are actions in place to help safeguard these important areas of the ocean. Target 3 of the GBF sets out to protect 30% of the global ocean; the new BBNJ Agreement brings opportunities for protecting the high seas; at more regional and national scales measures such as species-specific management plans and industry-oriented tools such as PSSAs can provide solutions.

People are part of the great ocean family too, and working together is key to effectively safeguarding it. We explore some innovative approaches by small island developing states that help ensure resources are made available for sustainable, long term biodiversity conservation.

### **KEY ELEMENTS**

In this episode, we will dive headfirst into the transformative Ocean Breakthroughs! Across five sectors – marine conservation, ocean renewable energy, shipping, aquatic food systems and coastal tourism – these Breakthroughs are paving the way for a net-zero, resilient, and healthy planet. The fundamental question is: What must we achieve by 2030 to transform how these sectors operate and realise this vision by 2050?

In the first segment, five contestants will pitch their Breakthrough and highlight how their sector can achieve key targets from the GBF while driving real progress on climate objectives. Watch as they bring these critical sectors to life, showing the path to living in harmony with nature delivering meaningful benefits for Nature, Climate, and People.

The spotlight will then shift to our other guest stars: Ocean Champion Countries. Through powerful testimonies, they will present their national plans and strategies to bring these Ocean Breakthroughs to reality. From cutting-edge finance solutions to scientific research and governance reforms, they will reveal the levers that can propel these sectors forward.









# 2:30 - 3:30 PMScience & Technology for action $\widetilde{O}$ </

This session will discuss the role of ocean science and knowledge to support implementation of the GBF. It will explore the links across the ocean science value chain from observations to data to science and knowledge and the importance of ensuring sustained investment in capacity development and transfer of technology. It will showcase the work being carried out in the framework of the UN Decade of Ocean Science for Sustainable Development, and other initiatives as tangible examples of the role of science, knowledge and technology in implementation.

#### **KEY ELEMENTS**

The first segment of this informal "seaside chat" will explore the different elements of the ocean science value chain with speakers discussing the role of observations (POGO), data (INVEMAR), science (PML) and the ways in which they inform policy (DEFRA).

The second segment will showcase three successful examples of where the different parts of the ocean science value chain have combined to generate knowledge that has a positive influence on policy. Examples include regional case studies and the work emerging from the Ocean Decade Vision 2030 process. Speakers will provide their views on factors of success (and failure) and common lessons for working across scales to support implementation.

The session will conclude with closing remarks from three UN agencies – IOC, UNEP and ISA – and will end with the launch of a new publication showcasing numerous examples of Ocean Decade Actions that are contributing to GBF implementation.
