Sixto Cancel Founder & CEO, Think of Us

Sixto Cancel is the Founder and CEO of Think of Us. Think of Us (TOU) is an Action Tank driving systematic change in child welfare. Through focused projects and sweeping initiatives, TOU drives structural changes in child welfare policy and practice. Sixto was named as Forbes Top 30 Under 30 Social Entrepreneurs and is on the 2021 Forbes Under30 Lister Board. Sixto has been recognized by the White House as a "White House Champion of Change," a "Millennial Maker" by BET, and named "Top 24 Changemakers in Government under 24" by the Campaign for a Presidential Youth Council and Sparkaction. Sixto has served as a Young Fellow at Jim Casey Youth Opportunities Initiative since 2010 where he has played a key role in the initiative's work of extending foster care permanency for older youth. Sixto is a Clinton Global Initiative University Alum, a FastForward Alum, an Ashoka Fellow, a Board Member of Adventr – an interactive SMART video tech company – and most recently on the Advisory Board for Box, Inc. Sixto and the team at Think of Us are working to ensure that every person has the conditions they need to heal, develop, and thrive.



Kristi Craig Senior Director of Public Policy, Casey Family Programs

Kristi is Senior Director on the Public Policy team for Casey Family Programs. In this role, she supports the foundation's efforts to inform and educate federal and state policymakers about the need for practice and funding strategies that support efforts to improve outcomes among children and families. She also supports the foundation's efforts to improve child welfare public policy in states across the country. He also produces and writes Child Welfare Wonk, an online publication for child welfare policy professionals, and founded and runs a policy and advocacy consulting practice related to child and family health and wellbeing. Prior to launching his entrepreneurial ventures, Zach spent nearly 12 years at the American Academy of Pediatrics (AAP), most recently as Director of Federal Advocacy & Child Welfare Policy. Zach holds a Master of Public Health in Health Policy from The George Washington University and a dual BA in Political Science and International Studies from American University.



Dawn Wilson, MSW

Director, National Training Institute, Center for Adoption Support and Education

Dawn Wilson, MSW, Director, C.A.S.E. Training Institute, has more than 30 years of experience in the child welfare, mental health and prevention fields, with expertise in program development and implementation. As Director of the federally funded National Adoption Competency Mental Health Training Initiative, Ms. Wilson oversees the development, pilot implementation, evaluation and national launch of two state-of-the-art web-based trainings for child welfare professionals and mental health clinicians to effectively address the mental health and complex challenges of children, adolescents and their families moving to permanency through adoption or quardianship. Previously Ms. Wilson served as a Child Welfare Program Manager with Catawba County Social Services in North Carolina overseeing prevention, family reunification, independent living, and post-permanency services. She worked collaboratively with The Duke Endowment on the Child Well-Being Project to develop, implement and evaluate an evidence-informed post-permanency service, Success Coach, to provide case management and in-home therapeutic services to improve outcomes for adoptive, quardianship and reunified families following foster care. The Success Coach Service garnered national attention as a promising practice and was the recipient of the 2013 Youth Thrive Award from The Center for the Study of Social Policy; the Transforming Local Government 2014 Alliance for Innovation Award; and the Harvard Kennedy School Ashe Center 2015 Innovations in American Government Award. Prior to her work in child welfare, Ms. Wilson worked in the prevention and intervention fields focusing on domestic violence, sexual abuse, and teen pregnancy. Ms. Wilson received her B.A. Degree in Psychology from Appalachian State University in North Carolina and her Master of Social Work degree from the University of North Carolina at Chapel Hill.
