

### **Advocacy 31nine**

Advocacy 31nine advocates for children in foster care who move from family to family. Many foster children "fall through the cracks" because they are moved from school to school. A recent study showed that children who live with trauma early in life are 32 times more likely to struggle and have learning difficulties in school. Advocacy 31nine tracks the children, advocates for them, attends and educates the foster parents on IEPs and attends meetings about said IEPs. Children have benefited from this organization by receiving the services that they need to be successful and to live a full life after they leave the foster care program. Since it's inception, Advocacy 31nine has unlocked over \$3 million dollars of services. They have served over 1,000 students and have the backing of over 25 community partners. Without these interventions, many of the foster children will end up in jail or dropping out of school because they had no one to advocate for them. Nicole Marshall and Jenny Mullins are the cofounders of this organization and have already helped multiple families unlock services that otherwise would not be available.

#### **Peter and Julie Bartolini**

Peter and Julie Bartolini are the founders of Firm Foundation Youth Homes. Peter has spent the last 25 years working with and advocating for children who come from hard places. Since Peter and Julie first becoming foster parents in 2004, they have had over 30 kids placed in their home. Since 2001, Peter has worked with Royal Family Kids' Camp and Hope & a Future, putting on week-long summer camps and a life-skills mentoring program for kids who are in foster care. Peter is also a speaker and trainer for Family Matters, a national ministry that helps parents raise truly great kids. Julie is a trained practitioner for Trust-Based Relational Intervention® (TBRI®). During the years of foster care in their home, Peter and Julie took in all comers from newborns who needed immediate respite to multiple kids whose families had failed them. In all cases the children were received with joy and love. Because of the tranquility with which foster kids were received in the home, Peter and Julia's biological children, Natalie and Sam, have been an added component of care, making family love a reality for every child they bring into their home. Peter and Julia have maintained open lines of communication with the families of their kids, even when their time of fostering was over. Many of these relationships remain fresh and vibrant today for the benefit of the child. When adoption was available, Peter and Julia were willing to seek it: three of their five children are adopted.



#### **More Than A Bed**

More Than a Bed provides free essentials to Southern Arizona foster, kinship, and adoptive families because a child that has been removed from their home often arrives with little-to-no belongings. More Than a Bed provides car seats, underwear, shoes, and, yes, beds. More Than a Bed understands it is the basics that give children and their families dignity and a sense of value and hope.

More Than a Bed's 5000 sq. ft. warehouse of donated clothing and household goods is open to foster, kinship, and adoptive families to shop for what they need. They also provide urgent services and goods for families that receive an emergency placement. More Than a Bed has seen exponential growth in the number of families and children they serve, growing from 5 families served in 2014 to 796 families in 2020. On average they serve 27 new families per month. The COVID-19 pandemic did not slow the need of the community's children and More Than a Bed adopted the necessary protocols to safely keep their doors open.

Time and time again, families credit More Than a Bed with providing an invaluable service to them during their foster care journey. The accolades usually begin with phrases such as, "We couldn't have done it without Grace and More Than a Bed..." or "More Than a Bed saved us when the kids arrived..."

## **Jenny Mullins**

Jenny and Advocacy31nine gives resources to help foster parents make the best choice for the education of their children. Jenny is there to help every step of the way, while empowering families with knowledge and choice.

Amelia and Arnoldo have been foster parents since June 2015. They helped a young man that had Type 1 diabetes get healthier and maintain contact with his step-siblings while he was in their care. They also helped him transition to an adoptive home. Currently they are working with siblings, ages 3 and 6. The 3 yr old girl is lively, energetic, very creative, and imaginative. Her older brother has been diagnosed with Autism. This is their 4th placement since being in the foster care system for 2 years. The little girl attends a learning center where she has excelled in her social skills.

The 6 yr old started in person school because virtual school was difficult for him. In the foster home he can anticipate his routine and helps his sister as well as picks on her, as any big brother would. Amelia and Arnold, at the beginning, were feeling that they may not be the best match for the kids. The 6 yr old had daily tantrums where he would throw himself on the floor and was not willing to participate in activities. His sister was afraid of him and the foster parents' own son, who is 5 yrs old, was not wanting to play with either child. The pandemic made it extra difficult as they were limited to being home, not even able to go out to parks as they were closed. Services were not coming into the foster home. However, Amelia and Arnold persevered and both kids are successful. The siblings take pride in caring for their belongings and being able to meet their needs met. The little girl has had the services necessary to have her developmental needs met. The little boy has the desire to do things and be a helper, also improving in all areas of development. Amelia & Arnoldo and their son have been loving, patient, resourceful and most of all inclusive. They continue to support the children in maintaining a meaningful relationship with their biological parents.

Mr. Bailey grew up in the foster care system his whole life: living in foster care homes in Dallas, Texas to group homes in Van Nuys, California. Mr. Bailey found his forever family with the help of Kidsave and CEO Randi Thompson. Tyerae Bailey has been a figure for foster youth all across the country: saying "We must progress together, no matter how long it may take." Mr.Bailey has been a spokesperson for Kidsave International for over 2 years and a child advocate his entire life. Mr.Bailey travels across the country from Los Angeles to Washington D.C.. Most recently he helped Kidsave International open a new program in Houston Texas! Mr.Bailey has been able to be a part of an Emmy Award winning national television show on the A&E Network called "The Day I Picked My Parents!", produced by Naked Entertainment. Tyerae Bailey aims to dedicate his life to making the lives of each and every child and citizen of the world better everyday. Mr. Bailey enjoys being around children and spending time with them because it allows him to reflect and remember why he does what he does and why he loves it!

### **Angela Featherstone**

Angela Featherstone experienced abuse and neglect growing up which continued when she was put into the foster care system in Canada at the age of 16. The abuse and neglect stopped when she was emancipated at age 17.5. Within a year of emancipation, Featherstone became one of Canada's top models. However, the effects of her traumatic past continued and she did not have the coping mechanisms to handle all of life's ups and downs. This led her to start a nonprofit called Fostering Care in 2020. Fostering Care is a 501(c)(3) nonprofit organization based on Featherstone's first-hand experience with trauma and the foster care system. Fostering Care offers a holistic healing school for youth aging out of foster care. This school is the first of its kind and hopes to alleviate the negative outcomes that many youth experience after aging out of the foster care system. To do this, Fostering Care ensures each student receives a teaching certificate in a healing modality, such as yoga, meditation, or breathwork. Additionally, Fostering Care hosts guest lectures on topics such as drug dependency, nutrition, and various life skills. Featherstone hopes each student is able to achieve self-sufficiency, positively contribute to society, and help others heal upon completion of the healing school. Click to go back to the first page

#### **Sari Grant**

Sari Grant is a passionate, committed advocate for foster youth. She is a licensed clinical social worker who has worked for the Los Angeles County Department of Child and Family Services (DCFS) for over 30 years. Sari is currently a DCFS Children's Services Administrator III responsible for child-specific, targeted, and general recruitment of adoptive families. She also oversees DCFS's Permanency Partners Program, which is responsible for family finding and engagement services for LA County.

Sari is DCFS's Liaison for Kidsave's Los Angeles Weekend Miracles program (LAWM), an innovative family visit program that helps older foster youth in LA County (ages 9-17) find adoptive families and lasting connections with caring adult mentors. LAWM provides a unique opportunity for children and prospective families to meet, and for relationships to form naturally. Once people meet and get to know the children, their challenges become something the families want to help them overcome. Participating youth in care are given a choice as to which families they want to form a weekend hosting and/or permanent relationship with. LAWM is changing how child welfare systems search for families for older children. Sari was largely responsible for changing DCFS social worker reluctance to referring children to LAWM, many of whom did not believe that families could be found for these youth.

#### **John Burton Foundation**

John Burton Foundation has been the pioneers when it comes to legislation and advocacy for youth that have experienced homelessness and foster care. They championed many bills that have positively impacted the lives of these populations such as cosponsoring AB12 (Extended Foster Care), AB153 Housing Investments for TAY foster youth, AB153 Expectant Parent Payment for pregnant foster youth, AB132 establish a Basic Needs Center in CA Community Colleges, and much more. This organization proactively addresses the challenges and opportunities our youth face from housing and homelessness, K-12 and higher education, economic security, health, and basic needs. When COVID-19 hit, they were in the frontlines of advocacy sharing the outcries of current and former foster youth through their publication: "JBAY: Hanging By a Thread." This publication exposed the trauma and deficits of resources that youth in care encountered. In our nation's crisis of COVID-19, JBAY was able to spread resources and awareness about youth in care. Youth were able to remain in the foster care system beyond age 21 (through December 31, 2021) which helped prevent them from being homeless during a health crisis.

JBAY doesn't just stop at passing bills but prides themselves in implementation. One great example is Homekey which is included in Governor Newsom's \$2.75 billion program to reduce homelessness. JBAY successfully advocated for 8% of this funding to address youth homelessness. That's \$220 million! Recently, JBAY launched their Critical Needs and Opportunity Fund which

pays for critical needs for youth, ages 16-26. For example, former foster youth Patrick was forced to leave his apartment due to his roommate being contracted with COVID-19. With no family support, JBAY stepped in to pay for a hotel thus preventing him from being homeless. This type of support saves the lives of many foster youth.

This organization doesn't ever stop thinking big and continues to be the heroes in our communities.

### **Celeste Liversidge**

Attorney Celeste Liversidge has been practicing exclusively in the field of adoption law since 2001. She is a fellow of both the American Academy of Adoption Attorneys and the Academy of California Adoption Lawyers and a member of the National Association of Counsel for Children, Christian Adoption Legal Services, National Council For Adoption, and the North American Council on Adoptable Children. Celeste earned her law degree from Pepperdine University School of Law and her undergraduate degree from Westmont College. She has served on numerous boards and is an adjunct professor at Pepperdine School of Law.

Celeste founded Ethical Family Building, a nonprofit 501(c)(3) organization which encompasses AdoptMatch, which is committed to promoting ethical standards in domestic adoption, TruAdopt, a nonprofit law firm that exists solely to provide free legal representation to expectant moms considering adoption, AdoptConnect, a platform where adoptive parents and birth parents can securely share photos and communication in an open adoption, and Adoption Law Group, a law firm dedicated exclusively to adoption. Celeste is a powerful advocate for safe, child-centered adoptions and providing support for birth moms after placement. Celeste is an impactful leader among adoption attorneys nationwide, always pushing for higher ethical standards in the adoption field.

### **Helena Lopez**

Helena Lopez's service to children in need began when she was a child. When she was 10 years old, Lopez's mother opened three group homes for teenagers in foster youth. Lopez saw the residents as her siblings and fondly remembers how many of them attended her Junior High School promotion: "I had the biggest crowd of family there." Years later, Lopez became a Case Manager at the Greater Hope Society group home, where she relished in empowering foster youth.

After law school, Lopez worked in real estate law in San Francisco until she received a fateful phone call. Her mother needed Lopez's signature tenacity and leadership in launching a foster family agency called A Greater Hope in Barstow, California. The County of San Bernardino needed an agency in their community as no other providers would travel to the High Desert at that time.

Demonstrating her characteristic compassion, Lopez told her mother "yes" and moved to Barstow, California. Lopez put her expertise in management, contracts, and research to work as she served as A Greater Hope's Executive Director for 17 years. In January of 2019, Lopez was appointed CEO. Under Lopez's leadership the organization has grown to four locations with multiple programs, more than 50 employees, and is the largest provider of safe and loving families for foster children in San Bernardino County. Since 2002, more than 6,000 children have found loving foster homes through A Greater Hope.

A recognized leader in foster care, Lopez is the 2021 President of the California Alliance for Children and Family Services. She is also a member of the Alliance's Leaders of Color group. She served as the past President of the Inland Empire Alliance and is currently the Co-Chair of the Association of Foster Family Agencies.

#### **Theresa Marcroft**

Terri's, passion for adoption originated over 21 years ago, when she became a mom. Terri's daughter's birthmother made an adoption plan in 1999, while she was a senior in high school. Terri and her husband witnessed Sydney's birth and brought her home from the hospital when she was only 24 hours old. They have cultivated and enjoyed an open adoption since then.

Terri's passion for adoption goes far beyond being an adoptive Mom. In 2008, Terri identified the need to actively advocate for adoption. When many of her friends were facing infertility, they looked into adoption but few newborns were available. Terri's research, plus a series of focus groups and interviews, showed that young women today don't even realize that adoption is an option. As a result, less than 2% of young American women facing unplanned pregnancy choose adoption for their babies. In California, that number is less than 1%. At the same time, there are over one million childless couples in the US hoping to adopt.

After ten gratifying years of parenthood, and 25 in high tech marketing & communications, Terri founded Unplanned Good Inc. to get adoption on the radar of young women facing unplanned pregnancy. She leads the organization's efforts to encourage pregnant girls to consider adoption. Unplanned Good partners with local pregnancy & medical clinics to provide information and encouragement about adoption. The Unplanned Good web site offers testimonials from birthmothers, adoptees, and adoptive parents so that young women can learn more about this option. They publish a monthly newsletter, advertise online, and speak at both local and national conferences. Terri and her team spread the word that open adoption can be a huge blessing for all involved.

Terri is also on the Board of Pharaoh's Daughters, a community serving orphans and vulnerable children.



## Mausami Momaya, BASW, MSW, LCSW

Mausami Momaya, BASW, MSW, LCSW, has tirelessly served children in need in the foster care community and in domestic/international adoption. She began her journey in child welfare on her summer vacations as a child when visiting orphanages in her native country of India. The children would all line up while Mausami placed assorted fruits in their hands. This simple gesture taught her the spirit of giving, and illuminated the discussion of children who are the same but have different circumstances. These direct actions placed a permanent seed in Mausami to see what she was able to accomplish. Mausami graduated with high academic honors in her undergraduate and graduate school education. She completed internships with the LA DCFS in domestic adoption and foster care, as well as serving the Native American Community. Post-graduation, she began her working career as a Domestic Adoption & Foster Care Social Worker. In 2000, Mausami joined the family business her mother started, Bal Jagat -Children's World Inc agency. Mausami traveled to orphanages in Vietnam, Thailand, Moldova, Romania, China, and India opening programs. As the Director of Social Services, she supervises social workers while being a social worker herself. There have been countless humanitarian projects spearheaded by Mausami including hiring more caregivers to provide additional nurturance at orphanages and opening a home for physically disabled children to receive physical and occupational therapies. Mausami acquired various foreign countries' licensures and completed the agency's Hague accreditation paperwork in 2008, 2012, 2016, and 2020. Mausami's pursuit to unite orphaned children with loving adoptive parents here in the US is active and in full force. She has helped an estimated 5,000+ orphan children to have loving families over the last 27 years.

## **Christopher Baker-Scott**

After entering foster care at age eight, Christopher became all too familiar with the hardships that youth in the child welfare system face. He wanted to lessen these hardships for other foster and adopted youth. He first recognized the power of education as the "great" equalizer" as a recently aged-out youth at Tunxis Community College. Today, as a recent Harvard graduate, he remembers this lesson as clearly as ever. Christopher founded Sun Scholars Inc. in order to remove some of the barriers to entry that former foster and adopted youth face during post-secondary education. Sun Scholars Inc. began as a small program operating out of a single university and, since receiving funding from the Connecticut Department of Children and Families, has grown to serve students around the entire state. Christopher has raised \$1.2 million to fund Sun Scholars mission, grown the organization's staff to 7+ professionals who all have lived experience in foster care, and have helped hundreds of young adults in the foster care system with direct service. He goes beyond academic support to help his students tackle issues such as housing and food insecurity, and his organization has a proven track record of increased enrollment and retention. Christopher and his organization are committed to improving educational equity and college graduation rates by using a student-first mentality. Through all of his work and advocacy, Christopher is breaking down the hardships faced by those going through the child welfare system. Christopher is also a 2019 Foster Youth Intern Program alumni, was recognized as one of Connecticut Magazine's "40 under 40" in 2022, and holds a Governor's Appointment on the Department of Children and Families State Advisory Council. Christopher now resides in Manchester with his wife, foster daughter, and pets Puchakaya (rabbit) and Fig Newton (cat).

### **Loraine Ireland**

Summer also provides group services in schools, offices, and even homes.

Angela and Summer have worked together to share their vision of providing evidence-based quality services to all families in their community and have worked diligently to ensure that all have access to services. They have partnered with local churches, community health centers, schools, and businesses in an effort to reach more children and families. They have also been successful in asking the local community to sponsor a child in need of services. Hope 1312 Collective also launched a therapeutic summer camp, Royal Family kids Camp, for children aged 6-12 who are in foster care. The relationships made during camp are carried on all year through mentorship programs and other touch points. The goal is to create long lasting relationships that teach children their value and worth. In addition to these programs, Hope 1312 Collective actively encourages DFCS workers to continue to protect the children in their community. They also support foster and kinship families through Care Communities and they even support birth families with simple things like meals.

Shelly Ballard has practiced adoption law since 1988, shortly after becoming a parent by adoption herself. She has handled hundreds of adoptions of every category as both a solo practitioner and as a partner in a small law firm. In addition to representing clients in adoption matters, Shelley has been actively involved in legislative efforts to improve adoption since the early 1990s. She has helped draft and lobby for many pieces of legislation affecting adoption in Illinois: including the "Baby Richard Law" enacted in 1994 that created the Illinois Putative Father Registry and the addition of several safeguards to the Illinois Adoption Act to reduce contested adoptions. She was recognized by the Illinois House of Representatives in a formal House resolution for this effort. Shelley authored the Illinois Bar Journal's lead article in its December 1994 issue, entitled The Baby Richard Law: Changes to the Adoption Act, an article that was instrumental in upholding the constitutionality of the law when it was challenged in the courts. In addition, she contributed the chapter on adoption for the ISBA Family Law Handbook, published by the Illinois State Bar Association and has for many years written the chapters on Interstate and Adult Adoption for the Illinois Adoption Law Practice Handbook, published by the Illinois Institute for Continuing Legal Education. Shelley also regularly addresses adoptive parent groups and legal professionals on various legal issues affecting adoption.

Shelley relocated to North Carolina in 1998 and operated a solo practice focused on adoption and reproductive technology law until 2002, when she returned to Chicago. While in North Carolina, Shelley was involved in the successful 2001 legislative effort to revise North Carolina adoption law to shorten the revocation period for adoption consents, allow openness in agency adoptions and permit advertising by approved adoptive families searching for a child to adopt. She also taught an introductory adoption seminar for Central Piedmont Community College and authored several adoption articles that appeared in the Charlotte Parent, Carolina Parent, and Carolina Youth Alliance magazines.

Shelley graduated magna cum laude from Vanderbilt University School of Engineering in 1979, and cum laude from Northwestern University School of Law in 1987, where she was elected to the Order of the Coif (top 10% of her class). Since 1990, she has been a Fellow of the Academy of Adoption and Assisted Reproduction Attorneys (formerly the American Academy of Adoption Attorneys), a national organization of attorneys devoted to the ethical and competent representation of parties in adoption and collaborative reproduction matters.





Karen and Larry's foster care story began in 1990 with leading youth ministry at Mt. Moriah Baptist Church. They quickly built relationships with local children, especially youth from rough homes. The Elliotts committed themselves to helping uprooted children feel grounded and safe.

Since 2014, Karen and Larry have fostered 17 children. They work to fulfill each child's permanency goal, and consistently accept older children who are harder to place, especially in rural areas like LaRue. In 2019, the Elliotts adopted Jaylen (13), who grew up in a home with domestic violence, drug abuse, and a step-dad who forced and taught him to steal. Today, Jaylen takes pride working on the Elliotts' hay farm. Like other youth the Elliotts have fostered, he finds peace and purpose working the natural land. The Elliotts teach children practical skills, like how to build a wagon, to help them build a sense of accomplishment, confidence, and control within their environment.

LaRue would not be the same without the Elliotts. Rural areas often see a gap in mental health and social services and a lack of foster homes. Because of the Elliotts, LaRue children can stay in-county for school and close to their friends. Karen and Larry take time to develop relationships with children's biological families, linking arms to create a greater sense of support for each child. Karen and Larry are a significant part of children's web of support, even after the children leave foster care. This critical continuity in their lives prevents attachment trauma and protects their sense of belonging. Simply, the Elliotts help children flourish while strengthening their family and community roots.

The Elliotts currently care for one adoptive son and three foster children.

### **Stephanie Perlow**

With a change in perspective and approach to building relationships, their work challenges foster care alumni, parents, and advocates to be aware and intentional about redefining the "normal" and how each person is a puzzle piece to the growth of their community. They highlight the components of that relationship as well as the aspect of the community that needs to be formed in a healthy and loving environment.

To do this, Together for Good volunteers can provide support in several ways: temporary hosting of children to give parents a safe option during crisis (crisis hosting), care for children once a week or once a month (respite care), supporting mothers via hospitality meals, parenting classes, and more (relational support), or becoming part of a wrap-around team which offers supplies and resources to families. Together for Good helps communities in Minnesota, lowa, and Texas. In 2021, 576 individuals hosted vulnerable children and families, 155 total children were supported, and there were 81 total church partners. At its core, Together for Good is building relationships with the church and vulnerable families to keep children with their family and out of foster care.

In addition to assisting foster families, the organization has expanded its services to aid the Mississippi Department of Child Protective Services with reunification and prevention cases and recently began partnering with the local school districts to assist students in need. 

After earning her MSW degree in 1981, she worked for one of New York City's voluntary foster care/adoption agencies. Her clients were children who were considered "hard-to-place" due to their age, racial background or special needs. During her tenure with this and other agencies, she helped many children find loving, adoptive families, including older children, sibling groups and children with special needs ranging from emotional and behavioral difficulties to Down Syndrome and HIV.

In 1988, she started Adoption Options, a private practice facilitating the adoption process by networking with a wide range of adoption professionals, including domestic and international adoption agencies, adoption attorneys, social workers and adoptive parent support groups in the New York Metropolitan area. She regularly conducted home studies, post-placement services and counseling for families who adopted children from all across the United States and around the world. Over the years, Lori developed a sub-specialty working with non-traditional adoptive families (single parents, gay and lesbian, step-parent adoptions). She frequently attends and has been a featured speaker at many area adoption conferences.

The non-profit also provides mentorship, educational, and emotional support to youth aging out foster care. In 2017, Liz was honored as a Presidential Leadership Scholar for her work.

Carla Riccobono, LSW, is the Senior Director of New Alternatives for Children's (NAC) Foster Care and Adoption Program. Ms. Riccobono has worked for NAC since 2001 and has been in her director role for six years. Her program serves children who have been removed from their parent's care and have a significant medical diagnosis, developmental disability and/or a psychiatric diagnosis. Truly the most vulnerable children, within the already vulnerable population of youth in foster care. Ms. Riccobono and her team work tirelessly to stabilize the children and place them in the care of a certified resource parent or kinship resource. The work immediately starts to mitigate the concerns that brought the child into care and to safely return them to their parent's care, and if that's not possible, they look to discharge the child to an open adoption or guardianship with their foster parent. This is all done with an understanding that entering foster care and being removed from your family is traumatizing for all parties.

Ms. Riccobono's team achieved 350% of their KINGAP goal, far exceeding NYC's expectations for children leaving foster care through guardianship to a kinship resource. NYC has recently acknowledged NAC's foster care program's excellence by increasing their contract by 50%. Additionally, the COVID pandemic has not slowed the program's ability to maintain safety, connect families and to work toward permanency. Under Ms. Riccobono's management, her team of social workers continued to make home visits and monitor family visits, even at personal risk to their own health. NYC's foster care population and specifically NAC's clients are far better off due to Ms. Riccobono's incisive and compassionate leadership and vision.

## **Victory Christian Church**

Going through the foster care system, creates memories both positive and negative. Pastor "Charlie", Victory Christian Church in Albany, NY is a product of the foster care system and has not forgotten his young experiences, needs and hopes. Over the past three years his church has opened "Our Store" in Albany to supply without cost clothes, shoes and merchandise to foster families.

Pastor Charlie comments that, "Often kids in the foster system get "hand-me-down" clothes or simply get by with very few possessions of their own. I feel that really affects them in a negative way.

"In July 2021, his church cut a ribbon to open the mini-department store, Our Store", offering brand new items for free to foster care families in need. The store has shoes, clothes, bedding and luggage for children moving from one home to another, many times with only a garbage bag to carry all their possessions. With donations from the community, the Pastor states, "we want to change their negative reactions to used clothes and to make sure that foster care kids feel important.

Our Store operates in the Westgate Shopping Plaza for three years. This Christmas they served any child or teen in the foster system with name brand sneakers, jackets, luggage, and personal items. During the holiday season, 52 foster families that needed help were severed by the store. In addition, store volunteers prepared gift bags for foster children in group homes.

Victory Christian Church is a multi-site, non-denominational church, operating for 20 years, to serve the community, the less fortunate and widows and orphans.



## **Congregations for Kids**

Congregations for Kids (CFK) equips and empowers the Charlotte community to be champions for children, families and social workers in the foster care system through four pathways; Foster, Mentor, Serve and Give. Aside from recruiting and training foster parents, CFK also hosts a mentorship program, serves aged out youth and meets tangible needs. CFK also launched a program that has made a markable difference in social worker retention. In 2018, Mecklenburg County DSS met with CFK to talk about their biggest challenges. At the top of the list was social worker turnover. Shortly after, CFK launched the 'Socialight' Program that asks community members to be a 'light' to a child welfare social worker. The program allows community members to sign up to be 'Socialights' and asks social workers to enroll to gain encouragement in the front line work they perform daily. The social worker is asked a few questions and then paired with a 'Socialight'. CFK then supports the relationship and provides the 'Socialight' with creative ways in which they can encourage their social worker. CFK has seen some incredible relationships form from this program but even more impressive, the turnover rate in North Carolina's largest county went from 69% in 2018, to 27% in 2019, to 19% in 2020. This is incredibly important because foster children with one social worker achieves permanency, on average, 74.5% of the time and only 17.5% of the time when there is social worker turnover (National Center on Crime and Delinguency). Ultimately the 'Socialight' program has the probability of helping children in foster care achieve permanency more often. CFK is excited to share this program (at no cost) to other organizations throughout the country to help them achieve the same type of success when it comes to the high rate of social worker turnover.

In the late 90s, Christina also stepped forward as a foster parent to "Meg". Christina maintained contact Meg in the years following reunification with her her biological family. When she became a young mother, Meg found herself at risk of losing her son to foster care. Christina stepped up informally to provide extensive respite, support and mentoring to Meg and her partner. They remained united and are thriving.

Christina also helped bring Every Child Oregon to Benton County to meet immediate needs of children in care, resource families, child welfare workers and biological families. Her devotion of countless hours and personal resources helped this organization flourish in our community. Christina's 2021 novel, "The Way It Should Be" won critical acclaim for its exploration of foster care, adoption, addiction and the complicated relationships that result. It inspires conversations about the challenging and emotionally complex issues in child welfare.

Through her personal life, Christina does volunteer work and writing; she's made it her mission to highlight kids' need to know their biological parents love them and have value, even in the moments they struggled most.

Even more impressive, Marcía herself experienced the foster care system as a young person in Philadelphia and beat the statistics to attain not only her Bachelor's but her Master's in Social Work. She is extraordinary not only because of the work that she does but HOW she does the work: with unending love, thoughtfulness, and authenticity. The ripples that come from the work that she has done are infinite.

The Attic Foster Network works to support foster families by providing tangible needs and a community of like-minded people while engaging the church. Their mission is to empower churches and their people to engage in the prevention, intervention, and emancipation of the local orphan. Their vision is to eliminate the orphan crisis in Midland, Odessa, and the surrounding area. The current issue of fostering in the Permian Basin is overwhelming, as nearly 90 percent of kids who are fostered have to move away from their hometown, and around 60 percent of those kids move more than 100 miles away. These boys have two other brothers who were adopted by another local family, and Rachel works diligently to maintain those critical sibling relationships. Rachel also builds strong bonds with the biological families of the children in her care, and continues to support those families who have been reunified. Rachel works alongside advocacy groups such as the South Texas Alliance for Orphans, the Blue Ribbon Task Force, and the Bexar County Children's Welfare Board to raise awareness and bring about systemic change.





Ashley writes curriculum for effective and life-changing birth mom support groups nationwide and advocates for openness, honesty, and education within adoption. Her program, Knee to Knee, under the Lifetime Healing Foundation, trains licensed adoption agencies and law firms in eleven states to provide effective postplacement support for birth parents who have placed a child for adoption. Ashley is also the owner of Big Tough Girl, an advocacy platform focused on the power of sharing stories, educating others on the issues, and providing resources so that women can feel empowered and successful in their journey. She is the co-host of the Twisted Sisterhood Podcast, a support podcast for birth mothers in their post-placement life. Ashley Mitchell's main message, "adoption is for life," is crucial for both adoptive and birth families to know and understand, in order to better serve their children and give them not only permanency, but a loving and thriving environment.



Dr. Susan Branco, she/her/ella, is a licensed professional counselor and a transracial and transnational adoptee from Colombia, South America. She is a long-standing advocate for increased adoption-related research and training within counselor education and is passionate about improving mental health outcomes for transracially adopted persons. For over 14 years she maintained an independent practice collaborating with adoptee children, adolescents, families, and birth parents. She applies her lived, clinical, and research experience to increase awareness about adoption counseling practice in a variety of ways. In 2015, Dr. Branco graduated from Virginia Tech with a doctorate in counselor education and supervision. During her doctoral studies until present day, Dr. Branco has published extensively in peer reviewed journals and book chapters on the topic of adoption, adoption counseling, and transracial adoption. Her work has been cited over 100 times by other scholars and the Netherlands' government in their 2021 report on international adoption practices. She has presented over 100 workshops, lectures, and trainings on the topic of adoption related counseling practices to high school, undergraduate and graduate students, teachers, families, mental health practitioners, adoption professionals, and her fellow adoptee community. Dr. Branco's advocacy work illuminates the need for culturally responsive and adoption fluent mental health services for adoptees and their families. Currently, she is a practicing counselor, serves as a tenure track Assistant Professor in the Counselor Education program at St. Bonaventure University, and is an instructor with the Post Adoption Certificate program at Rutgers University. In addition, Dr. Branco is a steering member of the Society for Adoptee Professionals of Color in Adoption. She is a mentor, dissertation and thesis advisor to other adoptees researching adoption related topics. Her recent research on Colombian adoptee international search and reunion is featured on a genealogy service, Myheritage, in their biweekly podcast.

### **McLane Layton**

J. McLane Layton, Founder and President of Equality for Adoption Children, knew as a young adult she would be an adoptive parent. As she was going through the adoption process, she discovered that her children would not be automatic U.S. citizens even though both she and her husband were U.S. citizens. It was then she began her quest for equal citizenship rights for internationally adopted children. She knew change in the law was needed so foreign adopted children of American citizens would be granted automatic U.S. citizenship.



As Legislative Counsel to U.S. Senator Don Nickles, McLane was instrumental in drafting legislation for several initiatives that are important for adoptive children and families, including the Child Citizenship Act, which became law in 2000. McLane has advocated for many families facing obstacles in the adoption process. She has been successful in expediting the sometimes very lengthy process of uniting adopted children with their families in the United States. Among her many acts of service, she obtained Humanitarian Parole for a Kosovo refugee who was adopted by an American military family in Germany and helped draft a private relief bill to provide her citizenship status. She helped two American families complete their adoptions after Romania shut down adoptions of Romanian children to Americans; worked with Citizens and Immigration Services and families adopting HIV positive children to dramatically reduce the waiting time for receiving a waiver for their children to enter the U.S.; and she traveled with the Congressional Coalition on Adoption Institute to China, Romania and Russia to promote adoption and ethical adoption practices. Additionally, McLane served as a longtime member of the CCAl Advisory Council.


