KERRY MARKS HASENBALG | 2023 Founding and Former Executive Director of CCAI

Kerry Marks Hasenbalg began her work on Capitol Hill as the fellow for the Congressional Coalition on Adoption (CCA). In 2001, together with the four congressional co-chairs of the CCA, Kerry created the Congressional Coalition on Adoption Institute (CCAI). As the organization's founding executive director, she worked closely with congressional members on child welfare issues in the U.S. and abroad. Under her leadership, both the Congressional Angels in Adoption awards program and the Congressional Foster Youth Internship program were created. Kerry has visited more than 40 countries, often meeting with both high-ranking government officials and the poorest of the poor to advocate for improved child welfare policies and practices. Prior to her work in DC, she spent three years working in Russia as an interpreter for Christian mission groups and later with adoption organizations. Over the years, Kerry and her husband, Scott, have been known to work in tandem for children's causes. In their joint efforts, they have been instrumental in the creation of several charitable organizations, including Christian Alliance for Orphans, where Scott served as a founding board member; North Branch Young Life, where Scott and Kerry serve as committee members; Calvary Chapel DC Metro; Orphan Institute; Show Hope, where Scott served as the Executive Director for 12 years under the board leadership of its founders, Steven Curtis and Mary Beth Chapman; and CCAI. In recent years, Kerry has led dozens of private formation retreats for leaders and lay people from the US and abroad. She and Scott live together in Danville, Pennsylvania, with their four children, Cole, Maya, Leah, and Annika, whom she homeschools.

THE HONORABLE MARY LANDRIEU | 2023

Former U.S. Senator of Louisiana, Senior Policy Advisor, Van Ness Feldman LLP


Senator Mary Landrieu served in the United States Senate for three terms, first elected in 1996. As a member and later Chair of the Senate Energy and Natural Resources Committee, she passed significant legislation, including the Gulf of Mexico Energy Security Act (GOMESA), the Israel American Energy Alliance, and the RESTORE Act, the largest federal investment in the Gulf Coast in U.S. history. Landrieu also served on the Senate Armed Services Committee and the Appropriations Committee and chaired the Small Business and Entrepreneurship Committee. As Chair, she was the lead sponsor of the Small Business Jobs Act of 2010, creating and retaining over 650,000 American jobs. Known for her bipartisan approach, Landrieu was a passionate advocate for Louisiana, especially after Hurricanes Katrina and Rita. Before her Senate career, she served in the Louisiana State Legislature from 1979 to 1987, championing causes related to women and children, flood protection, and education reform. Elected as State Treasurer in 1987, she implemented strong fiscal management, pension fund diversification, and created the first-ever municipal investment fund, now valued at over \$2 billion. Senator Landrieu serves on the Board of Directors of CenturyLink, the second-largest U.S. communications provider to global enterprise customers. In the non-profit sector, she is on the boards of the National Alliance for Public Charter Schools, Resources for the Future, and the Congressional Coalition on Adoption Institute, representing over 145 Members of Congress working to remove barriers for vulnerable children and families. A graduate of Louisiana State University, Landrieu is married to Frank Snellings, an attorney and real estate broker in Washington, DC. They have two grown children and one grandchild.



Little did she know that the powerful arms and hands she began to develop as a small child would someday carry her around the globe as one of the world's greatest athletes.





Nationally-Recognized Child Welfare Consultant





EXTREME MAKEOVER: HOME EDITION | 2010 American Reality Television Series





INVISIBLE CHULDREN | 2006 Peace-Building Organization



His journey to uncover his roots and embrace his identity was featured on VH1 in October 2005, where he also collaborated with Sarah McLachlan on a rendition of "Cats in the Cradle," resonating with adopted children everywhere. Beyond personal discovery, McDaniels co-founded Camp Felix in 2006 with casting director Sheila Jaffe, dedicated to nurturing children without parental support. Camp Felix aims to empower neglected youth with new opportunities, fostering their growth into resilient, successful adults. McDaniels' advocacy transcends self-promotion, striving to instill hope and support for all children in need. His life's work reflects a commitment to empower and uplift those facing similar challenges.

JARS OF CLAY | 2005 Christian Alternative Rock Band

with the hit "Flood" in 1995. Since then, they have achieved over five million in career sales, 17 number one radio hits, an American Music Award nomination, and BMI honors for songwriting and performing. Jars of Clay is also renowned for their humanitarian efforts, described as "humanitarian aid workers posing as rock stars." Their global advocacy includes work in China with Amnesty International and child abuse prevention in the U.S. In response to the HIV/AIDS pandemic, band members Dan Haseltine, Stephen Mason, Matt Odmark, and Charlie Lowell founded the Blood Mission in 2002, providing clean blood and water solutions in sub-Saharan Africa. They are dedicated to raising awareness about the needs of HIV/AIDS-affected families, including orphans and vulnerable children. On tour, they engage with college students, youth pastors, and community leaders on social justice, vocation, and service. Born in Portland, Maine, Victoria Rowell was raised in foster care for 18 years. Emmy-nominated, Rowell has been honored with ten NAACP Image Awards for her theatrical contributions. On the hit series Diagnosis Murder, she co-starred with Dick Van Dyke for eight seasons and wrote for the series, featuring issues of foster care and adoption. Sony Television has supported a foster care and adoption storyline, at Rowell's suggestion, on The Young and the Restless, which has received Congressional recognition. In 1990, Rowell founded The Rowell Foster Children's Positive Plan (RFCPP), offering services in fine arts, higher education, and healthcare. Rowell has been the National Spokesperson for the Annie E. Casey Foundation for four years and received the United Nations Association Award and an Honorary Doctorate in Humanities from the University of Southern Maine for her contributions to foster care and adoption.



SESAME WORKSHOP | 2005 American Educational Children's Television Series

Sesame Street is the most widely watched children's television series in the world and Sesame Workshop's longest-running show, with over 50 years in production. Debuting in 1969, Sesame Street was designed to help children aged two to five prepare for grade school. It stands out as the most thoroughly developed and researched preschool television program, focusing on cognitive, emotional, physical, and social development. Sesame Workshop, a nonprofit organization founded in 1968, creates research-based media to help children worldwide reach their highest potential. This includes television, radio, books, magazines, interactive web and computer software materials, and community outreach. Sesame Workshop has addressed issues like fear and loss following September 11, childhood obesity, lead poisoning, fire safety, language development, music education, financial literacy, and adoption. The Workshop has developed local adaptations of Sesame Street in 25 countries, including Russia, Israel, Palestine, Jordan, China, Spain, South Africa, Bangladesh, and Afghanistan.





LAURA BUSH | 2005

Former First Lady of the United States

Laura Bush was born on November 4, 1946, in Midland, Texas, and earned a bachelor of science degree in education from Southern Methodist University in 1968, followed by a master of library science degree from the University of Texas in 1973. Actively engaged in national and global issues, Mrs. Bush focuses on education, healthcare, and human rights. She annually promotes adoption during National Adoption Day ceremonies, emphasizing its transformative impact on children's lives. From their experience adopting two children, the Tripletts understand the financial burden that can prevent loving people from adopting. Therefore, they began a foundation to meet the financial needs of those desiring to adopt. Kirk and Cathi started Tour Fore Adoption in Scottsdale, AZ to provide grants to families who wish to adopt domestically but struggle with financial resources. Kirk and Cathi also support Chicks in Crisis, an organization that cares for pregnant women who are scared and unprepared for their pregnancy.



JANE SEYMOUR | 2004

Award-Winning British Actress

Jane Seymour, Emmy and Golden Globe Award-winning actress, devoted mother, and respected child advocate, has held numerous positions as a celebrity spokesperson, including ambassador for the United Nations Children's Fund (UNICEF) and a member of the American Red Cross celebrity cabinet. 

Alongside First Lady Laura Bush, Bruce launched the AdoptUsKids website, highlighting children available for adoption. To promote foster care adoption, he created public service announcements featuring stars like Jamie Foxx and the Charlie's Angels cast. Additionally, he donated a state-of-the-art recording studio to The Hip Hop Project at Art-Start, empowering at-risk urban youth. Bruce organized the Los Angeles premiere of "Rugrats Go Wild" to benefit foster care programs. In June, he traveled to Washington, D.C., for a press conference urging Congress to improve foster care. He also participated in National Adoption Day, finalizing over 1,400 adoptions of foster children.

DAVE THOMAS | 2001

American Businessman, Philanthropist, Fast-Food Tycoon

As an adoptee himself, Dave was a tremendous advocate for adoption and a hero to thousands of waiting children in the U.S. foster care system. In Dave's words, "Every child deserves a permanent home and loving family." In 1992, he established the Dave Thomas Foundation for Adoption, which supported programs to make adoption easier and more affordable. Dave promoted adoption benefits for corporate and government employees, simplified the adoption process, and advocated for adoption tax credits for all adoptive parents. He spread his message nationwide, meeting with Members of Congress, corporate America, and the media. Dave and the foundation were instrumental in creating the U.S. postage stamp promoting adoption and the annual CBS television special "A Home for the Holidays." Both efforts raised adoption awareness across America and prompted thousands to inquire about waiting children. Dave's family, friends, and the foundation continue his work to ensure every child finds a forever family. Dave sadly passed in 2002.



Johannes ("Hans") H.A. van Loon was the Secretary General of the Hague Conference on Private International Law from 1996 until 2013. The Hague Conference, an intergovernmental organization based in the Netherlands, comprises 54 member states, including the United States. During his tenure, van Loon was instrumental in initiating the work that led to the Hague Convention on Protection of Children and Co-operation in Respect of Intercountry Adoption, signed in 1993. His efforts included persuading member and non-member states of the necessity and feasibility of a worldwide treaty on inter-country adoption. After the treaty's signing, he remained actively involved in its promotion and implementation, maintaining high-level contacts with governments and various organizations. Additionally, van Loon contributed to the development of other multilateral treaties and published extensively on private international law issues.







MARY BETH & STEVEN CURTIS CHAPMAN 2001

Co-founder and Chairman of the Board of Show Hope | American Singer and Songwriter

Steven Curtis Chapman, a four-time Grammy award winner, sold over seven million albums, had thirty-seven number one singles, and received numerous Dove awards (Christian music's Grammy awards). Steven and his wife, Mary Beth, are both advocates for children in need. They have three biological children: Caleb, Will Franklin, and Emily. In March 2000, they adopted their daughter, Shaohannah, from China, which profoundly changed their lives. Inspired by their experience, they encouraged friends and family to consider adoption. In 2001, they returned to China to support friends and family in adopting children. Together, Steven and Mary Beth founded Shaohannah's Hope, a foundation to assist families with adoption costs. According to Steven, "Shaohannah's Hope is a fund to help aid families who want to adopt and have a place at their table and a place in their heart, but don't have a place in the bank account for it." Steven's album, "Declaration," includes a song dedicated to Shaohannah, entitled "When Love Takes You In."



ROSIE O'DONNELL | 2001

American Comedian and Television Producer

Rosie O'Donnell gained fame as the host and executive producer of the critically acclaimed "The Rosie O'Donnell Show," a nationally syndicated talk and variety series. Known for her diverse roles in film and theater, Rosie is also a prominent advocate for children. Her commitment to child welfare is exemplified by her creation of The For All Kids Foundation, which supports children's charities nationwide. In addition, Rosie used her platform to educate the public about adoption with her special "How to Adopt" show, sharing her personal adoption journey. She first became a mother in 1995 when she adopted her son, Parker, followed by her daughter, Chelsea, and son, Blake, in subsequent years. Rosie's advocacy has highlighted adoption as a viable and loving choice for building a family and has shone a light on the important role of birth mothers. Through her efforts, she has positively impacted all members of the adoption triad: birth parents, adoptive parents, and children.

Gail and Larry Cole have dedicated their lives to caring for children in need. They have four children, including two biological and two adopted. Their commitment to adoption was profoundly demonstrated when they chose to leave behind their homes and careers in Michigan after facing racial discrimination in their adoption process. They sought a new environment where their children, Lynette and Sean, could find a permanent home free from such barriers. Their story of resilience and love has had a lasting impact. Her efforts led to the adoption of hundreds of thousands of international children and reshaped perceptions of what constitutes an "unadoptable" child. Bertha Holt founded the organization that bears her name, dedicated to finding families for children in need. Her legacy is reflected in the countless lives she touched, including many disabled and orphaned children who experienced the power of love and family. Her impact is remembered fondly, with many considering her a beloved "Grandma" for her nurturing spirit and dedication to family. Her contributions continue to inspire the global adoption community. Holt sadly passed in 2000.



THE HONORABLE TOM BLILEY | 2000

Former United States Representative

U.S. Representative Tom Bliley, known for his influential roles in Congress and as Chairman, values his role as a father above all. Together with his wife, he adopted two children, a deeply personal experience that reshaped their lives. Understanding that adoption benefits both the child and the parent, Rep. Bliley has passionately advocated for adoption-related policies. He played a key role in founding the Congressional Coalition on Adoption in 1985, alongside U.S. Rep. James Oberstar and former Senators Gordon Humphrey and Lloyd Bentsen. Throughout his tenure, Rep. Bliley championed numerous initiatives to increase adoption awareness, including tax credits for adoption, family leave, and the establishment of the National Adoption Information Center. His efforts also extended to foster care incentives and support for orphans and displaced children. Rep. Bliley's leadership and dedication have left a lasting impact on the adoption community. Bliley sadly passed in 2023.
