Effective May 1, 2019

For submissions to NGC International UK Ltd. (NGC UK) only.

Comics, magazines and CGC Signature Series items must be submitted on separate submission forms.

All fees are in pounds and include VAT.

Fees include round trip shipping and insurance between NGC UK and CGC Headquarters.

A £12 handling fee per submission form applies to all submissions.

CGC Signature Series	Tier fee + £10	The CGC Signature Series label (yellow) is applied to comic books that have been signed by someone of significance to the comic. Though in select instances CGC may accept signed books directly from the signer/publisher, generally these labels will only be issued to books signed under the direct observation of a CGC representative. Contact NGC UK to confirm eligibility prior to handling a book signed per CGC Signature Series. Applies to all collectibles on the form.
ReHolder	£20	CGC-certified collectibles are encapsulated in a new holder. Select ReHolder for collectibles valued up to £50,000.
High Value ReHolder	£30	CGC-certified collectibles are encapsulated in a new holder. Select High Value ReHolder for collectibles over £50,000.
Internet Imaging	£4	If chosen, CGC provides digital imaging of the cover of items submitted under any of its grading and service tiers for £4 per item. Consists of accurate, high-resolution images (sent by email) of the front and back of the collectible, shown encapsulated in its CGC holder. Applies to all collectibles on the form.
