

# NGC CONSERVATION UK SERVICES & FEES

Effective January 29, 2026

For submissions to Certified Collectibles Group—International UK Limited (CCG UK) only.

US, world and ancient coins must be submitted on separate submission forms.

All fees are in pounds and are listed with and without VAT.

Fees include round trip shipping and insurance between the CCG UK and NGC Headquarters.

A £11 (£13.20 VAT included) handling fee per submission form applies to all submissions.



NGC is the official conservation service of the ANA and PNG.

Modern Conservation	£10	£12	All <b>uncertified</b> US or world coins struck 1965 to present (except patterns, die trials, etc.), or <b>uncertified</b> US or world tokens and medals struck 1990 to present, both private and official, except coins, tokens and medals that require an NGC Oversize Holder (over 45 mm). Maximum value £2,000 per coin. Fee includes conservation only. Also select an applicable NGC grading tier. NGC grading fees additional. If NGC believes that conservation will not benefit a coin submitted under the Modern Conservation tier, it will be transferred to grading and the conservation fees will be refunded less a £4 per coin evaluation fee.
Gold Conservation	£21	£25.20	All <b>uncertified</b> gold coins, both vintage and modern, except ancient coins and coins requiring an NGC Oversize Holder (over 45 mm). Maximum value £4,000 per coin. Fee includes conservation only. Also select an applicable NGC grading tier. NGC grading fees additional. If NGC believes that conservation will not benefit a coin submitted under the Gold Conservation tier, it will be transferred to grading and the conservation fees will be refunded less a £4 per coin evaluation fee.
Standard Conservation	3.5% Fair Market Value (FMV) (£17 minimum fee)*	4.2% Fair Market Value (FMV) (£20.40 minimum fee)*	All coins. 3.5% Fair Market Value (FMV) (£17 minimum fee excluding VAT). Also select an applicable NGC grading tier. NGC grading fees additional. If NGC believes that conservation will not benefit a coin submitted under the Standard Conservation tier, it will be transferred to grading and the conservation fees will be refunded less a £4 per coin evaluation fee.

\*Declared value MUST represent fair market value and NGC reserves the right to make adjustments for undervalued items.

\*NGC Oversize Holder fee of £21 (£25.20 VAT included) per coin applies to coins over 45 mm in diameter.
