For non-bulk submissions, the maximum number of coins per submission form is 50. Use multiple submission forms as needed.

For bulk submissions, the minimum number of coins per submission form is 100.

A \$10 handling fee per invoice applies to all submissions.

For each coin, a complete description including denomination, year (or date range), geographic location and ruler name should be provided, as applicable. A Spink number should be provided for coins of England, Ireland, Scotland and Continental imitations. An appropriate catalog number should be provided for patterns, tokens and medals. **If complete information is not provided, an attribution fee of \$5 per collectible will be applied to the entire submission form.**
