## PMG Grading Tiers & Services, Effective January 1, 2019

(Turnaround times are approximate and not guaranteed. Estimated turnaround begins on the day notes are received by PMG.)

A \$10 handling fee per invoice applies to all submissions.



PMG is the official grading service of the ANA and PNG.

**US Notes** An attribution fee of \$5 per catalog number is charged when notes submitted are not accompanied by proper catalog number (e.g. Friedberg, etc.).

Economy Special (US)	\$35	28 working days	Notes valued up to \$1,000. All errors, US BEP issued bonds, specimens, proofs, US essays and / or notes not listed in Friedberg, Haxby, Criswell or Schwan.
Modern (1960-Present)	\$20	28 working days	Notes valued up to \$300. All notes issued 1960 to present <b>except</b> error notes, US BEP-issued bonds, specimens, proofs, US essays and notes not listed in Friedberg, Haxby, Criswell or Schwan.
Bulk Submission		Varies	<b>Applies to all bulk submissions:</b> Notes valued up to \$300. <b>50-note minimum.</b> The following notes are <b>NOT</b> eligible for bulk submission tiers: error notes, US BEP-issued bonds, specimens, proofs, US essays and notes not listed in Friedberg, Haxby, Criswell or Schwan.
Consecutive Notes	\$12		<b>Consecutive Notes:</b> All notes must be the same catalog number and all serial numbers must be in consecutive order. All vintage or modern notes are accepted provided they meet the bulk requirements above.
Mixed Vintage (Pre-1960)	\$16		<b>Mixed Vintage:</b> Notes may be a mix of catalog numbers and / or serial numbers. All notes issued before 1960 are accepted provided they meet the bulk requirements above.
Mixed Modern (1960-Present)	\$14		<b>Mixed Modern:</b> Notes may be a mix of catalog numbers and / or serial numbers. All notes issued 1960 to present are accepted provided they meet the bulk requirements above.

**World Notes** An attribution fee of \$5 per catalog number is charged when notes submitted are not accompanied by a proper catalog number (e.g. Pick, etc.).

Modern (1960-Present)	\$20	28 working days	Notes valued up to \$300. All notes issued 1960 to present <b>except</b> error notes, specimens, proofs and/or notes not listed in Charlton or the <i>Standard Catalog of World Paper Money</i> .
Bulk Submission		Varies	<b>Applies to all bulk submissions:</b> Notes valued up to \$300. <b>50-note minimum.</b> The following notes are <b>NOT</b> eligible for bulk submission tiers: error notes, specimens, proofs, Chinese notes issued from 1948 through the 1953 First Series notes (Pick numbers 800 to 859) and notes not listed in Charlton or the <i>Standard Catalog of World Paper Money</i> .
Consecutive Notes	\$13		<b>Consecutive Notes:</b> All notes must be the same catalog number and all serial numbers must be in consecutive order. All vintage or modern notes are accepted provided they meet the bulk requirements above.
Mixed Vintage (Pre-1960)	\$20		<b>Mixed Vintage:</b> Notes may be a mix of catalog numbers and/or serial numbers. All notes issued before 1960 are accepted provided they meet the bulk requirements above.
Mixed Modern (1960-Present)	\$15		<b>Mixed Modern:</b> Notes may be a mix of catalog numbers and/or serial numbers. All notes issued 1960 to present are accepted provided they meet the bulk requirements above.

A \$10 adjustment fee will be charged for submission forms that must be modified prior to processing. This includes forms with more than one tier listed and bumps in tier levels due to undervalued notes.  
Note: Please limit notes to 50 per submission form. For bulk submissions, please limit notes to 100 per form. Use multiple submission forms as needed.

The following service options are available for both US and World note submissions.

Releases	Tier + \$10	According to tier	Select this service for any designation (e.g. Early Releases or First Releases).
Special Labels	Tier + \$5	According to tier	Select this service for any special label. Request desired label on the submission form.
PMG Oversize Holder	Tier + \$15	According to tier	Select this service for notes and / or sheets 195 x 120 mm to 205 x 220 mm in size. Must be submitted on a separate form.
Custom Holder		According to tier	Notes or sheets larger than 400 x 470 mm cannot be encapsulated by PMG.
Small	\$25		Select the \$25 Small Custom Holder tier for notes and / or sheets sized between 205 x 220 mm and 305 x 350 mm.
Large	\$50		Select the \$50 Large Custom Holder tier for notes and / or sheets sized between 305 x 350 mm and 400 x 470 mm.
ReGrade	Tier price	According to tier Ex: ReGrade Express is 5 working days	If you disagree with a grade assigned by PMG, you may submit the note for review for a higher grade. Note must be intact in its PMG holder. Also choose a grading tier according to note value and desired turnaround time.
Variety	Tier + \$8	According to tier	Additional attribution not mentioned in Friedberg, Haxby, Criswell, Schwan, Charlton & the <i>Standard Catalog of World Paper Money</i> , as well as all "f" fluorescence attributions for Chinese RMB notes.
Pedigree	Tier + \$5	According to tier	Reserved for information pertaining to a private or public collection. (Ex: Ford Collection) Submit copies of auction lots and plates, sales invoices or other backup of pedigree.

ReHolder	\$10	5 working days	A note in a PMG holder can be placed in a new holder. Notes valued up to \$10,000.
High Value ReHolder	\$25	5 working days	A note in a PMG holder can be placed in a new holder. Notes valued over \$10,000.
OTHER PMG SERVICES	FEE	ESTIMATED TURNAROUND	DESCRIPTION
Appearance Review	\$0 per note	12 working days	Review of a PMG note you believe is over graded.
Internet Imaging	\$5 per note	Tier + 1 working day	Digital imaging for notes submitted under any of PMG's grading and service tiers. Consists of accurate high-resolution images of the front and back of the note, shown encapsulated in its PMG holder. Applies to all notes on the form.
Return Packaging	\$5 per form	Tier + 1 working day	Examples include Certificates of Authenticity and folders / boxes.
