A € 15 handling fee per invoice applies to all submissions.

A € 10 adjustment fee will be charged for submission forms that must be modified prior to processing. This includes forms with more than one tier listed and bumps in tier levels due to undervalued notes. Choose only one tier per submission form. Catalog number (e.g. Pick, etc.) is required.
