

# PMG UK SERVICES & FEES

Effective January 29, 2026

For submissions to Certified Collectibles Group — International UK Limited (CCG UK) only.

US and world notes must be submitted on separate submission forms.

All fees are in pounds and are listed with and without VAT.

Fees include round trip shipping and insurance between the CCG UK office and PMG Headquarters.

A £11 (13.20 VAT included) handling fee per invoice applies to all submissions.



PMG is the official grading service of the ANA and PNG.

For current estimated turnaround times, visit [PMGnotes.uk/services](http://PMGnotes.uk/services). Turnaround times are estimates and are NOT guaranteed.

The Friedberg or Pick number should be referenced on the submission form when submitting notes listed in either of these references. An attribution fee of £4 (excluding VAT) per note is charged when notes submitted are not accompanied by a proper catalog number. All fees and maximum values in GBP.

A £10 (excluding VAT) adjustment fee will be charged for submission forms that must be modified prior to processing. This includes forms with more than one tier listed and bumps in tier levels due to undervalued notes. Choose only one tier per submission form.

Unless requested otherwise by the customer on the submission form, PMG will generally encapsulate notes in the smallest possible holder if doing so allows them to fit in one of PMG's standard holder sizes. For example, a vertically oriented note will be encapsulated in a horizontally oriented PMG standard holder if it will fit. Notes that require the PMG Oversize Holder or Custom Holder will generally be encapsulated according to the note's orientation.

Please limit non-bulk submissions to 50 notes per submission form. For bulk submissions, please limit to 100 notes per submission form. Use multiple submission forms as needed.

Bulk Submission			<b>Applies to all bulk submissions:</b> Notes valued up to £250. <b>Fifty (50)-note minimum.</b> The following notes are NOT eligible for bulk submission tiers: error notes and Chinese notes issued from 1948 through the 1953 First Series notes (Pick numbers 800 to 859). All serial numbers must be in consecutive order. Multiple catalog numbers are allowed, but there must be at least 25 notes per catalog number. All vintage or modern notes are accepted provided they meet the bulk requirements above.

PMG reserves the right to use a larger holder and charge the submitter the appropriate fees for notes that are close to the maximum dimensions of the requested holder type.
Custom Holder	Tier Fee + £45	Tier Fee + £54	Select the Custom Holder for notes and/or sheets sized between 205 mm wide x 220 mm high and 580 mm wide x 740 mm high. Must be submitted on a separate form. See PMG Services & Fees for current pricing.
Variety	Tier Fee + £8	Tier Fee + £9.60	Additional attribution not mentioned in Friedberg, Haxby, Criswell, Schwan, Charlton & the <i>Standard Catalog of World Paper Money</i> , as well as all "f" fluorescence attributions for Chinese RMB notes. The Variety fee applies when requested regardless of whether PMG determines the note to be a recognized variety.
Pedigree	Tier Fee + £4	Tier Fee + £4.80	A pedigree can be added to the certification label to indicate a note's past or present ownership. The Pedigree service must also be selected for all notes with a courtesy autograph. To pedigree a note to a previous owner, that collector or collection must be considered to be significant by PMG and sufficient documentation (including copies of auction lots and plates, sales invoices or other backup) must be provided to confirm the requested pedigree. You can also pedigree a note to yourself, typically without providing any documentation. To add a pedigree to notes already encapsulated by PMG, also select an applicable PMG ReHolder service. Print clearly on the submission form exactly how you want the pedigree to appear on the PMG label. All pedigrees are subject to PMG's approval. The Pedigree fee applies when requested regardless of whether PMG determines the note to have an eligible pedigree.
ReGrade	Tier Fee	Tier Fee	If you disagree with a grade previously assigned by PMG, you may submit the note for review for a higher grade. The note must be intact in its PMG holder. Choose a grading tier according to the note's value and the tier requirements. Notes are graded according to PMG's grading standards, and a higher grade is not guaranteed. Fees are not refunded if a higher grade is not received. A note submitted for ReGrade will be removed from its PMG holder by PMG staff and encapsulated with a new PMG holder, label and certification number, even if the grade does not change. All notes submitted under ReGrade are subject to the terms and conditions of the PMG Guarantee. In the unlikely event that the grade is determined to be lower through ReGrade, the ReGrade will be converted into an Appearance Review under the PMG Guarantee.
CrossOver	Tier Fee	Tier Fee	Review of a note helded by PCGS Currency, PCGS Gold Shield, PCGS Banknote Grading, PCGS CMC or PCGS Banknote (the "PCGS Brands") for PMG certification. A note will be removed from its holder only if PMG believes that the note will meet or exceed PMG's standards for the grade assigned by the PCGS Brand. If PMG does not believe that the note will meet PMG's standards, the note will be returned in its PCGS-branded holder and the grading fee will be refunded less a £9 (£10.80 VAT included) processing charge per note. If you would like the note in a PCGS-branded holder certified by PMG regardless of the PMG grade that it will receive, write CROSS AT ANY GRADE in bold letters on the PMG Submission Form.
