One of these forms must be prepared for each class at a licensed or member Beagle Field Trial. The Field Trial Secretary must list on the form the name and number of each hound for which advance measurement was requested when entry form was received. List all hounds measured for this class including any hounds measured out and transferred to another class.

When hounds are called for Second Series or for Winners Pack, the Field Trial Secretary must list the names and numbers of the hounds that have not been measured in advance, below are those of the hounds measured in advance.

The actual measurements shall be entered by one the judges or by a person designated by the judges. The Field Trial Secretary must submit these sheets to The American Kennel Club along with the results of the trial.
