AKC Government Relations 2025 Legislative Review - The First 6 Months

After a busy and dramatic election season, all 50 state legislatures, Congress and many cities and counties have already met in 2025 to deliberate on a broad variety of issues - and animals were once again a high priority.

The vast majority of state legislatures have either adjourned for the year or are on summer recess. To date, the American Kennel Club is tracking over 1,700 bills impacting dogs and dog owners across the country. This is an increase of approximately 300 bills over what AKC GR tracked at the same time in 2023 (the last time all 50 state legislatures were in session).




AKC Participates at American Legislative Exchange Council's Annual Meeting
