The tested model of Ford EcoSport was introduced in Australia and New Zealand in December 2013. This updated ANCAP safety rating applies to all variants built from October 2017 and on sale from December 2017 in Australia and May 2018 in New Zealand.

Dual frontal, side chest and side head-protecting airbags (curtains) and a driver knee airbag are standard. Autonomous emergency braking (AEB) and lane support systems (LSS) are not available. Occupant Protection.

Frontal Offset Test

Each body region is scored out of 4 points

Head / neck:	4.00 points
Chest:	3.43 points
Upper legs:	4.00 points
Lower legs:	3.71 points

In the frontal offset test, driver chest and leg protection was acceptable. Passenger protection was good for all critical body regions. All doors remained closed during the test. After the test, all doors could be opened with normal effort.

Side Impact Test

The vehicle was eligible for a side pole test because it has side curtain airbags. The vehicle scored the maximum 2 points for head protection in this test.

Pedestrian Test

Scored out of 36 points

Adult & child head impacts: 14.71 points
Upper leg impacts: 0.38 points
Lower leg impacts: 6.00 points

This vehicle scored 21.09 out of 36 points (Acceptable). The EcoSport scored maximum points for the protection provided by the bumper, with good performance in all areas tested. However, the front edge of the bonnet offered predominantly poor protection to the pelvis area. The protection provided by the bonnet surface was mostly good or adequate with poor results recorded along the base of the windscreen and on the stiff windscreen pillar. (v6)
