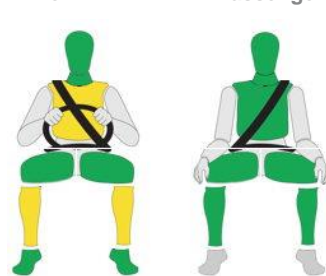

The tested model of Suzuki Vitara was introduced in Australia and New Zealand in mid-2015. This ANCAP safety rating applies to all variants including Turbo variants.

### Occupant Protection.

#### Frontal Offset Test

Each body region is scored out of 4 points

Head / neck:	4.00 points
Chest:	3.15 points
Upper legs:	4.00 points
Lower legs:	3.64 points

The passenger compartment held its shape well in the frontal offset test. Pedal and steering wheel displacements were well controlled. Driver and passenger contact with the airbags was stable. All doors remained closed during the crash. After the crash all doors could be opened with normal effort.

#### Side Impact Test

Each body region is scored out of 4 points

Head:	4.00 points
Chest:	4.00 points
Abdomen:	4.00 points
Pelvis:	4.00 points

Good protection was provided for the driver in the side impact test.

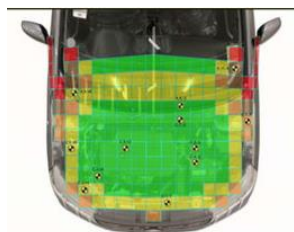
#### Pedestrian Test

Scored out of 36 points

Adult & child head impacts: 18.48 points  
 Upper leg impacts: 4.12 points  
 Lower leg impacts: 6.00 points

This vehicle scored 28.60 out of 36 points (Good). Most locations provided good protection for a struck pedestrian. Some locations at the base of the windscreen pillar and around the headlights performed poorly. (v8.3)
