

The BMW i3 was introduced in Australia and New Zealand in 2014.

Dual frontal, side chest and side head airbags (curtains) are standard. Antilock brakes (ABS), electronic brakeforce distribution (EBD), reversing collision avoidance, tyre pressure monitoring and electronic stability control (ESC) are also standard. Autonomous emergency braking (AEB) and lane support systems (LSS) are optional. Advanced seat belt reminders are fitted to both front seats. Rear seats do not have seat belt reminders.

Frontal Offset Test

Each body region is scored out of 4 points

Head / neck: 4.00 points
Chest: 2.99 points
Upper legs: 4.00 points
Lower legs: 2.58 points

The passenger compartment held its shape well in the frontal offset test. Driver leg protection was marginal. Pedal and steering wheel displacements were well controlled. Driver and passenger contact with the airbags was stable. All doors remained closed during the crash

Side Impact Test

Each body region is scored out of 4 points

Head: 4.00 points
Chest: 4.00 points
Abdomen: 4.00 points
Pelvis: 4.00 points

Good protection was provided for the driver in the side impact test. The side airbags performed well.

Pole Test

Scored out of 2 points

The vehicle was eligible for a side pole test because it has side curtain airbags. The vehicle scored the maximum 2 points for head protection in this test.


Pedestrian Protection.

Pedestrian Test

Scored out of 36 points

Adult & child head impacts: 14.82 points
Upper leg impacts: 0.00 points
Lower leg impacts: 6.00 points

The BMW i3 scored 20.82 out of 36 points (Acceptable). The bumper scored maximum points for its protection of pedestrians' legs, with good results in all areas tested. However, the front edge of the bonnet was poor and scored no points. The bonnet provided protection to the head that was predominantly adequate or marginal, with poor results recorded at the base of the windscreen and along the stiff windscreen pillars. (Tested by Euro NCAP v6)
