Message From the Director

In the fall of 2023, the CTE underwent an external review. The review process consisted of an extensive self-study and a two-day, on-Grounds visit by three well-respected reviewers with deep expertise in educational development, the structure and functions of teaching and learning centers, and the higher education landscape. During their visit, the reviewers interviewed UVA's senior leadership, dozens of CTE partners, stakeholders, and clients, and most members of the CTE team.

With external review, there is a tendency to look both back and forward. What is lost sometimes is an awareness and appreciation of the present. Through this lens, the here and now, it is noteworthy that the review committee described the CTE as “one of the premier educational development centers in the United States” and “an exemplary center for teaching and learning, one whose excellence is recognized and appreciated within UVA by individuals in varied areas and roles” and beyond. The committee also noted that “CTE staff are widely respected as experts and scholars in teaching and learning,” the center’s “programs and resources are... both practical and scholarly,” and the center is “consistently responsive to issues and crises related to teaching and learning.”



We greatly appreciate the review committee's glowing endorsement of our current work and are excited to imagine what is next. Guided by helpful suggestions from our external reviewers and our foresight into emerging national trends, we are energized to continue innovating our work in support of UVA's teaching mission. While some of this work will happen behind the scenes, like engaging with partners in collaborative strategic planning and developing a center-wide assessment plan, other work will be outward facing, like new programming focused on generative AI and new modes of delivery through our partnership with OneHE. You will have to wait until next year to learn more about these endeavors. For now, we invite you to explore the highlights of our work from this past year.

Support HHMI IE3 and Driving Change Initiatives

We partnered with various units to support ongoing work and new initiatives in connection with UVA’s HHMI IE3 and Driving Change grants.



- Worked closely with associate provost for undergraduate education to plan and facilitate interactions with Faculty Leads, including developing and facilitating retreats for leadership team, recruiting STEM faculty in five IE3 “Community Conversation” events, and recruiting external speakers.
- Worked with Faculty Leads and leadership team to design shared assessment of student perceptions in introductory STEM courses and created a process for managing data collection across multiple courses/departments.
- Conducted assessment each semester and facilitated reflective interpretation of data with instructors.
- Mentored graduate student intern to support assessment.
- Worked with the Office of Academic Support on developing and launching a set of 5 TA/LA professional development modules in Canvas.
- Attended and participated in HHMI Learning Community Cluster gatherings, along with 12 other institutions.

- As part of the cross-university Core Integrated Implementation Team, supported department leaders across four departments to ask questions about the student experience in self-study.
- Conducted research into “Bright Spots” in teaching and learning in UVA STEM.
- Worked one-on-one with department leads to develop programmatic questions, and coached leads to guide their own data- and equity-oriented department conversations.
- Developed custom assessment and data approaches to address department questions.
- Participated in department “pathfinder projects.”

1 Collaboration, 2 Research, 2 Dissemination.*

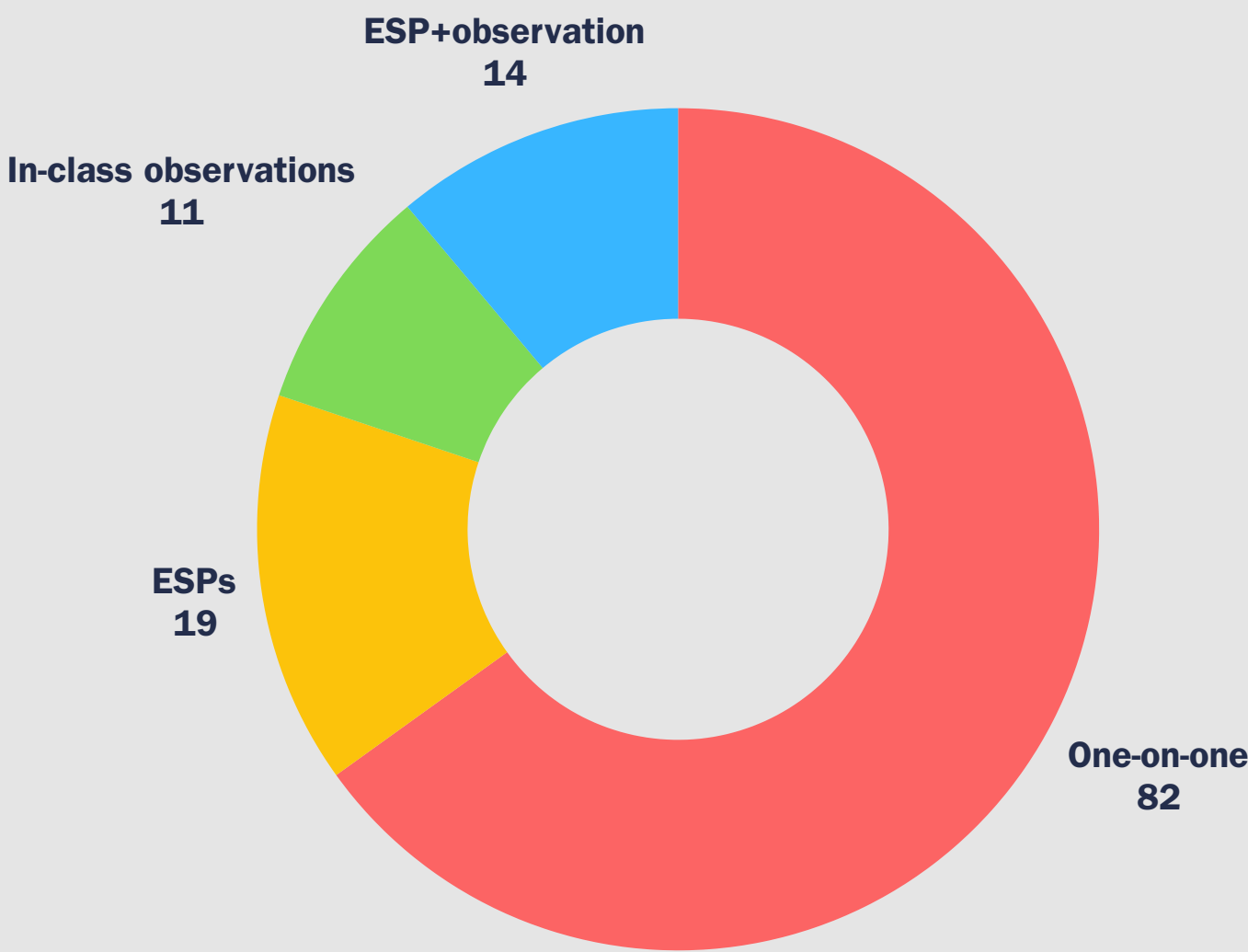
Thrive Grants

Received 22 applications and funded 10 Experiments (<\$2,000), 4 Small Pilots (up to \$10,000), and 1 Large Pilot (up to \$20,000).

Total amount funded: \$74,300

CONSULTATIONS

Completed 126 teaching consultations throughout the academic year. Instructors choose from four types: one-on-one consultation, Engaging Students' Perspectives (ESP) focus group, in-class observation, or ESP and observation.

15 instructors participated in this two-day workshop offering a deeper dive into designing writing assignments across disciplines with generative AI. This session was facilitated by Assistant Director Jess Taggart and Writing Across the Curriculum Director Heidi Nobles.

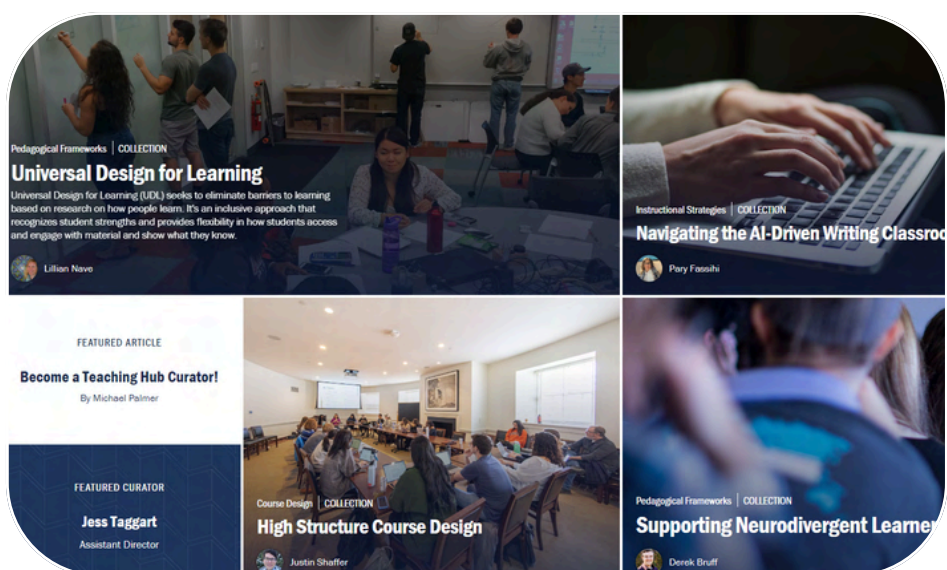
JULY

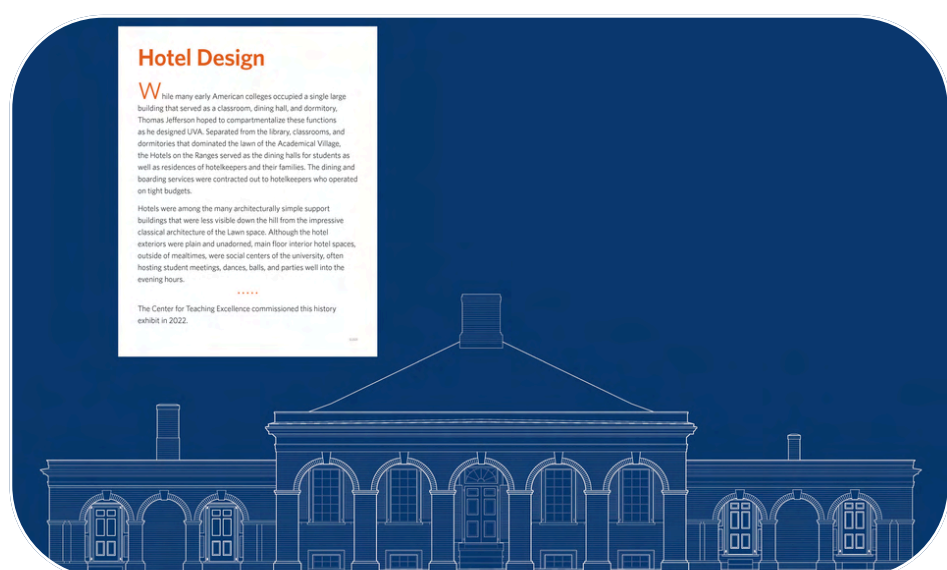

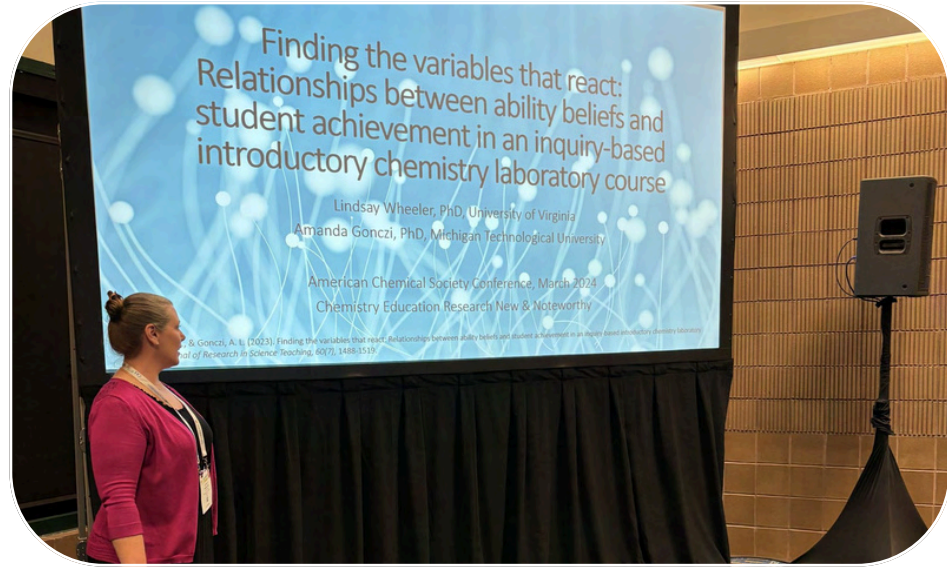
FEBRUARY

Leverage OneHE Content to Expand CTE Programming and Reach

We will pilot a subscription to the online educational development provider OneHE to offer additional support and resources to UVA instructors.



Develop and Implement the Faculty AI Guides Program

In collaboration with the Office of the Executive Vice President and Provost, we will train 50 faculty from across the University as AI Guides to advance the understanding of generative AI across Grounds.



Establish a CTE-wide Assessment Plan

In response to our external review, we will develop a CTE-wide assessment plan that articulates our principles and values around assessment, theory of change related to our various programs and initiatives, approaches to enacting and measuring change, and guidelines for how to assess the impact of our work across micro (faculty), meso (departments), and macro (institution) levels.
