PRODUCT INFORMATION

Natural Wet is a special formulation which includes saponins derived from *Yucca* plants which is used by the *Yucca* plant to alleviate the stress suffered under unfavorable conditions. **Natural Wet** may also facilitate nutrient and water absorption into the plant and stimulate plant growth and development. The principle ingredients in **Natural Wet** are saponins which are sapogenin glycosides derived mainly from *yucca* plant extracts. The *Yucca* plant and similar plants have adapted to harsh environments. These plants produce the saponins that aid in their survival. **Natural Wet** can be applied to potting mixes to aid in the uniformity of water absorption.

Directions of Use

Soil Application: Apply 16 oz. per acre (2 liters/hectare) in enough water to cover the acre.

Row Crops: Mix **Natural Wet** with fertilizer solutions.

Transplants: Mix **Natural Wet** with transplant water.

Bulk Soil: Add 16 oz. of **Natural Wet** per cubic yard while mixing.

Foliar Application:

Dilute Sprays: Use 16 fl. oz. of **Natural Wet** per 100 gallons (1 liter/800 liters) of spray solution.

Concentration sprays: Use 8 fl. oz. per acre (1 liter/hectare).
