

Manchester United v Arsenal Friendly Giveaway

OFFICIAL RULES

1. Description of Sweepstakes

Welcome to the Manchester United v Arsenal Friendly Giveaway (the “**Sweepstakes**” where eligible participants who enter the Eligible Retail Location (as defined below) and place a wager of at least Fifteen Dollars (\$15) (min odds of +100) on any market available at the Eligible Retail Location (as described below) or register on the landing page during the Sweepstakes Period (as defined below) will earn an entry into a drawing to win Two (2) of Twelve (12) Suite tickets to the July 22, 2023 Manchester United v Arsenal friendly match.

The Sweepstakes is sponsored by Betfair Interactive US, LLC (“**BIU**” or the “**Sponsor**”), located at 6701 Center Drive West, Suite 1000, Los Angeles, CA 90045. The terms “you” or “your” mean the person to whom a Sweepstakes Bonus (defined below) is issued to upon satisfaction of the terms set forth in this Sweepstakes. Redemption of the Sweepstakes is expressly conditioned upon acceptance of and compliance with all of these Sweepstakes “**Official Rules**”. Sweepstakes participants may be required to sign paperwork issued by the Sponsor.

2. Sweepstakes Period

The Sweepstakes will begin at 10:00 am ET on June 23, 2023, and end at 11:59 pm ET on July 10, 2023, (the “**Sweepstakes Period**” and each a “**Sweepstakes Day**”).

3. Eligibility

The Sweepstakes is only open to individuals who are at least 21 years of age and are physically present in the FanDuel Sportsbook at Meadowlands Racing in East Rutherford, New Jersey, (the “**Eligible Retail Location**”) during the Sweepstakes Period. Employees, officers and directors of the Sponsor, its affiliates, cable/satellite affiliates, advertising and Sweepstakes agencies, retailers, distributors (collectively, “**Sweepstakes Entities**”), and each of such employees’, officers’ and directors’ immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to participate in the Sweepstakes or receive a Prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. A person cannot be an eligible participant or winner if such person is a person: (a) with whom U.S. persons or entities are restricted from doing business under regulations of the Office of Foreign Asset Control (“**OFAC**”) of the Department of the Treasury (including those named on OFAC’s Specially Designated and Blocked Persons List) or under any statute or executive order; or (b) who is acting, directly or indirectly, for or on behalf of any such person. Void outside of New Jersey where prohibited by law. Any individuals who are actively on any “exclusion” or “self-exclusion” list(s) are ineligible to participate in this Sweepstakes. Individuals who have entered any self-limited or government agency self-exclusion program or have been otherwise excluded from casinos by a government agency, Sponsor or one of its affiliates or gaming license partners and persons on a Disassociated Patrons, Self-Limit, Involuntary Exclusion, Voluntary Exclusion or Self Exclusion List in jurisdictions which Sponsor or its affiliates or gaming license partners operate are not eligible to participate in the Sweepstakes or receive a Prize (as defined below).

4. Action Required

There are two (2) methods of entry into the Sweepstakes each of which qualify as an eligible entry into this Sweepstakes (“Entry”).

Eligible Wager Entry: On a given Sweepstakes Day you must enter the Eligible Retail Location and place a wager of at least Fifteen Dollars (\$15) (min odds must be +100) on any market available at the FanDuel Sportsbook at Meadowlands Racing (the “**Eligible Wager**”). You must enter your Name, Email, Date of Birth, and Bet Slip ID at: www.Fanduel.com/ManuvArsenal to be eligible.

Alternate Method: Alternatively, Participants may enter the Sweepstakes by filling out their Premier League Roster in the form at: <https://forms.gle/2ncrcnNNbSRy1c8G9> (“**Alternate Method Entry**”). Any Alternate Method Entry must be completely filled out to qualify as an Entry into this Sweepstakes.

Any Entry must be submitted before the applicable Sweepstakes is locked on July 10, 2023, at 11:59 pm ET (“**Lock Time**”) to be eligible for the Sweepstakes. Any submissions after this time will be disqualified from the Sweepstakes. There is no fee associated with the Alternate Method Entry.

All participants regardless of whether they enter via an Eligible Wager Entry or an Alternate Method Entry must be present at the Eligible Retail Location during the commencement of the Drawing to be eligible to claim their Prize (as defined below).

5. Claiming Sweepstakes Offer

Upon submitting an Entry and otherwise complying with these Official Rules, participants will be entered into the Drawing. Upon successfully submitting an Entry during the Sweepstakes Period, participants will receive an Entry into random drawings taking place on July 11th at 8:00PM ET (the “**Drawing**”) for the chance to win prizing as shown below:

(**Total value \$3,612 ARV**). (Collectively the “**Prize**”).

Six (6) “**Winners**” will be randomly selected from the Drawing from all Entries received during the Sweepstakes Period). If applicable, Prize Winners will be notified at the end of the Drawing. The Winners must be present during the Drawing to redeem the Prize. For avoidance of doubt, if the selected winner is not present during the Drawing, they will be disqualified from the Sweepstakes and another participant will be selected via Drawing. Odds of winning depend upon the number of eligible entries received. The purchase of any goods or services will not increase any participant’s chances of winning. Upon the request of Sponsor, the Winner must sign and return the following documents: an affidavit of eligibility; a liability/publicity release; and any other releases and waivers requested by Sponsor. If any of the foregoing documents are not completed, signed, and returned prior to deadline noted therein, or if a Winner is deemed by Sponsor to be ineligible or not to have complied with these Official Rules, then such Winner will be disqualified and an alternate Winner will be selected from the remaining eligible entries, time permitting.

Participants entering the Sweepstakes concurrently with wording, depiction or images that Sponsor considers, in its sole discretion, to be vulgar, profane, offensive or otherwise inappropriate shall not be eligible for the Sweepstakes.

See Section 4. Any wagers placed prior to the Sweepstakes or after the Sweepstakes Period will not be deemed an Eligible Wager. Wagers placed not at an Eligible Retail Location will not be deemed Eligible Wagers. Separately, wagers placed using site credits or any bonus received from a separate Sponsor Sweepstakes will not be deemed an Eligible Wager.

This Section of the FanDuel Terms of Use requires you to resolve disputes by binding arbitration and you agree to waive the ability to bring claims in a class action format.

LIMITATION OF LIABILITY: TO THE FULLEST EXTENT PERMISSIBLE UNDER APPLICABLE LAW, THE SPONSOR SHALL NOT BE RESPONSIBLE OR LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, ECONOMIC, EXEMPLARY, PUNITIVE OR OTHER DAMAGES UNDER ANY CONTRACT, NEGLIGENCE, STRICT LIABILITY OR OTHER THEORY ARISING OUT OF OR RELATING IN ANY WAY, DIRECTLY OR INDIRECTLY, TO REDEMPTION OF THE SWEEPSTAKES, EVEN IF FORESEEABLE OR EVEN IF THE SPONSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
