#### **OFFICIAL RULES**

# 1. <u>Description of Sweepstakes</u>

Welcome to the FanDuel Custom Putter Giveaway (the "Sweepstakes") where eligible participants who enter the Eligible Retail Location (as defined below) and place a retail wager of at least Fifty Dollars (\$50) on the 2023 Ryder Cup Tournament at the Eligible Retail Location (as described below) and register on the landing page during the Sweepstakes Period (as defined below) will earn an entry into a drawing to win a Custom FanDuel Swag Golf Putter.

The Sweepstakes is sponsored by Betfair Interactive US, LLC ("BIU" or the "Sponsor"), located at 6701 Center Drive West, Suite 1000, Los Angeles, CA 90045. The terms "you" or "your" mean the person to whom a Sweepstakes Bonus (defined below) is issued to upon satisfaction of the terms set forth in this Sweepstakes. Redemption of the Sweepstakes is expressly conditioned upon acceptance of and compliance with all of these Sweepstakes "Official Rules". Sweepstakes participants may be required to sign paperwork issued by the Sponsor.

### 2. Sweepstakes Period

The Sweepstakes will begin at 10:00 am ET on September 18, 2023, and end at 11:59 pm ET on October 1, 2023, (the "Sweepstakes Period" and each a "Sweepstakes Day").

The random drawing will take place on October 2<sup>nd</sup>, 2023 at 10:00AM ET (the "Drawing").

### 3. Eligibility

The Sweepstakes is only open to individuals who are at least 21 years of age and are physically present in the FanDuel Sportsbook at Live! Casino Pittsburgh 5260 Route 30 Greensburg, PA. 15601 (The "Eligible Retail Location") during the Sweepstakes Period. Employees, officers and directors of the Sponsor, its affiliates, cable/satellite affiliates, advertising and Sweepstakes agencies, retailers, distributors (collectively, "Sweepstakes Entities"), and each of such employees', officers' and directors' immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to participate in the Sweepstakes or receive a Prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal quardians, in-laws, grandparents, siblings, children and grandchildren and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Any Alternate Method Entry must be completely filled out to qualify as an Entry into this Sweepstakes.

Any Entry must be submitted before the applicable Sweepstakes is locked on October 1, 2023, at 11:59 pm ET ("**Lock Time**") to be eligible for the Sweepstakes. Any submissions after this time will be disqualified from the Sweepstakes. There is no fee associated with the Alternate Method Entry.

### 5. Claiming Sweepstakes Offer

Three (3) "Winners" will be randomly selected from the Drawing from all Entries received during the Sweepstakes Period). If applicable, Prize Winners will be notified at the end of the Drawing. Winners will be notified via the email/telephone contact information they used to enter the Sweepstakes within Seventy-Two (72) hours of the completion of the Drawing. If a prospective Winner does not respond to the communication from Sponsor within Seventy-Two (72) hours of the receipt of the communication, the prospective Winner will be disqualified and a new Winner will be randomly selected from the remaining Entrants in the Sweepstakes. If a Winner is unreachable; does not make direct contact with Sponsor by the time specified; or fails to accept the Prize, Sponsor reserves the right, in its sole and absolute discretion, to disqualify such Winner and to select a replacement Winner from the remaining qualifying participants.
