

FanDuel 2023 Wimbledon Sweepstakes

OFFICIAL RULES

NO PURCHASE OR WAGER OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION. A PURCHASE OR WAGER OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY / PRIZE ACCEPTANCE AGREEMENT MAY BE REQUIRED. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

1. Description of Sweepstakes

Welcome to the FanDuel Wimbledon 2023 Sweepstakes (the “**Sweepstakes**”) where any eligible participant who enters an Eligible Retail Location (as defined below), places a \$5+ wager on any 2023 Wimbledon Tennis market and registers their wager, will earn an entry for the chance to win 2 Tickets to the 2023 Men’s US OPEN Semifinal (travel and hotel accommodations included).

The Sweepstakes is sponsored by Betfair Interactive US, LLC (“**FanDuel**” or the “**Sponsor**”), located at 6701 Center Drive West, Suite 1000, Los Angeles, CA 90045. The terms “**you**” or “**your**” mean the person to whom a Prize/Grand Prize (as defined below) is issued to upon satisfaction of the official rules set forth in this Sweepstakes. Redemption of the Sweepstakes is expressly conditioned upon acceptance of and compliance with all of these Sweepstakes “**Official Rules**”. Sweepstakes participants may be required to sign paperwork issued by the Sponsor.

2. Sweepstake Period

The Sweepstakes will begin on 12:00 AM ET July 2nd, 2023 and end at 11:59 PM ET July 16th 2023 (the “**Sweepstakes Period**” and each a “**Sweepstakes Day**”).

This promotion’s random drawing will take place at 1:00 pm ET on July 17th, 2023 (the “**Drawing**”). Winning participants will be notified via email or phone within 72 hours.

3. Eligibility

The Sweepstakes is only open to individuals who are at least 21 years of age and are physically present in the FanDuel Sportsbook at (Live! Casino Hotel Maryland 7002 Arundel Mills, Circle #7777, Hanover, MD. 21076 or Live! Casino Hotel Philadelphia 900 Packer Ave., Philadelphia, PA. 19148 or Live! Casino Pittsburgh 5260 Route 30 Greensburg, PA. 15601) (each an “**Eligible Retail Location**”) during the Sweepstakes Period. Employees, officers and directors of the Sponsor, its affiliates, cable/satellite affiliates, advertising and Sweepstakes agencies, retailers, distributors (collectively, “**Sweepstakes Entities**”), and each of such employees’, officers’ and directors’ immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to participate in the Sweepstakes or receive a Prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. A person cannot be an eligible participant or winner if such person is a person: (a) with whom U.S. persons or entities are restricted from doing business under regulations of the Office of Foreign Asset Control (“**OFAC**”) of the Department of the Treasury (including those named on OFAC’s Specially Designated and Blocked Persons List) or under any statute or executive order; or (b) who is acting, directly or indirectly, for or on behalf of any such person. Void outside of Maryland, Pennsylvania and where prohibited by law. Any individuals who are actively on any “**exclusion**” or “**self-exclusion**” list(s) are ineligible to participate in this Sweepstakes. Individuals who have entered any self-limited or government agency self-exclusion program or have been otherwise excluded from casinos by a government agency, Sponsor or one of its affiliates or gaming license partners and persons on a Disassociated Patrons, Self-Limit, Involuntary Exclusion, Voluntary Exclusion or Self Exclusion List in jurisdictions which Sponsor or its affiliates or gaming license partners operate are not eligible to participate in the Sweepstakes or receive a Prize (as defined below).

4. Action Required

There are two (2) methods of entry into the Sweepstakes each of which qualify as an eligible entry into this Sweepstakes (“**Entry**”).

Wager Entry: To qualify for the Sweepstakes, on a given Sweepstakes Day you must enter one Sponsor’s Eligible Retail Locations, place a \$5+ wager on any 2023 Wimbledon Tennis market (the “**Eligible Wager**”) and register your Eligible Wager(s) via the landing page found at www.Fanduel.com/USopen.

Alternate Method: Alternatively, Participants may enter the Sweepstakes by filling out the form found at: <https://forms.office.com/r/M024CTDmaf> (“**Alternate Method Entry**”). Any Alternate Method Entry must be completely filled out to qualify as an Entry into this Sweepstakes.

Any Entry must be submitted before the applicable Sweepstakes is locked on July 16th, 2023, at 11:59 pm ET (“**Lock Time**”) to be eligible for the Sweepstakes. Any submissions after this time will be disqualified from the Sweepstakes. There is no fee associated with the Alternate Method Entry.

5. Claiming Sweepstakes Offer

Upon successfully satisfying the Deposit Method of Entry or Alternate Method of Entry requirements during the Sweepstakes Period, participants will receive an Entry into random drawings taking place at 1 pm EST on July 17th, 2023 (the “**Drawing**”) for the chance to win Two (2) tickets to the 2023 Men’s US Open Tennis Semifinals (taking place on Friday September 8th, 2023), and travel accommodations (the “**Prize**”). The total average retail value of the Prize value is Five Thousand Hundred Dollars (\$5,000). Two (2) “**Winners**” will be randomly selected from the Drawing from all Entries received during the Sweepstakes Period). Winners will be notified via email after he/she has been selected and must accept the Prize within Seventy-Two (72) hours of the conclusion of the Drawing. If a prospective Winner does not respond to the email communication from Sponsor within Seventy-Two (72) hours of the receipt of the communication, the prospective Winner will be disqualified and a new Winner will be randomly selected from the remaining Entrants in the Sweepstakes. If a Winner is unreachable; does not make direct contact with Sponsor by the time specified; or fails to accept the Prize, Sponsor reserves the right, in its sole and absolute discretion, to disqualify such Winner and to select a replacement Winner from the remaining qualifying participants. Sponsor shall not be responsible for failed attempts to notify the Winner and no responsibility is assumed by Sponsor for any correspondence returned as undeliverable or any other problems associated with attempt(s) to notify the Winners. Odds of winning depend upon the number of eligible entries received. The purchase of any goods or services will not increase any participant’s chances of winning. Upon the request of Sponsor, the Winner must sign and return the following documents: an affidavit of eligibility; a liability/publicity release; and any other releases and waivers requested by Sponsor. If any of the foregoing documents are not completed, signed, and returned prior to deadline noted therein, or if a Winner is deemed by Sponsor to be ineligible or not to have complied with these Official Rules, then such Winner will be disqualified and an alternate Winner will be selected from the remaining eligible entries, time permitting.

Prize recipients will be solely responsible for all federal, state, and local taxes, and for any other fees or costs associated with the Prize received, regardless of whether the Prize, in whole or in part, is used. Prizes are non-transferable, with no equivalents or substitutions except at Sponsor’s sole and absolute discretion. All Prize details not specified in these Official Rules will be determined in Sponsor’s sole and absolute discretion. Prize details and availability are subject to change and prize provider’s rules and restrictions, and in the event that Sponsor is unable to provide the winner with his or her Prize(s), the Sponsor may elect to provide winners with the approximate value of such item in cash or award an alternate prize of comparable or greater value. All Prizes are awarded “AS IS” and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). The approximate retail value (“ARV”) of the prizes is based on available information provided to Sponsor and the value of any prize awarded to a Winner may be reported for tax purposes as required by law. The Winners may be required to provide Sponsor with a valid social security number before the Prizes will be awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of Winners. Unclaimed Prize(s) will be forfeited. Prize(s), if legitimately claimed, will be awarded. The Sweepstakes Entities are not responsible for and will not replace any lost, mutilated or stolen prizes or any prize that is undeliverable or does not reach the winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Sweepstakes Entities will have no further obligation with respect to that prize or portion of the prize. The Sweepstakes Entities are not responsible for, and winner will not receive the difference, in any, between the actual value of the prize(s) at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material. Limit of one (1) Prize per person in connection with this Sweepstakes.

7. Limitations on Participation

This Sweepstakes is void where prohibited by law.

Participants entering the Sweepstakes concurrently with wording, depiction or images that Sponsor considers, in its sole discretion, to be vulgar, profane, offensive or otherwise inappropriate shall not be eligible for the Sweepstakes.

No Third-Party Sponsor: This Sweepstakes is in no way sponsored, endorsed, or administered by, or in association with any person or other entity, including any third party, other than FanDuel. All questions regarding the Sweepstakes must be directed to Sponsor. You agree as a condition of participating in the Sweepstakes that you shall release any third party from any and all liability arising out of or relating to your participation in the Sweepstakes, acceptance, use, or misuse of any Prize/Grand Prize.

Dispute Resolution: You agree that any claim or dispute that has arisen or may arise relating in any way to or arising out of the Sweepstakes, or these Terms will be resolved in accordance with the dispute resolution provisions set forth in the "Binding arbitration and class action waiver" Section of the FanDuel Terms of Use (<https://www.fanduel.com/terms>). This Section of the FanDuel Terms of Use requires you to resolve disputes by binding arbitration and you agree to waive the ability to bring claims in a class action format.

LIMITATION OF LIABILITY: TO THE FULLEST EXTENT PERMISSIBLE UNDER APPLICABLE LAW, THE SPONSOR SHALL NOT BE RESPONSIBLE OR LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, ECONOMIC, EXEMPLARY, PUNITIVE OR OTHER DAMAGES UNDER ANY CONTRACT, NEGLIGENCE, STRICT LIABILITY OR OTHER THEORY ARISING OUT OF OR RELATING IN ANY WAY, DIRECTLY OR INDIRECTLY, TO REDEMPTION OF THE SWEEPSTAKES, EVEN IF FORESEEABLE OR EVEN IF THE SPONSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

Miscellaneous: No waiver of any of the provisions of these Official Rules shall be deemed or shall constitute a waiver of any other provisions hereof, nor shall waiver constitute a continuing waiver unless otherwise expressly provided. If any provision of these Official Rules is found to be invalid or unenforceable by a court of competent jurisdiction, such provision shall be severed from the remainder of these Official Rules, which will otherwise remain in full force and effect.
