

## ForeFlight "Filing" Sweepstakes

### OFFICIAL RULES

The ForeFlight "Filing" Sweepstakes ("Promotion") is sponsored by ForeFlight LLC ("Sponsor") located at 2323 S. Shepherd Drive, Suite 912, Houston, Texas 77019.

Promotion begins on October 1, 2019 at 8:00am (Eastern Standard Time) and ends 11:59 p.m. (Eastern Standard Time) on December 31, 2019 ("Promotion Period"). All entries must be received during the Promotion Period to be eligible.

Upon conclusion of Promotion Period, a prizewinner will be determined by a random drawing from all eligible entries to be held by Sponsor on January 9, 2020 (each a "Winner"). A maximum of Five (5) prizes will be awarded during the Promotion Period.
