

Summary Annual Report

This is a summary of the annual report for the GREENVILLE UNIVERSITY RETIREMENT PLAN, (Employer Identification No. 37-0681530, Plan No. 001) for the period January 1, 2019 to December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$1274263. These expenses included \$21572 in administrative expenses and \$1252691 in benefits paid to participants and beneficiaries. A total of 489 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$28086457 as of December 31, 2019 compared to \$23846779 as of January 1, 2019. During the plan year the plan experienced an increase in its net assets of \$4239678. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$5513941, including employer contributions of \$454221, employee contributions of \$584080, others contributions of \$528, earnings from investments of \$4464900 and other income of \$10212.

The plan has a contract with Tiaa-Cref which allocates funds toward individual policies.

MINIMUM FUNDING STANDARDS

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An accountant's report;
2. Assets held for investment;
3. Insurance information including sales commissions paid by insurance carriers; and

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. These portions of the report are furnished without charge.
