 - **Adult education HS diploma (CALPADS School Completion Status Code 250)**
 - **Received a HS Equivalency Certificate (CALPADS School Completion Status Code 320)**
 - **Passed the California HS Proficiency Exam (and no standard diploma) (CALPADS School Completion Status Code 330)**
 - **Completed grade twelve without completing graduation requirements, not grad (CALPADS School Completion Status Code 360)**

- **New Files:**
 - **SINC – Student Incident**
 - **SIRS – Student Incident Result**
 - **SOFF – Student Offense**

EOY – Student Discipline

- **New Incident Result Codes**
 - **DSP:**
 - **(400) No Action**
 - **(700) School-related Arrest**
 - **(800) Law Enforcement Referral, not including school-related arrests**
 - **BER – Behavioral Emergencies**
 - **(501) Physical Restraint**
 - **(502) Mechanical Restraint**
 - **(600) Seclusion**

EOY – CRSC

- **Carnegie Units**
 - **What's a Carnegie Unit?** *(yeah, we don't know either)*

EOY – College Credit and Dual Enrollment

- **Course Level 40 – NO LONGER VALID**
- **Course Level 23**
 - **College Credit ONLY**
 - **A college-level, college credit bearing course in which a student *receives only college credit* upon successful completion.**
 - **Won't count towards Grad Reqs or GPA and won't display credits**
 - **Optionally won't print on transcripts**

EOY – College Credit and Dual Enrollment

- **Course Level 24**
 - **Dual Credit**
 - **A college-level, college credit bearing course in which a student *receives both high school and college credit* upon successful completion.**
 - **BUT...**

EOY – College Credit and Dual Enrollment

- **Course Level 24**
 - **...You will have students in the same class where SOME will end up getting College Credit and SOME will NOT.**
 - **We know, you dealt with this last year**

EOY – College Credit and Dual Enrollment

- **Course Level 24**
 - **...You will have students in the same class where SOME will end up getting College Credit and SOME will NOT.**
 - **We know, you dealt with this last year**
 - **We have a better solution this year...**

EOY – College Credit and Dual Enrollment

- **Course Level 24**
 - **New CRS Field: *College Credit State Course Code***
 - **Only populated on Course Level 24 records**
 - **Will have values limited to College Credit and CTE**

EOY – College Credit and Dual Enrollment

- **Course Level 24**
 - **Key HIS Field: *College Credit Hours (HIS.CH)***
 - **When populated, the course and section will be virtualized for the CALPADS Extract**
 - **When populated, code 24 will be extracted and the *College Credit State Course Code will be extracted***
 - **When not populated, the regular course will not have code 24 extracted**
