## MANUFACTURER'S LIMITED WARRANTY

For all products sold on or after October 1, 2017

The limited warranty set forth below is given by INMOTION, a division of Caldwell Manufacturing Company, North America, LLC ("INMOTION"), with respect to new merchandise purchased and used in the United States, its possessions and territories.

INMOTION warrants this product to be free from defects in material and workmanship, under normal and proper installation and use in accordance with instructions of INMOTION, for a period of three (3) years commencing on the date of original sale (the "Warranty Period"). INMOTION's liability under this limited warranty shall be limited to, at its option, repair or replacement, free of charge, of any part found to be defective in material or workmanship during the Warranty Period (including among others replacement with different parts or systems functionally equivalent or better to the parts replaced).

This limited warranty shall not extend to anyone other than the original purchaser or the person for whom the product was purchased.

The foregoing limited warranty does not cover any defects caused by or resulting from normal wear and tear; improper or deficient installation or maintenance by parties other than INMOTION or parties authorized by INMOTION; accidents or intentional acts of parties other than INMOTION; modification, alteration, repair or other change to the product by any party other than INMOTION; any use of the product other than in accordance with documentation and instructions provided by INMOTION; any other improper use, abuse, misuse or neglect of the product; damage incurred during handling or shipping by parties other than INMOTION; any Act of God or force majeure event; or exposure to excessive heat, cold or moisture, or harmful chemicals or substances. The foregoing limited warranty does not cover any labor costs or expenses incurred by any party not authorized by INMOTION in connection with the repair or replacement of any defective product.
