***HU Executive Session, March 13-15, 2020
(Current and New HU Students)***

All HU students that are not arriving from China, South Korea, Italy, or Iran, or who are not experiencing symptoms of the 2019 novel coronavirus (2019-nCoV), are required to attend the March 13-15, 2020 Executive Session in Harrisburg.

Executive Sessions are planned such that material delivered face-to-face in these sessions is often not easily deliverable offline. Recording some of the educational techniques used may be very difficult to capture effectively for later viewing and that material would be missing from the planned educational program of an absent student. If you are absent from the upcoming Executive Session, you must work with your course faculty to make up the missed content and achieve the educational objectives for the session.

If you are flying within the US to attend the upcoming Executive Session, please be aware that travel information, as well as general information including preventative practices, have been issued by the Centers for Disease Control and Prevention: <https://www.cdc.gov/coronavirus/2019-ncov/travelers/index.html>.

As a general matter, International Students attending HU on a F-1 Visa that are **not** arriving from China, South Korea, Italy, or Iran, or who are not experiencing symptoms of the virus are expected to remain compliant with the conditions of their Visa regarding attendance and credit load.

However, if you are a new HU international student **who is currently outside of the United States and in China, South Korea, Italy, or Iran, or exhibiting symptoms of 2019-nCoV**, HU can delay your program start date and issue a new initial Form I-20, "Certificate of Eligibility for Nonimmigrant Student Status."

For any HU students on an F-1 Visa who are **out of the country but currently studying at HU as an active student who are in China, South Korea, Italy, or Iran, or exhibiting symptoms of the virus**, you may be eligible for a medical reduced course load. You will need to provide to HU medical documentation from a doctor. Upon receipt of the documentation, HU's DSO will register you in the Student and Exchange Visitor Information System (SEVIS) for a medically reduced course load with no course load. However, you may not travel to the United States until you can re-enroll in a full course of study at HU consistent with the terms of your Visa. If your

anticipated return from a temporary absence exceeds the five-month limit, HU will provide details to the SEVP Response Center. SEVP will resolve these on a case-by-case basis. Consequently, it is critical that you keep HU informed and updated if you will not be in attendance due to issues related to the virus.

If you are an international student **currently inside the United States, attending HU on an F-1 Visa, exhibiting symptoms of 2019-nCoV, and cannot enroll or continue studies due to your health**, you are eligible for a medical reduced course load. You will need to provide HU medical documentation from a doctor. Upon receipt of the documentation, HU's DSO will register you in the Student and Exchange Visitor Information System (SEVIS) for a medically reduced course load with no course load. During the period you are ill, please follow directions from the CDC for treating and containing the virus: <https://www.cdc.gov/coronavirus/2019-ncov/downloads/sick-with-2019-nCoV-fact-sheet.pdf>. If your anticipated return from a temporary absence exceeds the five-month limit, HU will provide details to the SEVP Response Center. SEVP will resolve these on a case-by-case basis. Consequently, it is critical that you keep HU informed and updated if you will not be in attendance due to issues related to the virus.

NOTE: DEPENDING ON CORONA VIRUS DEVELOPMENTS, HU INTERNATIONAL STUDENTS WHO LEAVE THE UNITED STATES TO TRAVEL INTERNATIONALLY MAY NOT BE ABLE TO RE-ENTER THE COUNTRY, OR MAY BE SIGNIFICANTLY DELAYED FROM DOING SO.
