(“DJTP”) and the Republican National Committee (“RNC”) and the official Republican state parties Alabama, Alaska, Arizona, Arkansas, California, Colorado, District of Columbia, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, South Dakota, Tennessee, Texas, Vermont, Virginia, Washington, West Virginia, Wisconsin and Wyoming.

Contributions must: (i) be made only by U.S. citizens or permanent residents; (ii) not be made from the funds of a corporation, labor organization or national bank; and (iii) be the donor’s personal funds, not those of another person or entity.
