## About Yesli Vega

Yesli Vega was raised in Northern Virginia where she was taught the values of hard work, faith in God, and a love for the greatest country in the world. As a daughter of immigrants, a mother, a law enforcement officer, and a military wife, Yesli is the embodiment of the American Dream.

In the 1980's, Yesli's parents fled El Salvador in the midst of civil war, moving to America and passing on the ideals of freedom and opportunity offered by the United States to their children. This led her to serve in three separate Virginia law enforcement agencies and built on her commitment to serving the community she lived in.

When family tragedy struck, perpetrated by local gang members in a case of mistaken identity leading to the death of a family friend and her brother being severely wounded, Yesli made the decision to enter the world of law enforcement. Her career began as a street cop in the City of Alexandria where she faced the split second, life or death situations our men and women in blue face every day when they put on the uniform. She went on to serve as a certified hostage negotiator and member of the Crisis Intervention Team. She later moved to a force closer to home and joined the Manassas Park Police Department before duty called her family to South Korea to join her husband's deployment as a member of the United States Army. Being so close to the daily threat of Communist North Korea gave Yesli an even greater appreciation for America's commitment to freedom and human rights. Upon her family's return, Yesli accepted a job with the Prince William County Sheriff's office to serve as a deputy.

As her children grew older, Yesli took an interest in government and the policies put forward by those in charge of safeguarding our liberties. As a homeowner, she and her husband watched with concern as the services provided by local government did not match the increasingly high real estate tax they were required to pay. This, combined with a dangerous new political movement that sought to attack and scapegoat law enforcement led Yesli to serve in a different way - through elected office as a Prince William County Supervisor.

In her role as Supervisor, Yesli worked to defeat unconstitutional gun control resolutions, fought eminent domain abuse threatening low-income residents, advocated for reduced property taxes, and has been a steadfast advocate for government transparency, efficiency, and fiscal responsibility.

Yesli still serves as an Auxiliary Deputy for the Prince William County Sheriff's Office and is an active member at her church. She also enjoys coaching her daughter's soccer team and volunteering with the Special Olympics and Santa Cops. The first in her immediate family to graduate from college, Yesli has a Bachelor's of Science in Criminal Justice from American Military University and is a graduate of the Northern Virginia Criminal Justice Academy. She currently lives in Prince William County with her husband Rene and their two children.

Vega Victory Fund is a joint fundraising committee composed of:

Yesli Vega for Virginia and Yes to Yesli PAC (each individually, a "Committee" and collectively, the "Committees").

Any contributions to Vega Victory Fund permissible under the Federal Election Campaign Act, as amended ("FECA"), 52 U.S.C. §§ 30101 et seq., from donors who have not exceeded their applicable Federal contribution limits shall be allocated among the participating committees pursuant to the FECA and the following method (All limits will adjust based on changes made to contribution limits.):

1. The first \$2,900 from any single individual's contribution shall go to Yesli Vega for Virginia - 2022 primary debt election account. The next \$2,900 shall go to Yesli Vega for Virginia - 2022 general election account. The next \$5,000 shall go to Yes to Yesli PAC.
2. The first \$5,800 from any joint individual's contribution shall go to Yesli Vega for Virginia - 2022 primary debt election account. The next \$5,800 shall go to Yesli Vega for Virginia - 2022 general election account. The next \$10,000 shall go to Yes to Yesli PAC.
3. The first \$2,900 from any federal non-multicandidate PAC's contribution shall go to the Yesli Vega for Virginia - 2022 primary debt election account. The next \$2,900 shall go to Yesli Vega for Virginia - 2022 general election account. The next \$5,000 shall go to Yes to Yesli PAC .
4. The first \$5,000 from any federal multicandidate PAC's contribution shall go to Yesli Vega for Virginia - 2022 primary debt election account. The next \$5,000 shall go to Yesli Vega for Virginia - 2022 general election account. The next \$5,000 shall go to Yes to Yesli PAC .

Contributions allocated to Yesli Vega for Virginia and designated to the repayment of outstanding lawful debts incurred in relation to the 2022 primary election shall be reallocated if Yesli Vega for Virginia receives sufficient contributions to pay such debts.

Contributions to Vega Victory Fund and any participating Committee are not deductible as charitable contributions for Federal income tax purposes. All contributions permissible under FECA but that would cause a contributor to exceed any applicable Federal contribution limit to a specific committee, shall be reallocated to the other Committee to the extent permitted by FECA in accordance with the formula above. Any contribution that would otherwise cause a contributor to exceed any applicable Federal contribution limit or that is not permissible under FECA shall be refunded to the contributor. Any contributor may designate his or her contribution to a specific participating Committee, to the extent permissible by FECA. Any contributor may make his or her contribution payable directly to any of the participating Committees listed in the Preamble to this Notice. Any such designated contribution that causes the contributor to exceed the contribution limit to the designated participating Committee shall not be reallocated by Vega Victory Fund absent the prior written permission of the contributor as required by law.

All funds received in response to this solicitation will be subject to federal contribution limits and prohibitions.

Contributions from corporations, national banks, labor organizations, foreign nationals who are not lawfully admitted for permanent residence and federal contractors are prohibited.

The maximum an individual may contribute to this joint fundraising committee is \$10,800 per election cycle or calendar year as appropriate. The maximum amount a federal multi-candidate political action committee may contribute to this joint fundraising committee is \$15,000. The maximum amount a federal political action committee that is not a multi-candidate committee may contribute to this joint fundraising committee is \$10,800.

Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and employer of each individual who contributes over \$200 in a calendar year or election cycle, as applicable.
