**Certification Of Compliance With Order Dated January 5, 2026**

Pursuant to this Court’s Order dated January 5, 2026 (Dkt. 133), Class Counsel was directed to provide a second round of notice to newly identified class members (the “Second Class Notice”) on or before January 23, 2026 and to certify compliance and provide a list of timely requests for exclusion by March 30, 2026. Class Counsel hereby certifies that it provided the Second Class Notice as directed by the Court.
