Certification Of Compliance With Order Dated February 18, 2026

Pursuant to this Court’s Order dated February 18, 2026 (Dkt. 151), Class Counsel was directed to provide a third round of notice to newly identified class members (the “Third Class Notice”) on or before February 20, 2026, and to certify compliance and provide a list of timely requests for exclusion by April 27, 2026. Class Counsel hereby certifies that it provided the Third Class Notice as directed by the Court. Attached as **Exhibit A** is a list of individuals who timely requested exclusion from the class before the April 6, 2026 deadline either by letter or by email.

In total, Class Counsel mailed out 182,128 notices to class members (using the addresses provided to Class Counsel by the SSA) across the three separate notice periods. Of those notices sent out, approximately 6,562 (3.6%) were returned as undeliverable.

In total, Class Counsel received 276 opt-out requests (or requests for exclusion from the Class). That number includes those that were untimely or not made in the proper form (via email or mail), which Class Counsel has processed and reported nonetheless. As a result, *only* .15% of all class members mailed notices (excluding returned mail) submitted requests to opt-out from the class. Additionally, Class Counsel has fielded and responded to approximately 1,335 communications from class members including via phone, email, and mail.
