## NYCLA's 96th Annual Dinner Honors Roderick A. Palmore And George W. Madison

The New York County Lawyers' Association's (NYCLA) 96th Annual Dinner celebrating diversity in the legal profession will be held on Tuesday, December 14, 2010 in the Grand Ballroom of the Waldorf Astoria Hotel.

At the dinner, the NYCLA Diversity Award will be presented to Roderick A. Palmore, Executive Vice President and General Counsel of General Mills, Inc., who wrote the "Call to Action, Diversity in the Legal Profession," urging general counsel to drive diversity by demanding results in the law firms with which they work, as well as in their law departments. ner co-chairs are Michele Coleman Mayes, Senior Vice President and General Counsel, Allstate Insurance Company, and Robert L. Haig, a partner at Kelley Drye & Warren LLP.

At the dinner, NYCLA will recognize and honor the corporate law department and law firm signatories of NYCLA's Diversity Statement for their commitment to diversity in the legal profession. NYCLA's Diversity Statement, which has been signed by nearly 150 corporations and law firms, provides: "The undersigned law firms and law departments support efforts to increase diversity in the legal profession. We call upon other law firms and law departments to

join us in taking steps to implement such efforts. We believe that law firms should not object to requests by their corporate clients that the firms report the number of hours devoted to the clients' matters by minority lawyers. If our clients decide that they wish to publicly report the amounts of legal fees which they pay for services rendered by minority lawyers as emblematic of their commitment to increasing diversity in the legal profession, we would work with them to provide such numbers or estimates."

NYCLA has invited to attend as its guests, judges from both the federal and state trial and appellate courts, government officials, and bar association leaders. NYCLA's annual dinner is a magnificent social event, renowned as the "bench and bar event of the year." It provides an opportunity for clients, spouses and friends to join in a festive evening. Last year over 1,000 lawyers and judges attended the dinner.
