### About

John worked as the Special Assistant to the President and Senior Director for International Trade, Energy and Environment, where he was responsible for advising the President on international trade and investment issues and for the international aspects of energy and environmental policy.

John was also involved in export control and sanctions issues and preparing for meetings of the cabinet-level U.S.-E.U. Transatlantic Economic Council, the U.S.-India Economic Dialogue and CEO Forum, and the U.S.-China Strategic Economic Dialogue, including preparation for the November 2008 G-20 financial summit. John was one of only a handful of senior National Security Council staff asked to carryover with the administration of President Barack Obama to assist on transition activities.

In addition, John served as a senior advisor to the Assistant Secretary of Commerce for Import Administration at the U.S. Department of Commerce, where he advised the Assistant Secretary on issues raised in antidumping, countervailing duty and textile-related proceedings and policy matters

before the agency. John also worked as a law clerk to former Chief Judge Gregory W. Carman at the United States Court of International Trade, as well as a legal intern to the Chairman of the U.S. International Trade Commission. He began his career at the White House as the Executive Assistant to the Assistant to the President for Economic and Domestic Policy.
