Commercial Litigation

Lead investigator and trial counsel in successful defense of life insurance company in action filed by institutional, secondary owner of a life insurance policy attempting to enforce a misstatement of age in a Holocaust survivor's life insurance application. The court denied plaintiff's request for declaratory relief in full after a three-day bench trial. *Wilmington Trust, N.A. v. Segal, and John Hancock Life Insurance Company of New York, Case No. 1:21-CV-01540-PKC-TAM*.
