

LEHMAN'S OFFICIAL SWEEPSTAKES RULES
April-May 2019

1. ELIGIBILITY. No purchase necessary. This Sweepstakes (the "Sweepstakes") brought to you by LEHMAN HARDWARE AND APPLIANCES, INC., also known as LEHMAN'S, an Ohio corporation ("Sponsor") is governed by these rules (the "Official Rules"). The Sweepstakes is open to U.S. residents (excluding Puerto Rico) age 18 or older at the time of entry (the "Entrant"). Employees, directors, officers and principals, of the Sponsor, its subsidiaries, affiliates, contractors, agents and members of their immediate families or households are not eligible to participate.
