NICHD workshop to weigh strategies for diagnosing Gestational Diabetes This fall, NICHD will convene a consensus development workshop on Diagnosing Gestational Diabetes Mellitus. The workshop will bring together an international panel to identify the optimal strategy for screening for gestational glucose intolerance. Invited speakers include William Callaghan, Donald Coustan, Wanda Nicholson, Patrick Catalano, David Pettitt, Mark Landon, Matt Gilman, Tim Cundy, Aaron Caughey, William Barth, Brian Casey, Boyd Metzger, and Edmond Ryan.

Workshop participants will address 7 key questions:

- 1. What are the current screening and diagnostic approaches for gestational diabetes mellitus, what are the glycemic thresholds for each approach, and how were these thresholds chosen?
- 2. What are the effects of various gestational diabetes mellitus screening/diagnostic approaches for patients, providers, and U.S. healthcare systems?
- 3. In the absence of treatment, how do health outcomes of mothers who meet various criteria for gestational diabetes mellitus and their offspring



- 4. Does treatment modify the health outcomes of mothers who meet various criteria for gestational diabetes mellitus and their offspring?

Advisory Committee on Infant Mortality Meets

On March 8 and 9 the Secretary's Advisory Committee on Infant Mortality (SACIM) met to discuss the Administration's current work in the area of reducing infant mortality, as well as hear from several states and outside experts about their efforts.

SACIM is comprised of members of the public and private sector, and advises the Secretary of the <u>U.S. Department of Health and Human Services</u> on HHS programs that are directed at reducing infant mortality and improving the health status of pregnant women and infants.

The Committee , which meets semiannually, also provides advice on how best to coordinate Federal, State, local, and private efforts to address the health and social problems that impact infant mortality. SMFM submitted public comments at the most recent meeting that will be published with the full meeting report.

Congress sets itself up for a showdown

Despite the bipartisan agreement from August 2011 to cap federal discretionary spending at certain limits to reduce the deficit and avoid a government default, the House of Representatives and Senate have disagreed on their spending levels for fiscal year 2013. The Senate passed what is known as a "deeming resolution" that signaled to the Senate Appropriations Committee to set spending levels at those in the Budget Control Act law, passed last August. The House, however, set its spending levels at \$19 billion below those found in the law, arguing that the caps in the law were a ceiling.

The so-called Ryan Budget, named for the House Budget Committee Chairman Paul Ryan of Wisconsin, could mean a cut of up to 27 percent for the National Institutes of Health as well as other agencies housed within Health and Human Services (HHS), but also encompasses major cuts to education, transportation, and homeland security spending, as well as changes to the Medicare and Medicaid programs. The budget would leave defense spending at a flat level. The House budget is dead-on-arrival in the Senate, and while it passed the House on a near party-line vote at the end of March, it is expected to lead to a showdown toward the end of the year when Congress needs to resolve the differences and continue to fund the government for FY2013.

With Congress in an election year, it is likely that they will postpone action on major legislation, including many appropriations bills, until after November, when they will come back for a six week lame duck session. Other items that need to be addressed include the Bush tax cuts that expire at the end of the year, and the impending automatically triggered cuts to federal spending that go into effect in January if left alone.

OVERVIEW OF THE 32ND SMFM ANNUAL MEETING—THE PREGNANCY MEETING™

The Society for Maternal-Fetal Medicine's 32nd Annual Meeting-The Pregnancy Meeting™ was held February 6-11, 2012, in Dallas, Texas, The meeting was a huge success by all accounts. There were 1.735 attendees, including over 700 regular and associate members, 200 fellow-in-training members, and over 400 registered in the guest category. The Postgraduate Courses offered on Monday, Tuesday, and Wednesday were well attended and included updates on genetics, critical care, fetal echocardiography and infectious disease in addition to the "always popular" debates in ultrasound and clinical obstetrics. The Wednesday afternoon Scientific Forums focused on areas of great interest; one highlight was the Global Health Forum where 4 obstetricians from India, Haiti, Uganda and Ghana presented maternal death cases for discussion and review. The meeting itself began on Thursday with what everyone said was a "great display of science" - both clinical and basic. Other high-







UPDATE FROM THE PREGNANCY FOUNDATION™

The AAOGF and the Foundations of ABOG and SMFM joined forces in 2002 seek to identify future academic physician leaders in the field of Obstetrics and Gynecology and to stimulate their scholarly development, through the support of advanced scientific training. The SMFM/AAOGF Scholarship Award is to be used in an academic Department of Obstetrics and Gynecology in the United States or Canada to provide research training and experience for a candidate of proven ability who exhibits significant talent, original thought and evidence of dedication to an academic career. Research training may be either laboratory-based or clinical, and focus on fundamental biology, disease mechanisms, interventions or diagnostics, epidemiology or translational research.

A joint committee of the Pregnancy Foundation and the AAOGF Foundation will select the scholar. Applicants for the SMFM/AAOGF Scholarship must have recently completed MFM subspecialty training or be in the second or third year of an ABOG-approved MFM fellowship training program at the time application is made. Candidates **must** also be members of the SMFM.

Beginning with the 2013 award, the scholarship is for \$120,000 per year, renewable for a total of three years of research training. Each award must be matched by an institutional commitment of at least \$30,000 per year for the same period. The initial award is for one year and is renewable annually for two additional consecutive years of research training, based on satisfactory progress of the scholar in meeting the requirements of the program, the appropriate evolution of the research and the availability of funds. Only one year of the three years funded may be part of a subspecialty fellowship-training program. Indirect costs are not provided.

At least 75% of the candidate's efforts should be spent in research training and conduct of research which may occur in facilities either within or outside of the sponsoring Department of Obstetrics and Gynecology.
