

## Connecticut

Maternal mortality rates in the United States are rising. The U.S. has the highest rate of maternal death among developed nations with significant racial disparities and large differences in rates between states. The Society for Maternal-Fetal Medicine (SMFM) has identified four important ways that states are addressing the rising rates of maternal mortality: 1.) the establishment of maternal mortality review committees; 2.) the establishment of perinatal quality collaboratives; 3.) the expansion of Medicaid; and 4.) reporting of data stratified by race/ethnicity. ### Medicaid Coverage for Pregnant Women

Connecticut's Medicaid program will cover pregnant women up to 199% of the federal poverty level (FPL). In 2018, the FPL for a family of three is \$20,780.

### Rate of Maternal Mortality per 100,000 Live Births

Race	Connecticut	USA
White	14.3	18.1
Black	N/A	47.2
Hispanic	N/A	12.2
Overall	13.2	20.7

Black women are nearly three times more likely to die from pregnancy-related causes than white women in the U.S. Connecticut reports limited data stratified by race/ethnicity.
