Dear Majority Leader McConnell, Speaker Pelosi, Minority Leader Schumer, and Leader McCarthy:

The 50 undersigned organizations dedicated to improving maternal and child health respectfully request that you include both H.R. 4995, the Maternal Health Quality Improvement Act of 2019, and H.R. 4996, the Helping Medicaid Offer Maternity Services Act of 2019, in any end-of-year package. This strong bipartisan legislation, which was unanimously reported out of the Committee on Energy & Commerce, will improve the lives of women and families by helping to reverse our Nation's rising rate of maternal mortality.

The United States is the only industrialized nation where maternal deaths are on the rise. Each year, an estimated 700 women in the United States die during pregnancy and in the postpartum period from complications related to pregnancy. Of these maternal deaths, an estimated 60 percent are preventable. Stark racial disparities in maternal health outcomes persist; Black and American Indian/Alaska Native women are roughly three times as likely to die from pregnancy-related causes as white women. According to the Centers for Disease Control and Prevention, over 60 percent of pregnancy-related deaths occur in the days between delivery and one year postpartum.

Last year, thanks to Congress' extensive work and leadership in addressing maternal mortality, two bills to improve maternal health outcomes became law: P.L. 115-344, the Preventing Maternal Deaths Act, and P.L. 115-320, the Improving Access to Maternity Care Act. These laws are helping us take steps forward in preventing maternal deaths and improving maternal health outcomes. However, fully addressing the maternal mortality crisis, reducing severe maternal morbidities, and eliminating disparities in maternal health outcomes will require additional robust action and continued Congressional attention. Now, Congress has the opportunity to build on last year's progress by passing both H.R. 4995 and H.R. 4996 to help hospitals and maternity care providers implement clinically proven best practices, support state efforts to extend Medicaid coverage for women to one year postpartum, increase access to maternity care in rural and underserved areas, and work to eliminate racial and ethnic disparities in maternal health.

We urge you to build on Congress' commitment to addressing our Nation's rising maternal mortality rate. Congress must take meaningful action now to eliminate preventable pregnancy-related deaths and improve maternal health outcomes by passing both H.R. 4995 and H.R. 4996 as soon as possible.
