



Terms and Conditions

The following Terms and Conditions apply to any booking made between a participant and **Christ for all Nations, Inc.** (“CfaN”).

Requirement to Check CfaN Website for Current Trip Itinerary and Information. CfaN will provide the most current air and land itinerary for its Trip on the CfaN website [israel2019.org]. Each participant is responsible for regularly checking the CfaN website for updated Trip information, and each participant agrees that these terms and conditions include the CfaN website information. If you are a group leader, by agreeing to these Terms and Conditions, you agree that your group members have given you permission to accept these terms on their behalf.

Quotes & Prices. All quotes and prices are in USD (\$) and are based on the currency exchange rates at the time of issue. CfaN reserves the right to change prices based on fluctuations in exchange rates. Services and prices contained within quotes are only confirmed once a booking has been made in writing and/or with the payment of a deposit. Prices are based on pre-arranged Trip services, schedules, mileage, hotel accommodations and other variables. If a participant changes an itinerary or requests extra services additional pricing will be required.

Bookings & Reservations. Trip reservations will be confirmed based on availability at the time of booking. Receipt of a deposit and completed Registration Form by CfaN (electronically or by phone) are required to hold your reservation. Bookings and reservations are only considered confirmed with written notification (via email) from CfaN, and acceptance and understanding of the Terms and Conditions by each participant (or group leader on behalf of their members with their permission).

Deposits. Unless otherwise stated all Trips and services require a non-refundable deposit of \$500 (per participant). **Deposits are due May 15th, 2019.** Registration closes on **July 15th, 2019.** IF SPACE IS AVAILABLE, some registrations MAY be taken after March 8th. Full Payment. Unless expressly stated the following applies to all Trips and services booked with CfaN: (1) all tours and services must be prepaid; (2) all payments must be in USD (\$); and (3) full payment must be made by **July 15th, 2019**).

Payment Methods. Credit Card – CfaN accepts VISA, MasterCard and American Express. Payment can be taken over the phone or online. **Bank Wire** – CfaN accepts US and International bank wires. All fees and associated costs will be charged to the participant. **Cash** - CfaN does not accept cash payments for Trips or prepaid services in cash. Cash payments can be taken in some circumstances for incidentals and extras while on a Trip.

Cancellation. All cancellations must be received in writing or electronically. The dates below refer to the date the cancellation is received by CfaN. Trip deposits of \$500.00 are non-refundable and non-transferable at any time. Cancellation notice received by **July 15th** (90 days before the trip date) – full refund (minus the deposit).

Cancellation notice received after July 15th:

- 1) airfare non-refundable from that day on
- 2) 50% of tour refundable (minus the deposit and minus airfare) up until August 15th (60 days before the trip date).

Cancellation after August 15th - no refund.

No refund will be made if cancellation is the result of Force Majeure (either in a Trip county or in the participant's country) by government actions, inclement weather, terrorism, war, civil disturbance, strikes, or any other circumstance beyond the control of CfaN.

Trips and Services. Changes -- CfaN endeavors to conduct all Trips as described. However, we reserve the right to change the Trip itinerary. Trip itineraries may change due to safety, political circumstances, climate or other reasons. **Before the Trip** – as much as possible, participants will be notified before departing for their destination. However, in some cases participants may be informed of changes at the start of the Trip. **After the start of the Trip** – it is sometimes necessary to make changes to itineraries when a Trip is in progress. Participants will be notified of such changes when confirmed. CfaN is not liable for any additional expense incurred when such changes may be made. **Missed Trip sites or activities** -- are not refundable or transferable in any way. **Inclusions and Exclusions** -- It is each participant's responsibility to be aware of inclusions and exclusions from their Trip package. This information can be found on the CfaN Trip website israel2019.org

where tour packages and the section entitled “What’s Included?” must be read carefully.

Your Responsibility On Trip. Participants are responsible to ensure they attend all activities of the Trip on time. Failure to do so may result in missed sites or activities and extra personal expenses that are not the responsibility of CfaN. Participants are to remain with the Trip group at all times. Separation from the group could result in being left behind and the subsequent rejoining of the group would be a personal expense that is not the responsibility of CfaN. All participants are required to abide by the law, be compliant with security services, and be sensitive to cultural and religious groups, individuals and places. Participants must follow the instructions of the Trip guides and CfaN representatives. CfaN reserves the right to remove any participant from a Trip at its sole discretion.

Liability. CfaN accepts no responsibility for the direct or consequential loss or damage of personal belongings. The participant acknowledges that there may be an amount of risk to a participant’s health and/or safety involved in traveling in a foreign destination. To the full extent permissible by law the participant hereby assumes all such risk and releases CfaN and any parties acting on behalf of CfaN from all claims and causes of action arising from participating in such a Trip.

Travel Documents. It is the responsibility of each participant to ensure that the participant has all of the necessary documents to travel to the countries of their intended itinerary. **Passports and Visas** -- All travel to the country scheduled, as well as any other country on the itinerary, requires a passport with a minimum of 6 months’ validity from the time the Trip ends. It is the responsibility of each participant to ensure that their passport meets such basic requirement and is carried with the participant at all times. As part of the booking process, CfaN requires that each participant electronically enter their passport information on the CfaN Experience Israel website to be held securely and only used by CfaN in the case of an emergency. CfaN is not liable for any inconvenience, expense or loss resulting from not providing this information. It is the responsibility of each participant to ensure that visa documents are valid and appropriate for the countries and activities intended. Visas and passports should be carried at all times.

CfaN Documents. Please note that all documents issued by CfaN will be sent electronically, by email to the email address provided by the participant at the time of booking. CfaN cannot accept any liability for issues arising due to non-receipt of

documents whether because of incorrect information and contact details being submitted to **CfaN** or any other reason. It is the responsibility of each participant to ensure they read all information sent to them by **CfaN**. **CfaN** is not responsible or liable for any issues arising from a lack of knowledge of the sent information. All participants need to bring all necessary documents (in print form) when travelling.

Travel Insurance. **CfaN** requires that all participants in Trip activities or similar services have valid travel insurance. Each participant's travel insurance should provide coverage against personal accident, death, medical expenses and emergency repatriation with a recommended minimum coverage of US \$200,000 in each of the categories. **CfaN** also strongly recommends that each participant's insurance covers cancellation, curtailment, personal liability and loss of luggage and personal effects. Health and Medical. Each participant must inform **CfaN** of any special needs, requirements or medical conditions in advance of the Trip. **CfaN** will do its best to accommodate any such requirements but **CfaN** is not liable in any way for any loss related to such requirements. In some cases, **CfaN** may deem a person's health condition unsuitable for a given Trip and reserves the right to refuse Trip applicants or remove a participant from a Trip at its own discretion. **CfaN** is not responsible for any medical condition occurring during the Trip. All Trip participants must have valid medical insurance.

Accessibility. Participants should be aware that access to accommodations, transportation, restaurants, and other sites in destinations abroad may differ from that in other countries and accessibility is not guaranteed by **CfaN**. Many venues may not have an elevator. Streets may present difficult walking conditions. Public sites may not be handicap-accessible. Trip participation requires a minimum level of physical stamina, such as being able to walk uphill or climb stairs. By booking this Trip, each participant certifies that to the best of their knowledge, they are in sufficiently good health to participate in the Trip, and that any special medical or physical condition, dietary demands, and any other restrictions have been fully disclosed to **CfaN**. Each participant understands and agrees that health care facilities and services abroad may differ from those to which they are accustomed, and may be insufficient for treatment of their health conditions. Each participant is responsible for taking with them an adequate supply of all necessary medications when they travel abroad.

Photo and Marketing. Each participant consents to CfaN using pictures taken of them during the Trip and grants a perpetual, royalty-free, worldwide irrevocable license to use such images for CfaN marketing and promotional purposes.

Privacy Policy. We use a tool called “Google Analytics” to collect information about use of this site. Google Analytics collects information such as how often users visit this site, what pages they visit when they do so, and what other sites they used prior to coming to this site. We use the information we get from Google Analytics only to improve this site. Google Analytics collects only the IP address assigned to you on the date you visit this site, rather than your name or other identifying information. We do not combine the information collected through the use of Google Analytics with personally identifiable information. Although Google Analytics plants a permanent cookie on your web browser to identify you as a unique user the next time you visit this site, the cookie cannot be used by anyone but Google. Google’s ability to use and share information collected by Google Analytics about your visits to this site is restricted by the Google Analytics Terms of Use and the Google Privacy Policy. As part of the booking process CfaN collects personal information necessary for conducting its business. This information is held securely and is not given to any third parties who are not inherently involved in the conducting of the Trips or services for the customer. Personal information and travel history are retained. Credit Card information is stored securely until 30 days after the end of the Trip and then destroyed or redacted. CfaN is not responsible for document breaches caused by third parties.

Disclaimers, Waiver, and Release of Liability. Each participant understands and agrees that CfaN does not own or operate any of the facilities or suppliers of accommodations or services for the Trip. Each participant agrees that CfaN and its representatives shall not be liable for any injury, damage, loss, accident, delay or irregularity, liability or expense to person or property due to any act of default of hotel, transportation carrier, restaurant supplier or other contractor providing services to CfaN and its participants. CfaN and its representatives shall not be responsible for any liability or expense in any way due to acts of terrorism, civil unrest, labor disputes, war or threat of war, government restrictions, weather, theft, fire or illness, or any other cause beyond their control. CfaN and its representatives reserve the right to accept or refuse any person as a participant on any Trip. CfaN and its representatives reserve the right to cancel any Trip prior to departure for any reason, including insufficient number of participants, or to change itineraries and/or substitute services of equal or greater quality without prior notice. Each participant understands and agrees that CfaN provides services and travel activities that carry inherent risks. By participating in these travel activities by CfaN or its employees, partners, or agents, each participant agrees to the following: 1) Each participant understands and agrees that their participation in travel activities carries risks and may pose hazards and dangers. These may include anything related to the Trip. 2) Each participant understands and agrees that these risks and hazards may result from the actions and/or negligence of CfaN or any of its employees, partners, or agents. The risks and hazards may also be caused by the actions and/or negligence of the participants in the program, others, or may be the result of accidents. 3) Each participant understands and agrees that risks and dangers associated with travel and all travel activities exist, and **each participant assumes all responsibility for any losses and/or damages, caused in whole or in part by the negligence or other conduct of CfaN or its employees, agents, or partners, or by any other person, including any participants of CfaN.** Each participant is responsible for adhering to the rules and laws of the localities while on a Trip or traveling with CfaN or participating in activities arranged by CfaN or any of its agents or partners. The rights and privacy of fellow Trip participants must be respected while on a Trip. CfaN reserves the right to disqualify any participant before or during any program if CfaN judges that their participation may compromise the safety or comfort of others.
