



Maintenance

1. Use a spanner wrench with pin diameter of 1/4 in. (.635 cm) to take apart the valve (Fig. 2).




2. Replace the existing o-rings (PN 114054) (Fig. 3).



3. Reassemble the valve using thread adhesive.


