

## 2023 DODGE CHALLENGER SRT DEMON 170 CUSTOMER ACKNOWLEDGEMENT

The 2023 Dodge Challenger SRT Demon 170 (the “**Vehicle**”) is a unique performance Vehicle with unique characteristics, parts, systems and capabilities and performs unlike other vehicles. It is imperative that you understand and acknowledge the unique characteristics of this Vehicle before purchasing or driving. **Please refer to the Vehicle’s Owner’s Manual, User Guide, and 2023 SRT Demon 170 Supplement.**

In consideration for the opportunity to purchase the Vehicle, Customer hereby acknowledges and agrees that:

1. Customer shall have full responsibility and shall assume all risks related to the use of the features and applications in the Vehicle and shall only use the features and applications when it is safe to do so. Failure to do so may result in an accident involving serious injury or death. \_\_\_\_\_

2. Customer shall read and fully understands and agrees to be bound by the Vehicle’s Owner’s Manual, User Guide, and 2023 SRT Demon 170 Supplement in their entirety prior to operating the Vehicle. \_\_\_\_\_

3. If factory installed passenger and/or rear seats of the Vehicle are or have been removed, no person or persons shall ride in those areas. If factory installed passenger and/or rear seats of the Vehicle are removed, Customer acknowledges that in the case of a collision or other accident, people riding in those areas are more likely to be seriously injured or killed. \_\_\_\_\_

4. If the Vehicle is not factory equipped with a passenger seat and/or rear seats, Customer shall never attempt to install a passenger and/or rear seats because the passengers will not be properly protected. \_\_\_\_\_

5. Customer shall never use any “Track-Use” features or functions, (as covered in the Vehicle’s Owner’s Manual) on public roads or any other prohibited area. The intended use of “Track-Use” features, functions, equipment or parts is for race vehicles on racetracks. \_\_\_\_\_

6. The Vehicle’s Mickey Thompson ET Street R drag radial tires (the “**Drag Tires**”) meet United States Department of Transportation requirements, but they are not intended for highway use, as the expected miles of wear from the racing compound is greatly reduced. This vehicle has been designed to maximize performance at the drag strip. In doing so, the standard configuration of this vehicle includes a two-speaker audio system, removed sound deadening material, and removed passenger/rear seat and seat belts for increased vehicle performance. As a result, the interior (driver cockpit) NVH (Noise, Vibration, and Harshness) will be louder overall. This vehicle will likely get louder over time, but note that is not an indication of degraded durability; it is simply a character change in the NVH. \_\_\_\_\_

7. The Drag Tires are not recommended for driving in wet weather conditions where there is an elevated risk of hydroplaning. \_\_\_\_\_

8. Customer shall not operate or move the Vehicle in temperatures below 15° F with the Drag Tires. In temperatures below 15° F, the Drag Tires can lose flexibility and that may lead to cracking and other tire damage. \_\_\_\_\_

9. Customer shall always inspect the Drag Tires for signs of cracking and damage before use. If highway use is desired, we recommend using The Direct Connection Street Wheel & Tire Package. \_\_\_\_\_

10. Customer shall use only those fuels specified in the Vehicle's Owner's Manual, User Guide, and 2023 Demon 170 Supplement as the use of other fuels will damage O2 sensors and catalytic converters. \_\_\_\_\_

11. Customer shall not tighten the lug nuts fully until the Vehicle has been lowered to the ground (e.g., from a jack or hydraulic lift). Note that lug nuts should be fully tightened prior to operating the Vehicle. Please refer to the **Vehicle's Owner's Manual, User Guide, and 2023 Demon 170 Supplement** in their entirety. \_\_\_\_\_

THE UNDERSIGNED CUSTOMER, FOR THEMSELVES AND THEIR PERSONAL REPRESENTATIVES AND HEIRS AND NEXT OF KIN, VOLUNTARILY ACKNOWLEDGES AND AGREE THAT HE OR SHE HAS READ, FULLY UNDERSTANDS AND VOLUNTARILY SIGNS THIS CUSTOMER ACKNOWLEDGMENT, AND AGREES THAT NO ORAL REPRESENTATIONS, WARRANTIES, STATEMENTS OR INDUCEMENTS APART FROM THE FOREGOING HAVE BEEN MADE BY OR ON BEHALF OF FCA US LLC OR DEALER. THE UNDERSIGNED CUSTOMER AGREES THAT HE OR SHE HAS HAD THE OPPORTUNITY TO ASK QUESTIONS ABOUT THIS DOCUMENT, THE VEHICLE ITSELF AND THE EFFECT THAT PURCHASING THE VEHICLE AT OR BELOW MSRP WILL HAVE ON THE ORDER IN WHICH THE VEHICLE WILL BE SCHEDULED FOR PRODUCTION, AND ALL SUCH QUESTIONS HAVE BEEN ANSWERED TO THEIR SATISFACTION. \_\_\_\_\_

13. THE CARBON FIBER WHEELS HAVE BEEN ASSEMBLED TO THE SPECIFICATION OF FCA US LLC. THE CUSTOMER SHALL NOT DISASSEMBLE THE ALUMINUM CENTER FROM THE CARBON FIBER RIM, MODIFY, AND/OR TAMPER WITH THE TITANIUM FASTENERS. THE CUSTOMER SHALL ALWAYS INSPECT WHEELS FOR CRACKING AND DAMAGE AFTER ANY IMPACT OR CURBING. \_\_\_\_\_

14. THE UNDERSIGNED CUSTOMER IS EXECUTING THIS DOCUMENT KNOWINGLY AND VOLUNTARILY. CUSTOMER HEREBY ASSUMES ALL RISK ASSOCIATED WITH THE OPERATION OF THE VEHICLE (SEE THE VEHICLE'S OWNER'S MANUAL, USER GUIDE, 2023 SRT DEMON 170 SUPPLEMENT IN THEIR ENTIRETY) AND WAIVES ANY AND ALL CLAIMS AGAINST FCA US LLC, ITS SUPPLIERS AND/OR DEALER. THE UNDERSIGNED CUSTOMER SHALL DEFEND AND INDEMNIFY FCA US LLC AGAINST ANY AND ALL CLAIMS ARISING OUT OF THE CUSTOMER'S NEGLIGENCE AND/OR BREACH OF THE TERMS OF THIS DOCUMENT. \_\_\_\_\_

ANY AND ALL DISPUTES RELATED TO THE VEHICLE, USE OF THE VEHICLE AND/OR UNDER THIS AGREEMENT SHALL BE RESOLVED BY BINDING ARIBTRATION IN ACCORDANCE WITH THE AMERICAN ARBITRATION ASSOCIATION COMMERICAL RULES, AND THE EXCLUSIVE VENUE FOR SUCH DISPUTES SHALL BE OAKLAND COUNTY, MICHIGAN. JUDGMENT MAY BE ENTERED ON THE FINAL ARBITRATION AWARD BY ANY STATE OR FEDERAL COURT HAVING JURISDICTION. \_\_\_\_\_
